



"A device for the underlining of any required word or sentence simultaneously with the typing of the same word or sentence."

Abstract.—This invention relates to a device for underlining whilst typing. The main principle of the

device consists of utilizing the fact that the type in a typewriter is so designed as to strike at exactly the same place with reference to the medial line of the typewriter. How this is to be utilized for the purpose of the invention may be gathered from Claim 1 which reads as follows:—

1. The use of an extra typebar and type carrying an underlining mark, used in conjunction with the normal keys and space bar of an ordinary typewriter and so connected thereto that when required the extra typebar and type carrying the said underlining mark will operate simultaneously with the depression of the space bar or of any one of the normal keys of the typewriter and place on the succeeding or preceding letter to that under type an underlining mark.

"A method of and apparatus for atomizing liquids."

Abstract.—This invention relates to the atomizing of liquids. The atomization is achieved by causing the liquid to impinge on a stationary disc at or near the centre thereof and to flow as a continuous film outwardly across and beyond the periphery of the disc into a zone protected from the atomising gas stream, beyond which zone the liquid is engaged and entrained by the atomising gas stream. One form of atomising apparatus is described.
