Revocation of Irrevocable Deeds of Gift on the ground of Gross Ingratitude

AN ACT TO PROVIDE FOR REVOCATION OF IRREVOCABLE DEEDS OF GIFT ON THE GROUND OF  $G {\rm Ross}$  Ingratitude and for matters connected THEREWITH AND INCIDENTAL THERETO

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:-

1. This Act may be cited as the Revocation of Short title. Irrevocable Deeds of Gift on the ground of Gross Ingratitude 5 Act, No. of 2017.

2. An irrevocable deed of gift may be revoked on Revocation the ground of gross ingratitude, only on an Order made of an by a competent court, in an action filed by the donor deed of gift of such deed against the donee to have the said by a 10 deed revoked.

3. Court shall not entertain an action referred to Time period in section 2, unless it is filed within a period of ten years within which from the date of the execution of such deed of gift and be filed. within two years from the date on which the cause of 15 action arose.

4. (1) The plaintiff in an action instituted under the Plaintiff to provisions of this Act shall file or cause to be filed in court  $\ ^{apply \ for}$ with the plaint, an application for registration of *lis* of the action pendens-

## 2 Revocation of Irrevocable Deeds of Gift on the ground of Gross Ingratitude

(2) The application referred to in subsection (1), shall be in triplicate and marked "original", "1st copy" and "2nd copy" and shall be substantially in the form set out in the Registration of Documents Ordinance (Chapter 117) and

5. Every action filed under the provisions of this Act Application shall be proceeded with and regulated by the procedure of the Civil Procedure provided for in the Civil Procedure Code (Chapter 101).

> "Registrar of Lands" means the Registrar of Lands appointed under the Registration of Documents Ordinance (Chapter 117) and having jurisdiction over the district in which the land which forms the subject matter of an irrevocable deed of gift which is sought to be revoked is situated; and

"Land" shall have the same meaning as in the Registration of Documents Ordinance (Chapter 117).
