#### Order

With effect from January 1, 1954, the limits of the Kohonsiya Pattu village area in the Divisional Revenue Officer's division of Matale South in the Matale District, are hereby altered and redefined by the exclusion, from that village area, of the portion specified in the Schedule hereto.

#### SCHEDULE

All that area of land within the village of Oyapahala in Kohonsiya Pattu, Matale District, and falling within the administrative limits of the Matale Urban Council as defined in the Order under sections 2, 6 and 30 of the Urban Councils Ordinance, No. 61 of 1939, published in the *Gazette* No. 10,426 of July 18, 1952, and bounded as follows:—

**North:** By a line drawn from the easternmost point of lot 312 in Matale Town Survey Sheet No. 1 15/60 B East, Eastwards parallel to and at a distance of 100 yards from the centre line of Bandarapola Road to a point on the centre line of Sudu Ganga or Diyabubule Oya.

**East and South:** By a line drawn from the last-mentioned point southwards and southwestwards along the centre line of Sudu Ganga or Diyabubule Oya to the centre of its confluence with Ganayake Agala.

**West:** By a line drawn from the last-mentioned point northwestwards along the centre line of Ganayake Agala to a point on a line in prolongation of the southern boundary of the road south of lot 311 in Matale Town Survey Sheet I 15/60 B East, thence northeastwards along the said prolongation and the said boundary to a point on a line in prolongation of the eastern boundary of Godapole Road thence northwards along the said prolongation and the said boundary to the southernmost corner of lot 312 in Matale Town Survey Sheet I 15/60 B East thence northeastwards along the southeastern boundary of the said lot to the starting point of the northern limit of the area.
