Notices Calling for Tenders

TENDERS FOR THE SUPPLY OF THREE NEW LORRY CHASSIS FITTED ENGINES WITH DIESEL

THE Chairman, Tender Board, Ministry of Agriculture and Food, will receive tenders from recognized motor dealers up to 3 p.m. on Tuesday, December 22, 1953, for the supply of three 3½ ton lorry chassis fitted with diesel engines according to specification given below.

2. Tenders should be in duplicate and sealed under one cover and should be addressed to the Chairman, Tender Board, Ministry of Agriculture and Food, Union Place, Colombo 2.

3. Tenders should either be deposited in the tender box in the Minis ry of Agriculture and

Food or be sent through post under registered

- 4. The envelope containing the tender should be marked "TENDER FOR THE SUPPLY OF THREE NEW LORRY CHASSIS FITTED WITH DIESEL ENGINES" on the left-hand top corner, and should reach the Chairman, Tender Board, Ministry of Agriculture and Food, Union Place, Colombo 2, not later than 3 p.m. on Tuesday, December 22, 1953
- 5. Tenders should be made on forms which will be supplied on application at the office of the Assistant Food Controller, Chalmers Granaries,

- Colombo. No tender will be considered unless it is on the recognized form. Tender forms will not be issued after 12 noon on December 21, 1953.
- 6. Tenders should indicate the price of the lorry chassis fitted with diesel engines, and the price quoted should be exclusive of Customs duty.
- 7. The three chassis should all be of one make and the three diesel engines should also be of one make.
- 8. Tenders should be signed. All alterations and erasures in the tender must be initialled by the tenderer. The amount tendered should be entered in the tender form both in figures and in words. Where the amount given in figures differs from the amount in words, or no amount is stated in words, the tender is liable to rejection.
- 9. Tenders should be firm for at least 40 days from the date of closing of tender and the tenderer must be in readiness to enter into a contract to carry out the work if notice of acceptance of tender is received by him within this period.
- 10. The three lorry chassis fitted with diesel engines should be delivered within 3 months of the acceptance of the tender.
- 11. A deposit of Rs. 200 will be required to be made at the office of the Assistant Food Controller, Chalmers Granaries, Colombo, before any tender form is issued. Should any person decline or fail to enter into a contract and bond or fail

to furnish approved security within 3 days of receiving notice in writing that his tender has been accepted, such deposit will be forfeited to the Crown and his name liable to be placed on the list of defaulters. Notice of acceptance of the tender will be deemed to have been received by the tenderer if it has been sent by post addressed to or left at the address given by the tenderer. All other deposits will be returned upon signature of the contract.

- 12. The successful tenderer should deposit a sum not exceeding Rs. 3,000 m cash fixed by the Food Commissioner (Control and Dstribution) in his discretion within 3 days of intimation of the acceptance of tender as security for the satisfactory fulfilment of the contract in terms of which the successful tenderer will be liable in damages for failure to carry out or complete the work in time. The sum so deposited will be mortgaged to and in favour of Her Majesty.
- 13. No tender will be considered unless all conditions laid down above have been strictly fulfilled.
- 14. The Government reserves to itself the right. of rejecting any or all tenders.
- 15. The contract should not be assigned or sublet without the authority of the Tender Board. Government reserves to itself the right to refuse to recognize a Power of Attorney issued by a contractor to carry on the contract on the contractor's behalf, and no such Power of Attorney should be issued to a person on the list of Crown defaulting contractors.

16. The successful tenderer will be required to employ only Ceylonese labour in carrying out the work tendered for.

The employment of only Ceylonese labour in carrying out the work tendered for will be made a condition of the contract and failure on the part of the successful tenderer to fulfil this condition will be treated as a breach of the contract and will render the contract liable to cancellation; provided, however, that in exceptional circumstances the Food Commissioner (Control and Distribution) may, with the concurrence of the Permanent Secretary, Ministry of Agriculture and Food, permit the contractor to employ non-Ceylonese labour.

The employment of non-Ceylonese labour without such approval in writing and concurrence is forbidden. The term "Ceylonese" shall mean—

- (a) a citizen of Ceylon by descent or by registration, or
- (b) a British subject who is born in Ceylon, one of whose parents was born in Ceylon, or
- (c) a British subject who is a descendant of a person falling within category (b).
- 17. The successful tenderer will be required to indemnify the Government against any claim by or in respect of any employee of the tenderer under the Workmen's Compensation Ordinance, No. 19 of 1934, or any statutory modification
- 18. Government reserves the right to object to the employment by the tenderer of any workmen whose employment is considered not desirable or to object to the employment of any workmen.
- 19. The contractor shall be bound by the laws of Ceylon at all times during the perod of this contract.
- 20. The contract shall be entered into by the contractor with the Food Commissioner (Control and Distribution) as soon as the acceptance of the tender is notified and the required security deposited. The value of stamps to be fixed to the bond or agreement shall be borne by the successful tenderer.

- 21. The form of agreement and bond is available for inspection at the office of the Assistant Food Controller, Chalmers Granaries, Colombo 1.
- 22. The Government does not undertake that orders will be placed up to the extent stated herein and accordingly Government will not be liable if no orders are placed with the successful tenderer to the said extent or at all.

Specification of the new Lorry Chassis fitted with Diesel Engines

A chassis should be capable of carrying a pay load of 70 cwt. The power unit should be a 6 cylinder Diesel Engine—normal or semi-6 cylinder Diesel Engine—normal or forward control. The wheel base should be 157" to 160", the sizes of the tyres being 32×6 or 34×7 front single, dual rear The chassis should be supplied without a driver's cab but with windscreen, windscreen wiper, number plates, tail lamp, spare wheel, spare wheel carrier and tools. MILLING OF GINGELLY SEED

THE Chairman, Tender Board, Ministry Agriculture and Food, will receive tenders up to 12 noon on Tuesday, December 8, 1953, for the service of milling Gingelly Seed from millers whose mills are situated within the Revenue Dis'rict of Colombo. The contract is for the period ending September 30, 1954.

2. All tenders should be in duplicate and sealed under one cover and should be addressed to-

- 4. Tenders should be marked "Tender for the Milling of Gingelly Seed" on the left-hand top corner of the envelope.

- 5. Tenderers should state the minimum percentage of (a) oil (b) poonac that they undertake to extract from a ton of gingelly seed and quote rates—
 - (a) for milling a ton (net) of gingelly seed, including packing of oil in cleaned 4-gallon tins and soldering them and packing poonac in bags of 112 lb. gross,
 - -(b) for collection and transport of one ton (gross) of gingelly seed from my store viz.: Tunisia Warehouse, Railway Yard, Maradana, to the mills of the tenderers,
 - (c) for transport and delivery at my store of one ton (gross) of gingelly oil and/or gingelly poonac in containers.

A minmum outturn of over 40 per cent. gingelly oil and of over 52 per cent. gingelly poonac is expected. The oil should conform to the specifications laid down by the Government Analyst for genuine gingelly oil.

- 6. - 11. The successful tenderer will be required after taking delivery to issue a receipt for the quantity of gingelly seed taken over.
- 12. The handling of gingelly seed, poonac and oil in the mill will be at the expense of the successful tenderer.
- 13. The successful tenderer will be responsible for washing and cleaning of the gingelly seed necessary for the purpose of milling.
- 14. The oil should be collected in tins which will be supplied by the Commissioner of Food Supplies (Guaranteed Price Scheme). The selected tenderer will be required to filter the oil and fill it into tins and solder them.
- 15. The poonac should be collected in bags provided by the Commissioner of Food Supplies (Guaranteed Price Scheme).
- 16. The oil and poonac should be weighed and randed over at my store to the Chief Storekeeper, Funisia Warehouse, Railway Yard, Maradana. In

- computing the outturn of oil and poonac from the gingelly seed supplied, only the net weight, i.e., the gross weight less the weight of containers will be taken into account. The Chief Storekeeper will issue receipts for the quantities of gingelly oil and gingelly poonac taken over from the successful tenderer.
- 17. The selected tenderer will be held responsible for the safe custody of all stocks of gingelly seed taken over by him as well as of the stocks of oil and poonac before delivery is made to the Commissioner of Food Supplies (Guaranteed Price Scheme).
- 18. No materials except those mentioned above will be supplied by the Commissioner of Food Supplies (Guaranteed Price Scheme).
- 19. The successful tenderer will be required to undertake milling within one week from the date of notifying him of the acceptance of the tender.
- 20 No tender will be considered unless in respect of it all the conditions above laid down have been strictly fulfilled.
- 21. The Government reserves to itself the right without question of rejecting any or all tenders.
