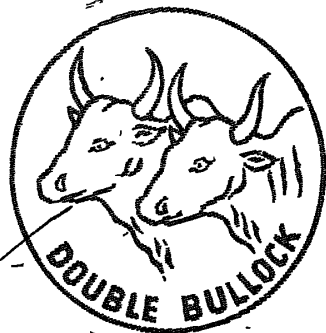

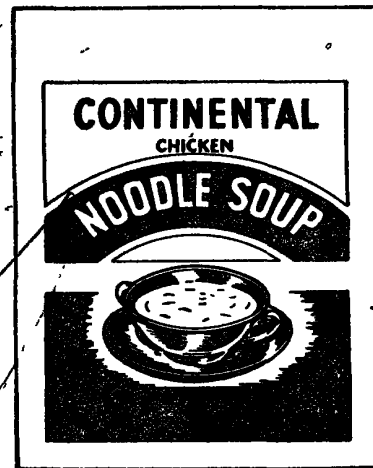

"Arrangement for a valve".

Abstract:—This invention relates to an arrangement for a valve. It comprises a feed chamber, an outlet chamber and an interposed valve seat with its associated spring loaded valve closing member. The valve closing member has a hollow space from which one or more ducts lead to the outside. When the valve is closed the said ducts establish paths between the hollow space and the feed chamber only. When open the ducts connect said hollow space with the smallest through-flowing section between the feed chamber and the outlet chamber. Either one or all of the interacting contact surfaces of the valve seats and closing member are domed (rounded).

"Improvements in or relating to mechanical screeners for raw sugar mill juice or other liquid carrying suspended matter".

Abstract:—The invention relates to mechanical screeners for raw sugar mill juice or other liquid carrying suspended matter. It comprises of a mechanical screener including at least a pair of eccentrics mounted for rotation about spaced axes, a frame journaled on said eccentrics so as to receive orbital motion therefrom and a screen or screens carried by said frame. This frame includes two spaced side plates each journaled on a pair of spaced eccentrics from which they are suspended and wherein the screens are carried between the side plates.
