"Improvements in or relating to roofs for storage tanks or similar structures".

Abstract—This invention relates to the roofs of tanks for the storage of liquids or of other similar structures

The invention includes broadly a domed roof for a circular structure such as a liquid storage tank which comprises a peripheral curb, a plurality of upwardly convex, radially disposed ribs which abut at their outer ends against the curb, a centrally disposed crown member to which all the ribs are screwed at their inner ends, each pair of diametrically opposite ribs having rigid continuity through the crown member and constituting a two-pin arch, and roof sheeting supported upon the arches formed by the ribs.

"Improvements in and relating to feeding means for sheets or webs used in tabulating, typewriting and like writing or recording machines".

Abstract—This invention relates to tabulating, typewriting and like writing or recording machines

According to the present invention apparatus for feeding continuous stationery assemblies consisting of superposed record webs and interleaved carbon transfer webs through machines as described above includes means whereby the record webs are adapted to be fed round the platen roller of the tabulator or the like relatively to the transfer webs by means adapted simultaneously to impart a positive feeding movement to the portions of the record webs on the infeed and outfeed sides of the platen in such a manner that the portions of the said record webs passing round the platen roller are out of contact with the surface of the platen or only lightly in contact therewith and wherein means is provided for controlling the feed of the transfer webs to permit the feed of a small increment irrespective of the amount the record webs are fed, the said feed of the transfer web or webs being effected by means controlled by a member or members adopted to be actuated when the record webs are unprinted or fed.

The purpose of the present invention is to create a firearm with a magazine which is made in such a way that it can contain a very great number of projectiles arranged in manner whereby the projectiles can be rammed one by one by the service personnel without the use of the magazine.
