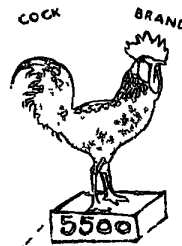

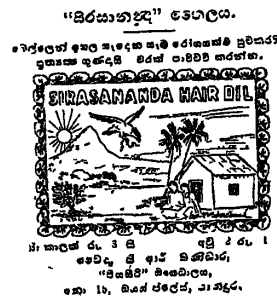

"Projectile with one or several driving bands"

Abstract. The purpose of the invention is to create a projectile with one or several driving bands which are attached in such a way so as to avoid time absorbing and expensive operations for their fabrication

The projectile with one or several driving bands is characterized by the said driving band or each of the said driving bands and the adjoining part or parts of the projectile wall or the whole projectile casing forming a continuous unit made in one piece, and by the said driving band or bands having lower hardness than the said part or parts of the wall or the projectile casing, which hardness is obtained by means of heat treatment

"Tea harvesting machine."

Abstract The nature of the invention can be ascertained from claim 1 which is as follows A tea harvesting machine which is provided with mechanically

operated cutters and which is adapted to run along smooth ground or other smooth tracks, and to straddle the rows of tea bushes, and thus to carry along the cutters at a uniform height in relation to the rows of tea bushes so that the young shoots can be cut therefrom, the cutters being operated by a prime mover positioned on the machine or on a tractor by which the machine is drawn along or through gearing connected with the ground wheels of the machine

The internal combustion engine is coupled to the fan by a flexible shaft and the atomizer is provided with one or more flexible supply lines so that the atomizer can be directed independently of the section of the apparatus containing the internal combustion engine.
