#### REGULATIONS.

#### THE SUPPLY OF ELECTRICITY

- 1. In these regulations:---
- "Act" means the Electricity Act, No 19 of 1950;
- "certificate of competence" means a certificate of competence to be an electrical contractor issued by the licensee;
- "Chairman" means the Chairman of the Passara
  Town Council;
- "licensee" means the Passara Town Council; and
- "Superintendent" means the Superintendent of the Electricity Department of the Passara Town Council.
- 2 Any person desirous of obtaining the use of electrical energy from the licensee shall, at least fourteen days before the supply is required pay in advance to the licensee the charges for the service cable
- 3. Every consumer of electrical energy shall pay for such energy at the rates specified in the licence granted to the licensee under the Act.
- 4. That portion of the service cable which is on the consumer's premises, the transformers, the main fuses, the meter, and the board shall remain the property of the licensee, and on no account shall they be moved or handled by any person other than any employee of the licensee.
- 5. (1) Every consumer wishing, at any time after his installation has been connected, to use any lamp, fan or meter of greater size than the one already in use or to instal any additional lamp or other apparatus consuming energy, either temporarily or permanently, or many way to alter or extend the wiring on his premises, shall notify his wish to the licensee in writing, and if he desires that an electrical contractor should do the work, he shall at the same time notify the name and address of such contractor.
- (2) No consumer shall connect or cause to be connected any extension, lamp, fan, or meter of greater size than the one already in use or instal any additional lamp or other apparatus consuming energy, either temporarily or permanently to the main installation unless such extension, lamp, fan, meter, additional lamp or other apparatus has been inspected and tested and found to be satisfactory by the Superintendent or by an officer authorised by the Superintendent in that behalf.
- 6. (1) In the event of the melting of the licensee's main fuse in any premises the consumer shall forthwith inform the Superintendent or the officer in charge of the Power Station.

- (2) No person other than one of the licensee's authorised officers or workmen shall replace any melted fuse which is the property of the licensee.
- (3) Where the services of any officer or workmen of the licensee are required to replace any fuse which is the property of the consumer a charge of fifty cents shall be made for replacing the fuse
- (4) Where the melting of any fuse which is the property of the licensee is found to have been caused by a defect in the consumer's wiring or apparatus, a charge of one rupee shall be made for replacing the fuse.
- 7. The licensee does not hold itself liable to the consumer for any loss or damage occasioned, directly or indirectly by the total or partial interruption of supply
- 8 Where the installation is re-connected after having been disconnected under section 45 of the Act, a fee of five rupees for testing and re-connecting shall be charged and shall be paid in advance by the consumer.
- 9 (1) All charges shall be deemed to be due on the date on which an account is presented.
- (2) No complaint against the accuracy of an account shall be entertained by the Chairman unless such complaint is made within a week after the presentation of the account
- 10. (1) Every consumer about to vacate his premises shall give in writing three clear days notice to the Chairman of his mtention to do so.
- (2) Where the notice referred to in paragraph (1) is not given, the consumer shall be held responsible for the licensee's equipment in his premises and for all energy consumed on such premises until the lapse of three days from the date on which the licensee receives notice of the fact that the premises have been vacated

Provided that if the supply to the premises is disconnected by the licensee before the lapse of the said three days, the consumer shall be held responsible for the energy consumed on the premises up to the time of disconnection

- 11 The licensee may in its discretion grant a certificate of competence to any person who is the holder of a certificate of recommendation from the Chief Electrical Inspector or who—
  - (a) has had at least three years' practical experience in a recognised electrical engineering workshop or firm or m an electrical power station; and
  - (b) has been regularly engaged for a period of not less than two years' in the practice of electrical engineering.
- 12. (1) No person who is not the holder, or a workman employed by the holder, of a certificate of competence shall—
  - (a) undertake or carry out any work in connection with the wiring or the electrical fittings or fixtures of any new installation which is intended to be connected to the licensee's electricity supply mains or—
  - (b) after any installation m any premises has been connected to such mains carry out or perform in connection with such installation, any electrical work.
    - (i) which consists of, or is in the nature of alterations, adjustments, additions or repairs to such installation; or
    - (ii) other than such ordinary replacement of lamps, fans, switches, or other component parts as in no way alters or affects the capacity and nature of such installation.
- . (2) No installation in connection with which any electrical work described in paragraph (1) is carried out by a person who does not hold a certifi-

- cate of competence or by a workman of such person shall be connected to the licensee's electricity supply mains.
- 13 (1) No electrical contractor shall carry out or perform any electrical work, such, as installation work, including additions, alterations and adjustments to existing installations, except after notice of not less than two days to the Chairman to enable the Superintendent or a person authorised by him to inspect the proposed work.
- (2) If the Superintendent approves the intended work, he shall settle with the contractor the position of the meter, and the contractor shall carry out the work in accordance wih such regulations as may be made under section 60 of the Act
- 14. On the completion of any electrical work referred to in regulation 13, such work shall be inspected and tested by the Superintendent and—
  - (a) if the installation is found to comply with the regulations laid down, a supply of electricalenergy to the permises shall be given; and
  - (b) if the installation does not comply with the regulations laid down, the certificate of competence issued to the contractor shall be liable to cancellation or suspension, and a supply of electrical energy to the premises shall not be given until such time as the installation has been made to comply with such regulations.
- 15 If any electrical contractor commences or carries out any work connected with any new installation without giving notice to the Chairman and obtaining his prior approval, the licensee may refuse to supply electrical energy to the premises wherein such work has been carried out or may call upon the contractor to effect such modifications or alterations to the wiring as the Superintendent may think necessary. If such modifications or alterations are duly carried out the installation shall be re-inspected and tested by the Superintendent and if found to be in order a supply of electrical energy to the premises shall be given
- 16. Where any electrical contractor carries out any extensions to any installation which is already connected to the licensee's electricity supply mains without prior notice to, and without the permission of, the Chairman, notwithstanding that such extensions have no been connected by the contractor to the main installation:—
  - (i) the whole installation shall be liable to disconnection from the licensee's electricity supply mains; and

 (ii) the electrical contractor shall, in addition, be liable to have his certificate of competence cancelled or suspended.

17.' No person other than an Electrical Inspector shall without the written permission of the Chairman or the Superintendent enter the power station or its premises

## BY-LAWS

- 1. These by-laws may be cited as the Advertisement (Panadura Town) By-laws, 1953.
- 2 No person shall cause any advertisement to be displayed so as to be visible from any street, road, canal or lake, except under the authority of a licence issued in that behalf by the Special Commissioner.

Provided, however, that the preceding provisions for this by-law shall not apply to any of the following advertisements unless such advertisement is an illuminated advertisement or a sky sign:—

- (a) an advertisement relating to any entertainment, the nett proceeds of which are to be used for the purposes of charity;
- (b) an advertisement relating to any entertainment to be held in the premises upon which such advertisement is displayed;

- (c) an advertisement displayed by the Government;
- (d) an advertisement relating to a religious, political or public meeting;
- (e) an advertisement in the window of any build-

ing;
(f) a "To Let" advertisement;
(g) a "For Sale" advertisement;
(h) a domestic name plate;

(i) a name plate, not exceeding one square foot in area used for professional purposes;

(3) an advertisement on a vehicle used for trade purposes, displaying the name and address of the owner of that vehicle; or

(k) an advertisement relating to the trade or business carried on in the premises upon which such advertisement is displayed

3 (1) Every application for a licence to display any advertisement shall be made to the Special Commissioner, at least seven days before the date on which the display of the advertisement is

Intended to commence
Provided, however, that the Special Commissioner may in special circumstances entertain any application which is not made within the time limit specified in the preceding provisions of this paragraph.

(2) Every application referred to in paragraph (1) shall be accompanied by a copy of the advertisement which the applicant intends to display

- (3) Where the Special Commissioner approves an application referred to in paragraph (1), he shall direct the applicant to pay for the licence to display the advertisement, a fee calculated at the rate of three rupees for each square foot, in respect of each year or part thereof. Such licence shall not be issued to the applicant until such fee is paid.
- 4 (1) Where the licence to display an advertisement is issued to any person, the Special Commissioner shall direct that person:
  - (a) to insert the number and the date of the licence in every copy of that advertisement,
  - (b) to cause every copy of that advertisement to be produced to the Special Commissioner for the purpose of being stamped in token of payment of the fee for that licence
- (2) Every person to whom a direction under paragraph (1) of this by-law is given by the Special Commissioner shall carry out that direction
  - 5 No person shall cause—
  - (1) an advertisement to be displayed in such a manner as to project over any street or road for a distance of more than six inches, measured horizontally from the building line unless such advertisement is a projecting sign constructed and erected in a manner approved by the Special Commissioner;

(2) an advertisement to be displayed on any boarding which exceeds more than twentyfive feet in height from the ground or projects over any street or road;

- (3) to be affixed to or suspended from the facade of a building abutting on any street or road, any shop sign which in length extends beyond the limits of such facade, or which in height at any point exceeds one-fourth of the distance of the bottom of such sign from the pavement or the mean level of the ground; or
- (4) any sky sign to be constructed and erected in manner which is not approved by the Special Commissioner
- 6 No person shall cause any advertisement to be displayed on any place of public worship, any public park or latrine, or any bridge, street, lamp post, or telegraph or telephone post.

7. (1) Where any advertisement is, in the opinion of the Special Commissioner, in an unsightly or objectionable condition he may by written notice order the person causing the display of such advertisement to stop such display within the time specified in such notice

(2) A person to whom a notice under paragraph (1) is sent by the Special Commissioner shall comply with such notice within the time specified

8 The owner or lessee of any hoarding used for the display of advertisement shall—

(a) maintain such hoarding in a proper state of repair and security, and

- (b) exhibit his name and address in clear and legible characters in a conspicuous position on the front of such hoarding

## BY-LAWS RELATING TO LATRINES AND CONSERVANCY

- 1. No owner or occupier of any premises shall construct on such premises any privy or latrine unless he has obtained a permit in that behalf from the Chairman
- 2 Where any person makes an application for a permit under by-law 1, the Chairman may require such person to furnish a plan and specifications of the privy or latrine which he intends to construct.
- 3 The Chairman, may in any permit granted by him under by-law 1, direct the applicant to provide a privy or latrine of such size as may have been approved by the Council, and in such a position on the premises as may be specified in the permit
- 4 If any privy or latrine has been constructed on any premises without a permit from the Chairman, or contrary to any requirements specified in the permit issued under by-law 1, the Chairman may, by notice in writing served on the owner or occupier of the premises direct the owner or occupier to close within such time as may be specified in the notice, such privy or latrine.
- 5 The Chairman may, by notice in writing served on the owner or occupier of any premises direct such owner or occupier to construct on such premises a privy or latrine of such size and type as may have been approved by the Council and in such a position on the premises and with such connecting drains as may be specified in the notice.
- 6 The Chairman may, by notice in writing served on the owner or occupier of any premises provided with any privy or latrine direct such owner or occupier to repair, alter or re-construct such privy or latrine in such manner and within such time as may be specified in the notice, if in the opinion of the Chairman, such privy or latrine—
  - (a) is structurally defective; or
  - (b) is unsuitable for the purpose for which it is used, or
  - (c) is insanitary or dangerous to health, or
  - (d) does not abut upon, or cannot conveniently be served from, a path provided by the Council for removal of night soil.
- 7 Every occupier of any premises provided with a privy or latrine shall maintain such privy or latrine at all times in a sanitary condition and in good repair
- 8. Whenever the Council by resolution decides that in any specified area paths should be provided by the owners or occupiers of premises in such area for the efficient removal of night soil, the Chairman may by notice in writing served on the owner or occupier to provide within such time as may be specified in the notice, a path of such width, in no way exceeding ten feet and in such position, either at the back or parallel to the premises, as the Chairman may specify in the notice.
- 9 The Chairman may refuse to approve any plan, drawing or specification of any building which any person intends to erect unless such person agrees to construct in the building a privy or latrine of such size and type as may have been approved by the Council
- 10. Every person on whom a notice is served under these by-laws shall comply with the requirements of that notice within such time as may be specified in that notice

- 11 Every person who commits a breach of any of these by-laws shall be guilty of an offence and shall on conviction be liable to a fine not exceeding fifty rupees
