Former Prime Minister Ranil Wickremesinghe yesterday admitted that the Financial Crimes Investigation Division (FCID) established by the previous 'Yahapalana' Government, to investigate allegations of fraud and corruption may have been in contravention of the Police Ordinance.

He was responding to questions by the members of the Commission to probe political victimization yesterday about the legality of the FCID.

'GOVT. CLOSELY MONITORING SITUATION' CAMELIA NATHANIEL

The current COVID-19 situation in the country is not at a level that requires the whole country to be placed under lockdown, but if the situation worsens the Government may have to take more far-reaching measures in order to deal with the situation for the greater benefit of the

people, said Defence Secretary Maj. Gen. (Rtd) Kamal Gunaratne.

"Even the President does not want to lockdown the country at this point, but if the situation gets worse, then we may have to take drastic measures. The Government does not want to impose another lockdown in the country but if and when there are many cases being reported from a particular area and depending on contact tracing outcomes, we may impose lockdowns in the affected areas. For instance, at the start of this cluster we had to place three police divisions in the Gampaha District under lockdown even though reluctantly. This measure was absolutely

necessary to contain the spread of the virus to other areas," he added.

In an interview with the Daily News he said the moment these garment factory workers had initially reported to the management regarding their obvious symptoms, the management of this factory should have handled it better. TO PAGE 02

Riyaj Bathiudeen's petition to be heard on Oct. 20

A writ petition filed by former Minister Rishad Bathiudeen's brother Riyaj Bathiudeen was yesterday fixed for support on October 20 by the Court of Appeal.

Through this application, Riyaj Bathiudeen is seeking an Interim Order preventing police from arresting him in relation to the investigations connected with Easter Sunday attacks.

President's Counsel Faiz Mustapha appearing for the petitioner sought an early date taking into consideration the urgent nature of the application. Accordingly, the Court of Appeal fixed the petition for October 20 for consideration.

UN support to revive tourism industry

Telephone facilities for inmates as prisons suspend outside visitors

The Department of Prisons yesterday (16) decided to re-introduce telephone facilities for prison inmates to contact family members and relatives.

Commissioner of Prisons (Rehabilitation) Chandana Ekanayake said, the availability of the tele-

phone was provided in March for a short period due to the COVID-19, as visitations for family and relatives were stopped.

"Now it has been reintroduced as visits to prisons have been halted again due to the current COVID-19 situation in the country.

There will be around 30 tele-

phone lines available in prisons across the country".

He further added, an inmate is only allowed a three-minute conversation, once a week.

"The inmate will be accompanied by a rehabilitation officer when making the call, in case of emergency and dire necessity another call is allowed. The inmate should give all details of the call to the officer".

On October (5) all the prisons had temporarily halted the visitation for family members and relatives when a second wave of the COVID-19 virus resurfaced in the country.

Alleged misappropriation case

State Minister had not committed any wrongdoing - Retired CID Inspector

Retired CID Inspector Padmasiri Dias testifying before the Colombo High Court said that investigations into the case filed against State Minister of Power Mahindananda Aluthgamage for allegedly misappropriating Rs.3.9 million belonging to a trade union affiliated to the Sri Lanka Freedom Party (SLFP) have revealed that the transactions were done in a systematic manner and State Minister Aluthgamage had not committed any wrongdoing.

He further said that State Minister Aluthgamage had obtained the aforesaid amount as a loan following a formal procedure and that the amount had been repaid within three months and that there was no fault in the transactions.

When the case was taken up before Colombo High Court Judge Adithya Patabendi, President's Counsel Nalin Ladduwahetti appearing for State Minister Aluthgamage in cross-examination of the witness, questioned that Investigations have not revealed whether State Minister Aluthgamage owned 17 acres of coconut land in Kurunegala, 92 acres in Ratnapura, 70 acres in Kotmale, 20 acres of cardamom cultivation and five acres in Kotmale inher-

ited from parents.Responding to the query, witness Padmasiri Dias said that investigations had revealed that Aluthgamage had inherited nearly 197 acres of tea and coconut cultivated land and a tea factory.

"Although he knew that State Minister Aluthgamage owned a large amount of property, no investigation was carried out regarding the revenue generated from it," he added

The case will be taken up for further trial on November 5.

Deputy Solicitor General Thusith Mudalige with Senior Counsel Nadee Sudurugoda appeared on behalf of the Attorney General.

President's Counsel Nalin Ladduwahetti with Attorneys-at-Law Buddhika Chandrasekara, Shalika Gunawardena, Janaka Ranatunga and Senior Counsel Kanchana Ratwatte appeared for State Minister Mahindananda Aluthgamage.

The Attorney General had filed indictments against Mahindananda Aluthgamage alleging that he had misappropriated Rs.3.9 million belonging to a trade union affiliated to the Sri Lanka Freedom Party (SLFP), during the previous Mahinda Rajapaksa regime.

Testifying further he said that investigations have revealed that the proposal of launching an attack using 20 suicide bombers was made during a discussion held on March 27, 2019 at a house in Sarikkammulla area in Panadura with the participants of seven persons including Zahran Hashim. He said it was revealed that the second attack was aimed at people trying to escape after the first attack and then another attack was planned on the hospitalization of the injured.

"During the meeting they also decided to select a foreign dominated area in Nuwara Eliya and look into the background for another attack there and Zahran Hashim had told his followers that there should be a suicide bombing in retaliation for the attacks on Muslims in New Zealand and the attacks on ISIS in Syria," he said.

"Investigations have revealed that the attack had targeted of Catholic Churches, Casinos and tourist hotels frequented by foreigners and Zaharan and others had also taken an oath in connection with the suicide bombs during the meeting," he said.

He further said that the investigations also revealed that it had been suggested that the attacks should be carried out within 15 days from March 27, 2019 as the bombs assembled by Zahrans's brother Rilwan were to expire during that period.

Accordingly, Zaharan has said that the attack should carried out within 15 days and that it was not specifically suggested that the attack should be carried out on April 21 targeting Easter Sunday and steps will be taken to inform the suicide bombers within three days before the attacks. However, the date has been already fixed by the Zahran for the attack to be carried out on April 21 on Easter Sunday.

During the meeting Alauddin Ahmed Muaz who detonated the bomb at the St. Anthony's Shrine said that he would take responsibility for detonating the bomb as the Shrine was located close to his house. Zahran had run a team of four spies and their main duties was spying on Colombo city police stations, the Naval head-quarters, searching for information on two Islamists who head left Zaharan's group and were ordered to be killed by him and searching for safe houses, the Sub Inspector further said in testimony before the Commission.

Meanwhile, the 5 member Commission ordered to record further testimony of the Sub Inspector without the presence of the Media.

Parliament sources said that some Opposition leaders asked for a four day debate on the subject but finally it was decided to hold the debate for two days. The Third Reading on the matter will be taken at 7.30 pm on October 22.

The round of questions for oral answers would not be held during these two days and the debate would last without a lunch break as well.

The Draft Bill of the 20th Amendment to the Constitution was tabled in Parliament for the First Reading on September 22. Justice Minister Ali Sabry presented the 20A Bill to amend the Constitution of the Democratic Socialist Republic of Sri Lanka.

The objective of the proposed 20th Amendment is to reverse most of the changes brought about by the 19th Amendment which was enacted by the previous Good Governance Government. It was also a key election pledge of the ruling Sri Lanka Podujana Peramuna (SLPP).

The President is targeted and the Police and Defence Ministry, including the Defence Secretary are being targeted and blamed. However, these people who are attacking and criticizing us are also citizens of this country. Perhaps they are disturbed that the arrest of Bathiudeen has been delayed or they may be worried about their safety and that of the country," he said.

However, the Defence Secretary added that while their concerns are understandable, there is a mechanism that needs to be followed by the police in making these arrests. "In Rishad Bathiudeen's case he was to be arrested but unfortunately, the news of his pending arrest was announced to the media and the media announced in to the public."

He said that the procedure was for the CID to record a statement from Bathiudeen and arrest him subsequently. "However, once the news of his pending arrest was broadcast, he went into hiding and now his lawyers have filed a writ application. Even though the police department is capable, that does not mean that they can find anyone who decides to hide from them, in a matter of hours or days. It is only two days since the order to arrest him was issued and although the process may take some time, people need to be patient. We don't want to show any mercy to Bathiudeen or his associates, but we must ensure justice to the victims. We will find him, but give us time," he urged.

When a person is in hiding he will not make himself available to be arrested by the authorities, said Maj.Gen. Gunaratne, adding that invariably he will be on the run evading arrest. "Perhaps he has a safe house or maybe shifting from place to place. Since he is a politician who commands some vote base, he may even have followers ready to provide him facilities to hide," the Defence Secretary noted. "However, we are doing our best and I am confident we will be able to get him very soon."

Through this intervention petition, Rev. Fr. Lorenz Ramanayake, the Director of Seth Sarana Caritas Colombo which functions under the direct aegis of Colombo Archbishop Malcolm Cardinal Ranjith is seeking an order to dismiss Riyaj Bathiudeen's writ petition in limine.

This intervention petition had been filed through President's Counsel Sanjeewa Jayawardena, counsel Rukshan Senadheera and Manisha Dissanayake and the intevenient petitioner is further requesting court not to issue Interim Order in favour of Riyaj Bathiudeen.

The intervenient petitioner stated that at a media conference held on April 19, 2020, the Police Media Spokesman had categorically stated that the evidence had been elicited against the petitioner Riyaj Bathiudeen for his involvement in the Easter Sunday attacks. The petitioner said he got to know that the petitioner had been suddenly released from CID custody on September 29.

The intervenient petitioner stated that the release of petitioner was to the grave and anxious concern of as much as Police had previously stated publicly that there is damning evidence inextricably trying the petitioner to the Easter Sunday terrorist attacks.

The intervenient petitioner further said that the Cardinal Malcolm Ranjith has already expressed his disapproval regarding the releasing of Riyaj Bathiudeen.

Pursuant to the complaints, the NMRA said it had also intervened to ensure that excess charges for the medicines used by the two patients were refunded to them.

Issuing a press release, NMRA Chairman Asita De Silva said that maximum retail prices have been imposed on several types of essential medicines and medical devices through a Gazette Extraordinary No.2123/35 on May 15, 2019 and these price regulations are applicable to all brand names and generic names of selected medicines.

"The NMRA also informed healthcare institutions to adhere to selling prices even for in-ward patients. Violating these provisions would be treated as an offence under NMRA Act, No.5 of 2015 and offending hospitals may have their pharmacy licenses cancelled," release said.

The NMRA advised the general public to be vigilant and complain to the Authority if they are over-charged for prescribed medicines and to visit www. nmra.gov.lk for further details on medicines under the price regulation through Gazette notification.

"However, the manager had not taken it seriously resulting in disrepute to this company which contributes immensely to the country's economy. The Covid situation in the country has gone this far due to the irresponsible conduct of certain officials of the company where the Covid-19 positive workers were detected."



But, now it has happened and the situation needs to be evaluated to determine what went wrong and where things went wrong, he said, adding that when Corona was spreading around the world, President Gotahaya Rajapaksa ensured the mechanism was set to deal with the situation.

"The military was ready, the health department was ready, police and the government elements including Government Agents (GA) and Grama Seva Niladharis were all ready. Everyone got together and the Task Force was placed under the leadership of the Army Commander and the situation was brought under control. Even when the Navy cluster was detected, we were ready to handle the situation. But, unfortunately this time around it is perhaps negligence due to ignorance by these persons that has led to this situation. But, since we have the mechanism in place, there is no serious danger and we are capable of handling the situation. The Defence Secretary however, made two requests from the people to be truthful in disclosing their whereabouts and adhere to the instructions recommended by the health authorities and the military such as washing hands and maintaining social distance etc," he said.

General Gunaratne said however, that the next two weeks is crucial and the situation has to be monitored closely. "Thereafter, we will see what the situation is and take the required decisions at that time."

Accordingly, the courts will either sentence those who violate the orders to a prison sentence of six months or impose a fine of not more than Rs.10,000 or both.

In addition, this gazette notification indicates the entry and maintenance of business and workplaces. Everyone who enters a workplace or place of business must wear a face mask at all times. Maintaining a social distance of not less than one meter between two persons. Measuring everyone's body temperature before entering the workplace. Providing adequate hand washing facilities with sanitizer. Maintain a document containing the name, identity card number and contact information of each visitor. Keeping the number of employees and other persons in the workplace not exceeding the maximum level.

Podi Lesie is cited as the second respondent in the case which was trialed at Galle magistrate court in the absence of the suspect.

However Podi Lesi is currently under the custody of Criminal Investigations Department on detention orders obtained from the Magistrate's Court on Thursday.

The Magistrate further ordered the respondent to report to the Criminal Investigation Department on every Sunday on completion of the detention period currently in progress and asked him to hand over the Passport (If he possesses) to the judiciary.

The defense lawyers making the application for bail for the suspect pointed out that although the court was told that the suspect had made death threats to the President, the Defence Secretary and others in the respective 'B' report there was no mention about inflicting death threats to the President. In that report the suspect had been charged for threatening and obstructing the official duties of the prison officers all of which are bailable offences. Hence, the defense pleaded for bail for the respondent

In response to the bail application, Deputy Solicitor General Dileepa Peiris affirmed that the suspect had made death threats upon the President and Defence Secretary stating that both of them will exist only for three years more. He had also threaten that within two hours they could arranged an armed attack to the residences of them.

The Deputy Solicitor General also argued that if a criminal of his nature would be released and sent home a more severe crimes could be expected. He also charged that Podi Lesi had planned to commit a mass homicides (a series of murders) and there by create history in the country. So, he vehemently objected the grant of bail to the suspect.

The Magistrate after considering the submissions from both parties released the suspect on above bail conditions

Former UNP chairman and Samagi Jana Balawegaya General Secretary Kabir Hashim told the Presidential Commission to Inquiry (PCoI) probing the Easter Sunday terror attacks on Thursday that Muslim MPs resigned from the Yahapalana Government to protect the government and not to protect Rishad Bathiudeen after a No-Confidence Motion was brought against him






The two storied building was constructed about two years ago by the Mahaweli Development Authority at the cost of 51 million.





The "New Normal"

he gazette giving legal effect to the prevailing health guidelines, issued by Health Minister Pavithra Wanniarachchi it is hoped, would act as an effective deterrent to those acting irresponsibly vis-a-vis the Coronavirus pandemic. According to the new gazette, a fine of Rs. 10,000 and/or a six month prison term will be imposed against violators of the health regulations in force. This time around the law ought to be imposed in all its severity if the problem is not to get out of hand, like in some other

It is the leniency adopted during the first outbreak, perhaps, that led to the public taking a casual approach to the looming danger of a second wave. Any softening of the penalizing process would certainly make the Coronavirus assume more serious proportions in this country at a time when almost all the Western countries have re-imposed curfews and lockdowns.

Sri Lankans are notorious for their short memories and for letting their collective guard down after the immediate danger has passed, a trend that was amply witnessed during the war years. Already 168 curfew violators have been arrested in the lockdown areas in the Gampaha district which is a clear indication that a majority of the public are either gluttons for punishment or seized by a death wish, willing to expose themselves to the deadly contagion.

Several thousand curfew violators were taken into custody during the first outbreak. In all probability they would have been left scot free after a warning. No wonder some people do not take curfews seriously. This time around the curfews and isolations must be strictly enforced and any violators severely dealt with.

Apart from making wearing face masks compulsory and the one metre distance rule, the gazette stipulating the restrictions in factories and workplaces too is timely. These places have very large work forces especially in factories involved in production activities. Besides a majority of these premises are not equipped to accommodate the full complement of such a workforce, bursting at the seams. Hence, the restrictions specifying the numbers that could be accommodated on any single day is a positive step, especially given that the second wave outbreak originated in a workplace that employed vast num-

According to Army Commander Lt General Shavendra Silva who is also Head of the Anti-Coronavirus Task Force, all cases detected so far have traced their origin to the Brandix cluster, ruling out a community spread. However, the unearthing of cases in large numbers on a daily basis from all districts in the country should be viewed with alarm, although everything is being done by those involved in hunting down the multi-tiered contacts. Their dedication and sacrifice should be appreciated by all.

However they are confronted with a problem - the unwillingness and reluctance on the part of those having had contact with the Brandix cluster in some form or other to respond to calls to submit themselves for quarantine. Most feel that doing so would mark them as social outcasts and the fallout from such an eventuality on their social life and also employment, while others are averse to entering quarantine centres due to other reasons, which according to Lt. Gen Silva had compelled his men go for the hard option and force such persons to see sense. After all, it is for their own good and good of the community at large. The larger benefit this will entail to all concerned is worth the price of a certain degree of inconvenience and sacrifice.

Like what Police Spokesman DIG Ajith Rohan said what they seek is not to intimidate anyone but to provide a shield against the spread of the Coronavirus. It is the duty of all citizens, therefore, to cooperate in this exercise.

The gazetting of the regulations making compliance mandatory under the law will ensure that the "New Normal" concept is permanently embedded in community life in this country as elsewhere in the world. This is because the, Coronavirus pandemic, while causing monumental upheaval, admittedly, has also brought in its wake certain positives such as constant adherence to good health practices.

During the strict regulations and restrictions forced down on the people due to the pandemic, it was a telling revelation on how the world would have been a better place to live in had these regulations and guidelines been in existence earlier, which would have even prevented the spread of the pandemic with such devastating effect.

With the World Health Organization (WHO) warning that the COVOD-19 would remain in our midst at least for the next two years before a viable vaccine is made widely available, it is just as well that we settle down to the "New Normal" life pattern right away. In that respect the gazette containing the enforced guidelines could not have come at a better time.

SRILANKA: NEWFOREIGN POLICY VISTAS

The short-notice Colombo visit of a high-level Chinese delegation, to be followed now by US Secretary of State Mike Pompeo's this month-end should be of interest as much to the Indian strategic community as to their counterparts in Sri Lanka. The question is that if the Chinese visit was a reaction to the recent Quad Ministerial Meet at Tokyo, and the delayed one by Secretary Pompeo, likewise, has been influenced by the

"Negotiations are underway for a ¥10 billion (Renminbi) currency-swap agreement between the Central Bank and the People's Bank of China, to address the current liquidity crunch," says Ajith Nivard Cabraal, Money, Capital Markets and Public Enterprise Reforms Minister, only days after the visit of a Chinese delegation, headed by former Foreign Minister, Yang Jiechi, now a leading Politburo member. Converting as US\$ 1.5 billion swap (approx), this is much bigger than the \$400 million swap deal with India, with 'technical negotiations' already on for another US\$ 1 billion swap.

Central Bank Governor during the presidency (2005-15) of Mahinda Rajapaksa, now Prime Minister, and Cabraal recalled how he had signed such a deal in his time. As if to make greater sense, or make light of what is otherwise seen as a further Sri Lankan tilt towards China, he indicated the possibility of the Government approaching the IMF for funding, instead. "If we have to go and hold the International Monetary Fund's (IMF's) hand — or if the IMF has to hold our hand — that, I think, is a danger signal. We know we have to get our debt situation under control. Do we need the IMF to say that? No," he said, by way of explanation.

During the Yang team's visit, China offered a US \$90 million grant towards Covid-related medical assistance, promised a further US\$ 500 million loan to Sri Lanka, repayable in ten years. The loan-agreement, as it turns out, was to have been concluded during Prime Minister Mahinda Rajapaksa's Beijing visit, which had to be delayed, and will be signed soon in the Chinese capital.

Following the successful conclusion of exchanges between the two sides, Sri Lankan President Gotabaya Rajapaksa is expected to visit China later this year — his first after assuming office. Thus far, also because of the intervening Covid-19 pandemic, President Gotabaya Rajapaksa's overseas visit was restricted to meeting with neighbouring India's Prime Minister Narendra Modi in New Delhi.

At talks with the Chinese delegation, President Gotabaya Rajapaksa pointed out that China had been a long-standing friend to Sri Lanka. It supported Sri Lanka to defeat terrorism and to build infrastructure, including the Hambantota Port, the Port City and Southern Expressway. He highlighted how "irrespective of the administration in power" in Colombo, bilateral ties had grown.

As if in this context, President Gotabaya Rajapaksa said that the Hambantota Port was Sri Lanka's idea, and not that of China, and the latter offered to fund it. Now, many geopolitical analysts call it a Chinese debt-trap to gain control over Sri Lankan affairs.

"I want to prove that it is not the case and that this large-scale project will help improve the living standards of the people." If the current focus is on the promised Chinese-funded SEZ at Hambantota, it remains to be seen, how much of Sri Lankan exports (as against imports) it would handle.

Read between the lines, President Gotabaya Rajapaksa was sending out a message to overseas critics that Ham-

Ajith Nivard Cabraal bantota was a 'national project' of Sri Lanka and there was across-the-board consensus in the matter. Clearly, he was referring to the predecessor Government of Prime Minister Ranil Wickremesinghe converting Mahinda era construction-cum-concession contract into a 'debt-equity swap' deal, handing over Sri Lankan 'territory' to a Chinese firm on a 99-year lease.

According to an official release from the Sri Lankan President's office, President Gotabaya Rajapaksa said he wanted to bring to Sri Lanka the type of development in rural areas that he had seen during his 13 visits to China before he became President (mostly when he was war-time Defence Secretary under President Mahinda, his brother).

President Gotabaya Rajapaksa wanted Sri Lanka's trade-deficit with China to be lowered with China buying more Sri Lankan goods. He pressed for more Chinese investment and visitors. He encouraged Chinese participation in the domestic tea auction. He also called for the establishment of a technology university in Sri Lanka with Chinese backing. According to reports, the two sides will also revive negotiations on a bilateral Free Trade Agreement, stalled during the Wickremesinghe rule.

Independence and sovereignty

Yang declared that China will firmly

stand with Sri Lanka to protect the country's independence, sovereignty and territorial integrity at international fora, including the UNHRC (where Colombo faces reprimand of some kind in the March 2021 session, after a twoyear leeway).

In a recent interview, Alaina B. Teplitz, the US Ambassador to Sri Lanka, told a Colombo-based newspaper: "Sri Lanka should engage with China in ways that protect its sovereignty. Sri Lanka is a sovereign nation, but we do believe it is better for countries if transactions are transparent and cost-effective, and if they create jobs and other material bene-

fits for local people.' It is in this context, revived talks of an early Colombo visit by US Secretary of State Mike Pompeo, towards October-end, and assumes added significance. While the visitor will press the hosts on the pending US proposal on the US\$ 480 million 'Millennium Challenge Cooperation' (MCC) connectivity project in Sri Lanka, the Rajapaksa leadership can be expected to feel the pre-poll American pulse on the UNHRC resolution.

The US concerns on China in Sri Lanka's Indian Ocean tri-junction with India and Maldives are well known. The US and India are partners in the four-nation Quad, also involving Japan and Australia. Recently, it signed a 'Framework

Agreement' for military cooperation with Maldives. Back home after the Quad Ministerial in the Japanese capital recently, Secretary Pompeo declared that "India needs the US as an ally" and talked about the 'China

According to media reports, Secretary Pompeo's Colombo visit is timed to coincide with his presence in Delhi. Citing Pompeo dropping his planned Colombo visit last year after Gotabava became President, a section of the Sri Lankan strategic community is curious if the rushed visit now was prompted by the Chinese delegation.

Form and content

The Chinese visit happened days after Prime Minister Mahinda Rajapaksa had held the customary first consultations after coming to power with Indian counterpart Narendra Modi, this time through a virtual summit, owing to the Covid pandemic. Between the two Asian powers, the question now arises if the preference for India is only in form, and not necessarily in content — whoever is in power in Colombo, post-Cold War.

Needless to point out, President Gotabaya Rajapaksa was profuse in his appreciation of China after meeting with the Yang delegation but was business-like on his exchanges with Prime Minister Modi, in interviews to the Indian media.

India already has a 'Neighbourhood First' policy, into which Sri Lanka very much fits in. Gotabaya Rajapaksa used his Delhi visit, after his election as President, to reiterate successive Sri Lankan Government positions that his administration (too) would follow an 'India First' foreign policy (which also implied security policy). After the Parliamentary Polls, his new Foreign Secretary, Admiral Prof. Jayanath Colombage said so in a series of interviews to the local media.

Given the trajectory of the China relations, now as under the predecessor Mahinda regime, Sri Lanka's 'India First' policy will obviously be confined to bilateral security issues and New Delhi's concerns in the mat-

This has become near-obvious, given Sri Lanka now wanting to review the India-Japan ECT project in Colombo Port, apart from the American-funded MCC scheme and Japanfunded 'light rail project' to decongest Colombo City — all of them signed by the predecessor Wickremesinghe administration.

In between, the Sri Lankan state too would be evaluating its own immediate security concerns, that too in the face of the Indo-Pacific Quad's increasing attention to the Indian Ocean Region (IOR), and the US' Framework Agreement with

While India may be reassessing its circumstances and priorities, Sri Lanka may also be seeking to reposition itself in the ever-evolving Indian Ocean geo-strategic scenario, where the nation may have as much to lose as it can gain, depending on what game it wants to play, how and

There is heavy voting in many states in the US with just more than two weeks for the presidential election on November 3. More than 15 million have already voted, and polls observers see the current voting numbers as staggering in a pre-election situation.

Both parties - Republican and Democratic - are steering supporters toward mail-in and early voting due to a surge in cases of coronavirus across the nation. Worrying case rises are experienced in battleground states including Wisconsin, Michigan and Pennsylvania, important for President Trump. Health experts have warned that large crowds on Election Day could worsen the health risks.

However, there are also moves by Republican governors and legislators to launch legal challenges to early voting by reducing ballot dropoff locations, and the placing of false ballot beves

President Donald Trump has moved to active campaigning, especially in what are considered the battleground states, where he won easily in the 2016 election, but is now showing a big drop in support.

Democratic rival Joe Biden holds a double-digit lead over President Trump less than three weeks from Election Day, a new Wall Street Journal/NBC News poll of registered voters finds. Mr. Biden is ahead by 11 points in the national survey, 53% to 42%, following a tumultuous few weeks that included Mr. Trump's nomination of federal Judge Amy Coney Barrett to the Supreme Court; the candidates' contentious, televised debate and the president's Covid-19 diagnosis and hospitalization.

There is also increased public interest in the US, on the Senate hearings on Judge Amy Coney Barrett nominated to the Supreme Court by President Trump, to take the place of Justice Ruth Bader Ginsberg who died recently. Judge Barrett, who is seen as extremely rightwing, has refused to answer many questions raised by Democratic Senators, especially about the legal support for abortions, the Affordable Care Act of President Obama - giving health insurance to many low-income Americans, which is now before the courts and will be taken up soon after

since the start of the pandemic on Thursday October 15 - which the prime minister has long said was his final cut-off date.

But despite no agreement being in sight, the Prime Minister Johnson is considering whether to prolong the exercise, potentially until the first week of November, to give the teams more time.

He spoke to the presidents of the European Commission and European Council on Wednesday night, where he "expressed his disappointment" that intensified discussions had led to little progress.

Downing Street said the prime minister would wait for the summit to conclude before he decided whether to pull out, with a decision expected after he heads home.

Boris Johnson will be advised by his chief negotiator that a trade deal with the EU is still possible should the prime minister ditch his deadline to exit by mid-October, and continue to negotiate with Brussels – as the French government offered a hint of compromise on fisheries

Pressure is mounting after the EU's chief Brexit negotiator Michel Barnier said the two sides are yet to make a significant breakthrough throwing doubt over whether Johnson's looming deadline will be met.

Top EU officials have warned the UK to stop trying to divide the EU27 in negotiations over the post-Brexit relationship, and said the UK is running out of time to reach a deal.


Germany's Foreign Minister Michael Roth and the EU Commission Vice President Maros Sefcovic issued the warning to London after participating in a meeting to prepare for an EU leader's summit in Brussels later this week.

The UK's Prime Minister Boris Johnson has already initiated legislation to make unilateral changes to the Brexit Withdrawal Agreement with the EU. He has set this week as his deadline for securing an agreement with the EU.

German Chancellor Angela Merkel vowed not to let Ireland down on Tuesday as part of any Brexit trade deal, while adding that EU member states are keen to come to an agreement with their British counterparts. "We want an agreement: from the Irish point of view in particular it is extremely important," Merkel said. "We won't let Ireland down but will continue to stick together in these exit negotiations," she added. France has said it is time for UK 'tactics' to be

Azerbaijan- Armenia

Heavy fighting continues between Azerbaijan and Armenia, with more than 700 reported dead, as the international community appeals

Russia has urged Turkey to work on bringing an end to deadly clashes in the Nagorno-Karabakh region, as Ankara has thrown its support behind Azerbaijan. Moscow's appeal came after Turkish President Recep Tayyip Erdogan on Monday demanded Armenia put an end to its "occupation" of Nagorno-Karabakh and called for it to leave the territory, which is internationally recognised as part of Azerbaijan.

"We call on all sides, especially partner countries such as Turkey to do all they can for a ceasefire and get back to a peaceful settlement of this conflict using political and diplomatic means," Kremlin spokesman Dmitry Peskov told journalists.

The fighting continues despite a ceasefire agreement between Azerbaijan and Armenia at talks held in Moscow last week.

The conflict between Armenia and Azerbaijan over the disputed region of Nagorno-Karabakh has fueled a fresh fight within NATO, with alliance members pushing Turkey to dial back its aggressive foreign policy and support a cease-fire in the Caucasus.

As the conflict over the disputed territory has escalated NATO Secretary-General Jens Stoltenberg called on Turkey to defuse the situation, given its decades of support for Azerbaijan. But Turkey has defied a joint call from the United States, France, and Russia for an immediate cease-fire in Nagorno-Karabakh.

Analysts fear that the conflict could spiral into wider regional confrontations; both Turkey and Israel have a close security relationship with Azerbaijan, Russia has a defense pact with Armenia, and neighbouring Iran is trying to play a role in mediating the conflict.

Brexit - No Deal?

A no-deal Brexit hangs in the balance as Boris Johnson says the outcome of Thursday's EU summit will dictate whether Britain will walk out of talks.

Britain, the world's sixth-biggest economy, left the EU in January and has since been locked in talks with the Union. EU leaders will hold a summit in Brussels this week to assess progress after UK Prime Minister Boris Johnson set a deadline for October 15 for a deal to be reached before the transition period ends on December 31. EU leaders met for their first Brexit summit

over. The French Foreign Minister told the Parliament, "As things currently stand, the hypothesis of a 'no deal' is a very real one, and also one that is unfortunately very likely today."

Meanwhile, the EU said on Tuesday that Brexit negotiations could drag on for weeks, into November, as Britain's self-imposed deadline for a deal was about to expire.

Afghanistan - heavy fighting

Tens of thousands of people in southern Afghanistan have fled their homes following days of heavy fighting between the Taliban and security forces, as violence continues to soar despite ongoing peace talks.

Taliban militants launched a series of attacks on the city of Lashkar Gah in restive Helmand province on Sunday night, prompting the US to call in air strikes to defend Afghan forces.

"More than 5,100 families or 30,000 people... have fled the fighting so far," Sayed Mohammad Ramin, director of the refugees department in Helmand, told AFP. "Some families are still living in the open in the streets in Lashkar Gah, we don't have tent to give them."

The Taliban's push in the strategic southern province of Helmand is again testing the strength of Afghan forces, as well as the US's commitment to its ally, only months after the US and the Taliban signed their own agree-

US warplanes are striking again, day after day, as the Taliban continue their attack. It's the time of year, as winter starts to close in, when violence often intensifies at the end of the fighting season.

The United Nations Assistance Mission in Afghanistan said thousands had fled and called on Taliban fighters and security forces "to take all feasible measures to protect civilians, inc.

safe paths for those wishing to leave" the area.

Under a deal the Taliban signed with Washington in February, the insurgents are not supposed to hit urban areas and are meant to keep violence down.

The US committed to pulling all foreign troops from the country by next May in return for Taliban security pledges and an agreement to begin peace talks with the Afghan government in Qatar, that appear to be stalled as the two sides have struggled to establish a basic framework for negotiations.

Belarus

As protests in Belarus continue there are warnings of a general strike there unless President Alexander Lukashenko announces his resignation. "If our demands aren't fulfilled by Oct. 25, the entire country will peacefully take to the streets," Sviatlana Tsikhanouskaya, the main opposition challenger in the recent presi-

dential election, said in a statement issued from Vilnius, Lithuania, where she's in exile after leaving Belarus under pressure from authorities after the country's disputed August 9 presidential election.

"On October 26, a national strike of all enterprises will begin, all roads will be blocked, sales in state-owned stores will collapse. You have 13 days to fulfill three conditions. We have 13 days to prepare, and in the meantime Belarusians will continue their peaceful and persistent protest," the statement said.

Belarus has been rocked by mass protests since August 9, when results of a presidential election reportedly handed President Alexander Lukashenko a sixth term in office. Tsikhanouskaya, who officials claim got only 10% of the vote, and her supporters refused to recognize the results as valid, saying they were riddled with fraud. The European Union and the United States have also refused to recognize the official results of the vote.

The rallies, some of which drew up to 200,000 people demanding the president's resignation, have posed the biggest challenge yet to Lukashenko, who has run the country for 26 years, relentlessly repressing the opposition and independent media.

In the first days of the protests, Belarusian authorities cracked down brutally on protesters, with police detaining thousands and beating scores. The government has since maintained the pressure, detaining hundreds of protesters and prosecuting top activists.

Last week President Lukashenko visited a prison to talk to jailed activists in a move commentators interpreted as an attempt to imitate a dialogue to reduce tensions. However, subsequently the authorities ramped up their crackdown on protesters, dispersing crowds with water cannons and stun grenades, hurting dozens and detaining hundreds.

Thailand protests

The Thai government has announced an emergency decree to stem largely peaceful protests in Bangkok, including a ban on large gatherings. The student-led democracy movement has called for the prime minister to resign and curbs on the king's powers.

Those arrested include key protest leaders the human rights lawyer Anon Nampa, student activist Parit Chiwarak, and Panusaya Sithijirawattanakul. Anon, 36, was the first to openly break the taboo on discussing the monarchy by calling for reforms in August. Panusaya became one of the most prominent faces of the protests since she delivered a 10-point manifesto urging royal reform later that month.

The decree from Prime Minister Prayuth Chan-ocha, a former junta leader, said protesters had intended to instigate an incident leading

to "chaos and incitement of conflict and public disorder" and caused "obstruction to the royal motorcade". Some protesters on Wednesday had raised the three-finger salute, a symbol of the movement, at a convoy carrying the queen as they were pushed back by ranks of police.

Shortly after the decree took effect, Thai riot police cleared protesters from outside the prime minister's office. Some tried to resist, using makeshift barricades, but they were pushed back.

In addition to limiting gatherings to four people, the decree puts restrictions on the media, prohibiting the publication of news "that could create fear or intentionally distort information, creating misunderstanding that will affect national security or peace and order".

The growing student-led democracy movement has become the greatest challenge in years to Thailand's ruling establishment. Protesters are demanding the resignation of Prayuth, a former army chief who seized power in a 2014 coup before becoming premier last year after a controversial election. They also seek the rewriting of the constitution, whose amendments in recent years have been disputed, as well as an end to the harassment of state critics.

Covid 19 - Global spread

Coronavirus is continuing its spread across the world, with more than 38 million confirmed cases in 189 countries and more than one million deaths.

The US has recorded more than 216,000 deaths from coronavirus - the world's highest official death toll. It is also fast approaching eight million confirmed cases, with 7,907,189 infected. India has the largest increase in numbers in Asia, with more than seven million confirmed infections, the second-highest official total in the world after the US, with 7,307,097 infected and 151,747 deceased. The country has, however, maintained a relatively low death rate, given the size of its population, and there are signs that cases and deaths may now have begun to decline.

In Latin America, Brazil has now passed 5m confirmed cases, although the number of daily new infections is now thought to be slowing. In Argentina, cases have been rising quickly - the country now has more than 900,000 infections.

In the Middle East, cases in Iraq have been rising steadily since June, with the country having recorded more than 400,000 cases in total. The virus is surging in many regions and

some countries that had apparent success in suppressing initial outbreaks are also seeing infections rise again.

The World Health Organization (WHO) has warned the global death toll could hit two million before an effective vaccine is widely in use. Lockdowns and other restrictions have been brought back in the worst-affected regions, especially in Europe, and there have been fresh appeals for people to wear face coverings and follow social distancing.

Israel imposed a new national lockdown after recording record numbers of daily cases in late September. The lockdown is due to be reviewed

and to be lifted only gradually. Other countries that have seen a resurgence of the virus include Peru, Canada and Russia.

The spread of Covid-19 in the UK has raised warnings of another national lockdown. Leading scientist Prof. Peter Horby said the UK was at a "precarious point" as Covid cases and hospital admissions continue to rise.

Prime Minister Boris Johnson has announced a three-tier system, where each region in England is placed into a tier based on the severity of cases in the area.

Prof. Horby, chair of the New and Emerging Respiratory Virus Threats Advisory Group (Nervtag) and a government adviser, said the "critical mission" now was to protect the NHS to avoid non-essential hospital services being cancelled, as many were when the UK went into its first nationwide lockdown in March. There are fears that the infected numbers would widely increase in November, leading to a national calamity.

French President Emmanuel Macron on Wednesday ordered a nighttime curfew for Paris and eight other French cities, after daily new infection rates reached record levels.

He said residents of those cities — having close to a third of the French population — would not be allowed to be outdoors between 9pm and 6am from Saturday, for duration of at least four weeks, except for essential reasons. "We have to act. We need to put a brake on the spread of the virus," Macron said.

"We are going to have to deal with this virus until at least the summer of 2021," Macron said, and "all scientists" were in agreement on that point. Germany will introduce tougher measures on gatherings and mask-wearing to fight a surge in coronavirus infections, Chancellor Angela Merkel said Wednesday after talks with the heads of Germany's 16 federal states.

Europe's biggest economy will begin imposing limits on people gathering at events as well as mandatory mask wearing at crowded places when new infections in an area reach 35 per 100,000 in seven days, earlier than under the previous yardstick used of 50 per 100,000.

G20 - Help

The Group of 20 nations, representing the world's biggest economies, has agreed to extend the suspension of debt payments by an additional six months to support the most vulnerable countries in their fight against the coronavirus pandemic.

The G-20 says the extension will provide ongoing relief for the \$14bn in debt payments that would have come due at the end of the year otherwise. Wednesday's decision gives developing nations until the end of June 2021 to focus spending on health care and emergency stimulus programmes rather than debt repayments.

International aid groups expressed disappointment that more debt relief isn't being provided by extending the moratorium on debt payments for a full year or by forgiving part of the debt rather than merely suspending payments.

At 20th Virtual Commonwealth Foreign Affairs Ministers Meeting

Minister Gunawardena calls for integrated strategies for multidimensional challenges

Foreign Minister Dinesh Gunawardena, leading the Sri Lanka delegation to the 20th Virtual Commonwealth Foreign Affairs Ministers Meeting (CFAMM) in the sidelines of the 75 UN General Assembly on Wednesday, called for innovative thinking, collective, and integrated strategies to address the multidimensional and cross-cutting challenges in the wake of the COVID-19 pandemic.

Highlighting that e-commerce and e-governance would define the competitive edge of countries in the post-COVID-19 world, Minister Gunawardena called for assistance to advance digitalisation of economies and services within Commonwealth member

He cited Sri Lanka's experience of conducting the first ever tea and rubber auctions via a digital platform, while the country also remained the first in South Asia to adopt international standards for digital transactions. He also proposed mobilising existing scientific and technical expertise and knowledge in the Commonwealth towards ongoing research related to COVID-19.

In this regard, the Foreign Minister highlighted the partnership between the University of Sri Java-

individuals to dengue infection, to understand immune responses to COVID-19 infections.

Minister Gunawardena, noting the unprecedented and adverse economic and social impact induced by the crisis on countries, underlined the urgent need for debt relief, loan repayment moratoriums, and financial stimuli to ease current difficulties.

Focusing on Sri Lanka's commit-

ments under the Action Plan of the Paris Climate Change Agreement, Minister Gunawardena informed that Sri Lanka planned to reduce 30% of GHG emissions by 2030 and move towards a resilient and cleaner future with low carbon economic growth by transitioning to hydro, solar, and wind power. He also underlined the need to identify the barriers, risks, and potential opportunities for scaling-

up climate finance for small states, including Sri Lanka.

The meeting was chaired by the Secretary of State for Foreign and Commonwealth Affairs and First Secretary of State of the United Kingdom, Rt. Dominic Raab MP, as Commonwealth Chair-in-Office. The CFAMM, which traditionally takes place in the sidelines of the United Nations General Assembly in New York, was held virtually this year amidst the COVID-19 pandemic.

The Sri Lanka delegation to the virtual CFAAM included Foreign Secretary Admiral Prof. Jayanath Colombage, Sri Lanka's High Commissioner to the UK Saroja Sirisena, and Director-General of the European Union and Commonwealth of the Foreign Ministry Dhammika Semasinghe.

MPs hold online panel discussion on 20th Amendment

An online (Zoom) panel discussion on the proposed 20th Amendment to the Constitution, themed 'After the 20th Amendment', was held with the participation of Government and Opposition Parliamentarians, civil and political activists, and academics, yesterday. The event was organised by the Department of Social Studies of the Open University of Sri Lanka.

Expressing his views, State Minister Premajayantha said the main purpose of moving the 20th Amendment is to reverse the problematic situation created by the 19th Amendment. According to him, the powers of this amendment would remain within the limits of the 1978 Republican Constitution and would not pave the way for an autocratic rule.

Dr. De Silva said the proposed amendment is solely an attempt to give extreme powers to one particular group and therefore, the Samagi Jana Balawegaya group he represents completely against this move. "We will stand by with the 19th amendment", he added. As a political party which follows the democratic path,

the Samagi Jana Balawegaya, would take every possible effort to defeat this amendment in the Parliament, he added.

Jathika Jana Balawegaya MP Dr. Amarasuriya said if this amendment is passed, the country would face a suppression by the ruling party. Therefore, the country would move backward and the democratic borders will also be limited. "This can be seen as a reflection of the original intentions of the 1978 constitution", she stressed.

Dr. Jayatileka, Prof. Bandara, and Nagamuwa also expressed their views at this discussion. Dr. Athulasiri Samarakoon coordinated the event, which was moderated by Lecturer Sumith Chaaminda.

Assigning the washing of clothes at Galle quarantine centres to external laundry services is prohibited, Galle District Regional Epidemiologist Venura K. Singarachchi said. All quarantine centres should provide their laundry details to the respective health authorities.

The washing and cleaning of used clothes of quarantine centres should be operated by corresponding centres accord-

ing to health regulations, following high standard scientific laundry methods which will be supervised by the health authorities, the epidemiologist added.

However, he affirmed that clothe washing undertakings of all quarantine centres have been carried out under quality and safe laundry processes. Especially the laundry processes at the quarantine centres maintained by Sri Lanka Navy are handled smartly and neatly, he

Former Swiss diplomat praises Lanka's quarantine process

Former diplomat from Switzerland Rudolf Albert Gauhl hailed the professional manner in which SriLankan Airlines and airport authorities quarantined people coming from overseas back to Sri Lanka.

Gauhl who was a top Embassy representative of Switzerland serving in Sri Lanka for nearly two decades said that he was so impressed about Sri Lanka that he decided to settle down in Sri Lanka after retiring from his diplomatic duties with his wife Hui.

In a bid to give back to Sri Lanka he set a Bright Light Foundation and was engaged in several CSR activities to help the underprivileged Sri Lankans.

He recalled that in mid-February this year they left for Switzerland in order to take part in the Lucerne Carnival. "The big bang and the carnival parades were great as always and the city of Lucerne shook and the carnival people experienced the best days of the year.'

However the corona pandemic moved around the world like a dark shadow with lockdowns and airlines after airlines stopped their flights.

"Airports all over the world closed indefinitely and our planned return flight was suddenly cancelled for an indefinite period. We were therefore blocked in Lucerne and my only hope was that at some point a window would open and a return journey to my host country Sri Lanka would appear.'

This window opened on September 25 when, thanks to the help of the Sri Lankan Embassy in Berlin and the Honorary Consulate in Zurich, we were suddenly offered a direct flight from Frankfurt to Colombo by SriLankan Airlines. (UL1506) Some foreigners and a large



number of Sri Lankan citizens, who were blocked for months after visiting their families because of Covid-19, were already waiting eagerly for returning to their home land.

"After the usual checking of the documents, we were accompanied to the cabin individually, keeping a safe distance. The stewardesses, masked from head to toe, insisted on receiving us with the unmistakable "Smile of Sri Lanka" despite the uncomfortable out-

The safety distance between the seats and the mask requirement also applied in the cabin. Dinner and breakfast were served in one-way service boxes and there was water served. After a perfect landing in Colombo the passengers were taken to Immigration and a compulsory PCR test followed."

"Later our disinfected travel bags



were checked by Customs and a scheduled AC bus brought us to the Jetwing Sea Hotel Negombo to undergo a compulsory 14 day quarantine."

The army itself has made available accommodation free of charge. During quarantine time, an additional PCR test was carried out after the 10th day of our stay. Guests will only be released if the test is negative.'

He said that strict precautionary measures applied in the hotel itself. "No third person was allowed to enter the guest's room. The body temperature was measured twice a day by a doctor and the guests were asked about their health condition."

Delicious food was served in one-way boxes which were deposited in front of the room door after prior notification. The consumption of alcohol is not permitted during this time."

"We believe that this entire process was done very systematically to world standards and this should be highly laud-

It's this professional pattern initiated by the government, tri forces and the health authorities that is still keeping the Covid patient count under 5,000 and most importantly death at 13.

Sri Lanka's outstanding success story in relation to the fight against Covid-19 deserves world attention and we would like to take this opportunity to thank and congratulate the Government for this achievement. In our case, a very special thank goes to the honorary consul of Sri Lanka in Zurich, the Stewardess from SriLankan Airlines and Dr. M. Abusayed, coordinator of the repatriation program in Colombo, who is a great support for many returnees in the airport through his commitment.

NINE-NIGHT CELEBRATION DIVINE POWER





This colourful Hindu festival has been celebrated for centuries. Its rituals are observed for different reasons within the wider Asian Hindu community. According to the ancient Hindu text Vaishnawa Purana, there are four seasonal Navarathri. However, in practice, it is the post-monsoon autumn festival called Sharada Navarathri which is reverently observed in honour of the deity Durga. The devotees worship the nine manifestations (avatar) of Maha Durga

he Hindu community in Sri Lanka and across the globe prepares to observe and celebrate the radiant festival of Navarathri. This year the traditional period of observance commences on October 17 (today) and concludes on October 25. The word Navarathri is derived from the Sanskrit language, and translates as nine nights and has the same meaning in many Asian languages.

This colourful Hindu festival has been celebrated for centuries. Its rituals are observed for different reasons within the wider Asian Hindu community. According to the ancient Hindu text *Vaishnawa Purana*, there are four seasonal Navarathri. However, in practice, it is the post-monsoon autumn festival called Sharada Navarathri which is reverently observed in honour of the deity Durga. The devotees worship the nine manifestations (avatar) of Maha Durga.

The corresponding month in the Hindu calendar is Ashvin, which falls in the Gregorian months of September and October. In India, which is the grand cradle of Hinduism, the Durga Puja (also spelt pooja) is synonymous with Navarathri, where goddess Durga battles and victoriously subdues a demon. The nine days are designated under three clusters to adore *Malai Magal*, *Alai Magal* and *Kalai Magal*.

A Hindu priest explained, "the Durga Puja festival marks the battle of Goddess Durga against the deceptive and powerful buffalo demon Mahishasura (Asura means demon). The Asura symbolizes the chaos and ignorance hidden inside one's outer appearance. In deeper context, this signifies the victory of good (Dharma) over evil. On the other hand, it is a harvest festival that appreciates the Goddess as the motherly influence which sustains creation according to Hindu belief. The Durga Puja festival dates coincide with Vijayadashami, where the victory of Rama is exalted.

During the Durga puja, other Hindu deities are also worshipped including Lakshmi (the Goddess of Prosperity and Wealth), Saraswati (the Goddess who bestows wisdom and music), Ganesha (who offers good beginnings) and Karthikeya (the God of War). The ritual of this Durga puja can be found in the 12th century scripture of Yasatilaka, which is said to be written by Somadeva where an ancient king offered a puja after a battle victory on an annual basis.



The *Puranas* (a vast genre of ancient Indian literature) associate Durga puja with the spring festival. In keeping with this belief, Tamil farmers used to offer a bundle of nine plants called *Navapatrika*, denoting the nine manifestations. Also, nine grains known as *Navadhanya* were offered. Today this practice is still seen in Tamil agricultural communities in the Northern Province.

The Indian religious cultural celebrations include extravagant stage decorations, recital of the legend, enacting of the story, and chanting of Hindu scriptures. I have witnessed the latter at various kovils and it is a beautiful display of devotion.

On the final day, called the *Vijaya-dashami*, the statue of Durga is immersed in a river symbolizing her return to the Divine Cosmos.

On the other hand, the statue symbolizing evil is burnt with fireworks marking the total defeat of evil forces. This festival starts the preparation for another important festival, Diwali or Deepavali (the Festival of Lights), which is celebrated 20 days after *Vijayadashami*. Diwali is one of the most vibrant religious festivals across the world with its dazzling lights.

These nine days are solemnly dedicated to the Goddess Durga and her nine avatars, where each day is dedicated to an incarnation of the Goddess.

Hindu scholars describe the significance of each of these nine days-



Known as Pratipada, this day is for Shailaputri (meaning "Daughter of Mountain"), also Parvathi. It is in this form that the Goddess is worshipped as the consort of Shiva; she is depicted riding Nandi the cow. The colour of the day is bright crimson (red) which depicts action and vigour.

DAY 2: Brahmcharini

Goddess Brahmcharini, another incarnation of Parvathi, is worshipped. In this form, Parvathi became Sati, her unmarried self. Brahmcharini is worshipped for emancipation or Moksha and endowment of peace. The colour of the day is royal blue which depicts calmness and energy.

DAY 3: Chandraghanta

Tritiya commemorates Chandraghantha - the name derived from the fact that after marrying Shiva, Parvathi adorned her forehead with a half-chandra (meaning moon). She is the embodiment of beauty, yellow being the colour for this day.

DAY 4: Kushmunda

Kushmunda is worshipped on Chaturthi. Believed to resonate the power of the universe, Kushmunda is associated with the endowment of vegetation on

earth. Green colour dominates this day. She is depicted as having eight arms.

DAY 5: Skandmatha

Skandamatha is worshipped on Panchami, the mother of Karthigeya. The colour grey is symbolic of the transforming strength of a mother when her child is confronted with danger. She is depicted riding a defiant lion, and safely defending the baby.

DAY 6: Katyayani

Born to a sage, Katya, is said to be an incarnation of Durga and is shown to display courage which is symbolized by shades of bright orange. Venerated as a warrior Goddess, this is a violent form of the Goddess Parvathi.

DAY 7: Kalaratri

She is considered the most ferocious form of Goddess Durga. Parvathi removed her fair skin to destroy Sumbh and Nisumbh, two demons. The colour for the day is white. The other forms associated with Kalaratri are Bhadrakali, Rudrani and Bhairavi. The fierce Kalaratri attired in red is said to destroy ghosts, demons and negative forces.

DAY 8: Mahagauri

Symbolizing intelligence and peace, the colour associated with this day is pink which endorses optimism. In this form, her right hand holds a trident and Mahagauri majestically rides a white


DAY 9: Siddhidatri

On the last day of the festival also known as Navami, people pray to Siddhidaatri. Sitting on a lotus, she is believed to possess all type of Siddhis. She is affectionately known as Saraswati Devi. The last day is believed to be the culmination of all the religious aspirations of those who worshipped.

Over these nine days, Hindu devotees will visit kovils around the country. However, this year there will be some restrictions due to COVID- 19. The Northern Province will have many pious pujas as villagers collectively celebrate these nine days of devotion. Navarathri is a beautiful confluence of Hindu faith and Tamil culture. It is a time for thoughtful reflection and spiritual refinement of the human. It reflects the multireligious population of Sri Lanka and powerfully projects our cultural diversity.







AMISSIONTO SERVE HUMANITY

he Anglican Church of Sri Lanka was bestowed with a new Bishop for the Diocese of Colombo. Reverend Dushantha Lakshman Rodrigo, affectionately known to thousands as Fr. Dushy was recently appointed as the 16th Bishop of Colombo.

S. Thomas' College, Mount Lavinia

The decision to appoint him to this high office in the episcopate was made by His Grace Justin Welby, the Archbishop of Canterbury, in his capacity as the Metropolitan of the Church of Ceylon (Sri Lanka). The Episcopal ordination and Installation into this high office is set to take place in November at the Cathedral of Christ the Living Saviour Colombo. The installation of an Anglican Bishop is a key ceremony in the church, laden with decorum.

I have been privileged to know Fr. Dushantha Rodrigo for the past 15 years. He is an unassuming gentleman, a prudent decision-maker, a leader with Christian charisma and importantly a humble person. He is blessed with a sense of humour which he gently unleashes from time to

I recollect many instances of his humility and resolute character. In 2017, there was a cyclone like wind condition in some parts of Sri Lanka. On hearing the terrible damage this wind had caused to the buildings of S. Thomas' Preparatory School, I visited the school with my friend Ravi Francis. I was not surprised to find Fr. Rodrigo attired in his cassock standing in the middle of the junior playground, amidst the rain. Ravi ran back to the vehicle to grab an umbrella for the Headmaster. The humble Fr. Rodrigo proceeded to talk to me, politely refusing the umbrella. His heart was totally focused on rebuilding the damaged sections and recommencing school. He did the rebuilding with great passion supported by all old boys. He is a leader who boldly leads by example, a trait which is important for such a high office which deals with the spiritual formation and guidance of all Anglican adherents.

Fr. Dushantha Rodrigo becomes the first Thomian to take on the mantle of Bishop of Colombo. Ever since Rt. Rev. James Chapman, the pioneer clergyman who sailed to Ceylon, set up the Anglican Churches and schools such as S. Thomas' College (STC), there were no Bishops from STC, Mount Lavinia. The great school by the sea has produced many good priests but no Bishops. Interestingly, cricketing rivals Royal College has produced four Bishops. Thus, the vision of Rt. Rev. James Chapman (the first Bishop of Colombo) took almost 169 years to become a reality with the selection of Rev. Dushantha Rodrigo. Needless to say that the Thomian community is very jubilant about their son who has created history.

I met up with the Bishop-designate at school. He was seated in his office. Fr. Dushy explained, "I started my education at S. Thomas' College, Mount Lavinia. I am from the batch of 1987. In school, I was fond of playing soccer and cycling. I took a keen interest as an altar server in the Chapel of the Transfiguration. During my college days, I worshipped at Christ Church Dehiwela, where I was also an altar server. The Vicar Fr. Lionel Peiris realized that I had the character of a priest. I too felt the voice of God gently prompting me towards the ordained ministry. This was duly identified by the Chaplain of S. Thomas' College Fr. Sunil de Silva, who subsequently left the college. He updated the Sub-Warden Fr. Duleep de Chickera (who later became Bishop of Colombo) to mentor me and guide me towards God's service. As I look back I can say with great respect and gratitude that Rt. Rev. Duleep de Chickera helped me and remains my mentor to this day.

can Church. Young Dushantha Rodrigo was fresh out of school. He spoke to the then Bishop of Colombo Rt. Rev. Swithin Fernando who said, "Son, you are still young. Why don't you work somewhere for two years? Learn to experience the corporate sector and then if you really want to serve God, you will break every fetter and return to the church." The young Thomian worked at Ford Rhodes (presently KPMG) and then faithfully answered the call of Christ's gospel. He underwent his Parish training for one year at St. John's Church, Colombo 15 before entering the Theological College of Lanka at

there was a gale-force wind. Before we could enter our home the big banyan tree came crashing down on the house, had we been inside we would be dead. God saved us. The system of education had changed a lot and we did not have corporal punishment. The students were seen and also heard. "In recognition of his service to the school, he was appointed Acting Warden. In keeping with the requirements of the church, he was relocated as Vicar of St. John's Church, Nugegoda where he served for five years.

The year 2015 was a significant year for Fr. Dushantha as the Bishop invited him to take on the mantle of Headmaster, S. Thomas' Prep

His ministry knowledge was further augmented with a Bachelor of Divinity degree from the Senate of Serampore, India. Recognizing the potential of this dynamic young priest, he was posted as the Chaplain to S. Thomas' College, Gurutalawa. Over the next few years, he served as curate and vicar of many churches including

a stint in Matara. Bishop-designate Rev. Dushantha Rodrigo recalled God's divine grace over his life, and added, "I was the vicar at Christ Church Mutwal where a great banyan tree has stood for nearly 150 years, in the church garden. One night I returned home with my wife around 11 pm after conducting a bible study. Suddenly

Dushantha Rodrigo as he has accepted the invitation to become the Bishop of Colombo. Fr. Dushy is no stranger to my Archdeaconry as he was here last year to conduct a workshop on liturgy and worship. He was also at St. John's College on two occasions in my three and a half years here. On both occasions, he came to Jaffna using public transport - once to witness his under 17 cricket team play against St. John's College in 2017 and next for the installation of the new principal of the college this year.

The church in the North joins me in praying for Fr. Dushy as he will face the challenge to be a shepherd who will understand the hardship his flock is enduring and stand in solidarity with them in their efforts to search for truth and justice and meaningful solutions to governance issues and in the collective journey towards reconciliation."

As the Anglican Church in Sri Lanka moves forward with her new Bishop it would be prudent to remember the words of the great theologian St. Augustine who said to fall in love with God is the greatest romance, to seek him the greatest adventure, to find him the greatest human achievement. This is a magnificent journey of a young altar boy who remained faithful to his calling and whom Almighty God blessed and duly promoted as Bishop.

WHO shows 'great concern' over Europe virus surge

DENMARK: European countries have unveiled tough new measures to try to curb a surge in COVID-19 coronavirus infections which the World Health Organization (WHO) warned is of "great concern".

Underscoring the disruption wrought by COVID-19 even in the corridors of power, US Presidential candidate Joe Biden's running mate

Kamala Harris suspended travel after a staffer contracted the disease and EU chief Ursula von der Leyen abruptly left a summit in Brussels for a similar reason. And in France, police

searched the home of the health minister as part of a probe into the government's handling of the coronavirus crisis, as new daily cases topped 30,000 for the first time.

A map published Thursday by the EU's ECDC disease control agency handed a red label for high rates of transmission and positive testing to more than half the 31 countries it monitors, which include non-EU members.

As the disease marches on relentlessly, millions in England are facing tighter restrictions, including a ban on household mixing.

Meanwhile Queen Elizabeth II made a first public appearance outside a royal residence since the start of the pandemic, going unmasked during a visit to a topsecret British government research

Across the Channel, a curfew is to be imposed in Paris and eight other French cities and in Germany there are new limits on people gathering at events.

Announcing a partial lockdown in "red" zones including major cities, Poland's government asked people to work from home if possible, while Switzerland's health minister Alain Berset said the situation there "is deteriorating faster than

Both countries are facing record levels of new infections.

With nearly 1.1 million coronavirus deaths and close to 40 million cases worldwide, countries in many parts of the world are facing tough choices on how to control the disease without the economic and social devastation wrought by nationwide lockdowns.

In India, where the pandemic has upended a movie-mad culture, some cinemas were allowed to reopen Thursday to try to attract punters back to the cash-strapped silver

Israel, meanwhile, said it was lifting an unpopular ban on citizens flying out of the country in an easing of a second nationwide lock-

At a press conference in Copenhagen, the WHO's regional director for Europe Hans Kluge told reporters it was time to "step up the measures" as rising case numbers on the continent were of "great concern."

Britain hopes a local three-tier system will fit the bill, with London heading into level two at the weekend and northwestern city Liverpool the only area in the top level, with strict limits on social mixing including the closure of pubs.

In France, police searched the home of Health Minister Olivier Veran, one of several current or former ministers being probed following complaints by victims of Covid-19 that they were slow to act to check its spread.

The action came after France announced a virus shutdown between 9 pm and 6 am in Paris and other hotspot cities that will

remain for as long as six weeks. In neighbouring Spain, bars and restaurants will close across the northeastern region of Catalonia for the next 15 days, while Germany said daily infections have reached levels not seen since the start of the pan-

Breaking with past practice, China has sought to avoid a major lockdown after an outbreak in the port of Qingdao, testing almost 10 million residents but allowing people to come and go as they please.

Countries across Africa - which accounts for just over four percent of global cases -- have also eased lockdowns and travel curbs over the past month, but weekly cases and deaths have ticked up, according to the Africa Centres for Disease Control and Prevention.

Donkey therapy to help Spain's stressed-out doctors

dock, a young nurse is quickly surrounded by a group of donkeys gently nudging her for attention as she strokes their soft noses and feeds them

When someone places a 10-day-old colt in her arms, Monica Morales squeals with delight, visibly relaxed after a few hours unwinding at El Burrito Feliz - "The Happy Little Donkey" -- an association offering free donkey therapy sessions to medics fighting the virus. Known as animal-assisted therapy, such encounters can help with a range of physical and mental disorders, including stress, depression and anxiety. Although such therapy is more associated with horses, experts say donkeys are better suited to helping mental or emotional disorders given their gentle nature and intuitive respect for personal space.

"The situation is quite overwhelming, what we went through before is now happening again," says Morales, 25, who spent months working in a Madrid hospital when the pandemic hit. She is now based in the south as Spain faces a second wave.

"There are more and more patients, and growing tensions among colleagues so being here with these donkeys is really helping." Located by a sprawling forest on the edge of Andalusia's Donana National Park in southern Spain, El Burrito Feliz is a nonprofit association with 23 donkeys that

SPAIN: Walking into a dusty padhave worked with Alzheimer's patients and children with problems.

The "Doctor Donkey" project began in late June as a way of offering respite to frontline workers battling a virus that has killed some 33,400 people, infected more than 900,000, and left medics traumatised and exhausted.

"The huge stress created through the daily struggle with Covid-19 exhausts them, so here they can be strengthened through therapy with the donkeys," explains Luis Bejarano, 57, who runs El Burrito Feliz.

"They can recharge their batteries to keep fighting another day." Bejarano says the idea came from a book about Japan's therapeutic forests where people spend time among trees to reduce stress and depression as an alternative to therapy.

"The situation generates a lot of anxiety and stress because of the risk of getting infected, or passing it on to colleagues, family members or other patients who are more fragile than usual," says 31-year-old oncologist Mari Paz Lopez. And the risk of falling ill is very real, with one in 10 of Spain's healthcare workers getting infected -- twice that of the general population and one of the highest rates in the world. "We've not been offered any psychological help although I know it exists in other places," says Lopez who works in the southern city of Jaen and heard about the donkey therapy through television. - AFP

Over half of EU countries 'red' on new virus travel map

SWEDEN: More than half of countries in the EU, plus the UK, were on Thursday labelled red in a new map issued by the bloc's disease control agency aimed at guiding decisions on travel restrictions.

The map was issued after EU member states decided on Tuesday to coordinate their approach to travel restrictions on other countries in response to Covid-19 outbreaks.

Seventeen of 31 countries covered by the European Centre for Disease Prevention and Control (ECDC) were labelled red or mostly red, meaning average daily cases over the previous 14-day period were 50 or higher per 100,000 inhabitants coupled with a test positivity rate of over four percent.

The red rating is if the 14-day notification rate is 150 cases or higher per 100,000.

In addition to the 27 EU countries, the ECDC covers the UK, Norway, Iceland and Liechten-

A green rating means the 14-day notification rate is lower than 25 cases per 100,000 and the test positivity rate below four percent, and orange are those that fall between red and

Member states agreed not to impose travel restrictions on travellers from regions rated 'green", but none achieved that level nation-

For countries that are red and orange, members states are free to decide what measures, if any, they wish to impose but could for instance require travellers coming from those countries to undergo quarantine or a Covid-19 test.

Five countries - Austria, Germany, Sweden, Denmark and Iceland - did not receive a rating, with the agency citing a lack of informa-

\$60 dollar experimental vaccine available in Jiaxing

CHINA: A \$60 double-dose experimental coronavirus vaccine is being made available to some residents in an eastern Chinese city, health officials have said, the first details of a mass rollout for an as-yet unproven vaccine.

Officials in Jiaxing city said Thursday residents aged between 18 and 59 with "urgent needs" can seek consultations at clinics for a Sinovac Biotech vaccine that authorities have been giving to groups such as medical workers.

The statement from Jiaxing's centre for disease control and prevention did not specify what constituted "urgent needs".

Authorities did not say how

China has already given hundreds of thousands of essential workers at ports, hospitals and other high-risk areas across the country an experimental vaccine, according to officials.

Beijing has also made bold predictions on a broader rollout before year-end as it battles a storm of international criticism over its early han-

Chinese President Xi Jinping has also previously declared that Chinese vaccines would be made a "global public good".

China has signed up to a World Health Organization-led bid to ensure future COVID-19 vaccines are distributed to developing countries, the biggest economy yet to join the attempt to control the pandemic.

Beijing has not given details on how much money it would commit to the deal, which has a fundraising goal of \$2 billion and aims to provide 92 low and middle-income countries with a future vaccine.

Indian cinemas re-open after 7 months

INDIA: Cinemas in movie-mad India tentatively re-opened on Thursday but with worries about coronavirus and only old films showing, early punters were few and far between.

The famously cinema-hungry nation has been deprived of physical venues since March, when it entered a serious lockdown that continues today. The pandemic has clobbered

theatres worldwide but in India, home to the planet's most prolific movie industry, it has upended a culture that treats the stars of the silver screen almost like gods. After the recent loss of several

luminaries to coronavirus, cancer and even suicide - as well as a Bollywood drugs scandal -- the industry is desperate for some good news.

But it may have to wait, with some states still keeping theatres closed - including Maharashtra and its movie mad capital Mumbai -- and film studios offering no new releases.

At the Sharada Cinema in Bangalore on Thursday, there was only a small trickle of customers for the morning showing of action "Kaanadante Maayavadanu".

with as little as 75 rupees (\$1) buying three hours of drama, dancing and song in air-conditioned luxury.

But with temperature checks at the door, half the seats left empty for social distancing, and only a limited selection of food, the experience now is a far cry from what was previously on offer. Top Bollywood producer Aditya Chopra is also preparing to release "Bunty Aur Babli 2", a sequel to a 2005 hit, at the same time, according to media reports.

But with India's virus cases surging past seven million, the threat of infection remains strong, prompting authorities in Mumbai, the home of Bollywood, to put off reopening cinemas for the time being.

"Mumbai is the heart of the film industry - if theatres are closed there, half the battle is already lost," said analyst Nahta.

In such uncertain times, if the remaining cinemas are able to sell even half the tickets available - 25 percent of normal capacity - they can celebrate, he said.

"If they manage to fill 60 percent of the seats on offer, it will be superb news for the industry." - AFP

Trump defends COVID-19 response, Biden talks 'UNITY'



US: US President Donald Trump delivered a combative defense on Thursday of his COVID-19 response while election challenger Joe Biden -offering a glaring contrast in style in a rival town hall -- accused him of doing "nothing" to end the pandemic.

The dueling appearances, scheduled at the same time on rival television networks, showed Biden giving unflashy, empathetic, often in-depth answers to voters in the audience, while Trump delivered a fiery, sometimes agitated defense of his Presidency.

Trump, who trails in the polls ahead of the November 3 election, was espe-

economic damage. "We're rounding the corner," Trump insisted with his usual optimism, even as swaths of the United States sharply

By contrast, Biden's appearance on rival network ABC mirrored his steady and generally lowkey campaign, with promises of bipartisan healing in divided Washington and aiming steady fire on Trump's coronavirus record. "We're in a situation where we have 210,000 plus people dead and what's he doing? Nothing. He's still not wearing masks," Biden said of Trump at the event in Phil-

adelpĥia. "We've got to

change the nature of the way we deal with one another," Biden said. I'm elected President, the first thing -- and not a joke... I'm going to pick up the phone and call them and say, 'Let's get togeth-

Biden repeatedly came back to the theme of unity, saying he would be President to all Americans including those who voted against him. Originally, both candidates were meant to meet Thursday for what would have been their second of three Presidential debates.

With only 19 days until the election, Trump is now running out of time to overtake Biden. - AFP

Scientists throw lifeline to world's rarest primate

FRANCE: Hainan gib- are strictly arboreal," lead bons - the rarest primates on Earth - were already teetering on the edge of extinction in 2014 when the most powerful storm to lash China's coast in half a century ravaged their island oasis.

Decades of economic development, along with logging and deforestation, had reduced their habitat by more than half.

What primary forest remained was also fragmented, further hemming in the tailless apes, which travel exclusively above ground.

But the massive mudslides unleashed by super typhoon Rammasun made things worse, gouging 15-metre wide gullies into the mountainous forest and effectively cutting off their treetop highways.

"Canopy connectivity is critical for gibbons as they author Bosco Pui Lok Chan, head of the Kadoorie Farm and Botanic Garden in Hong Kong's New Terri-

tories, told AFP. "Forest fragmentation thus presents a major conservation challenge for gib-

It not only limits their ability to forage for food, it can interfere with the search for a mate and make them more vulnerable to predators.

bons."

After the typhoon, Chan and his colleagues noticed while monitoring the gibbons -- only a few dozen of which remain in the wilds of China's Hainan Island -that they had trouble crossing these new gaps in the

And when they did, "they took very risky routes involving a lot of long jumps and high falls among the few surviving trees," he light-bulb moment.

"We constructed a twopronged canopy rope bridge across the damaged arbore-

al highway," he said. The "bridge" consisted of two parallel ropes tied at

either end to trees. The conservationists also set up motion cameras to record any movement on or across the ropes.

The group of nine gibbons most affected by this particular gash in the forest didn't avail themselves of

the lifeline right away. Indeed, only 176 days later did the cameras capture the first image of a gibbon on the ropes.

After that first crossing, however, others quickly followed suit. Some strode across the mountaineeringgrade ropes like tight-rope walkers, while others moved underneath, swinging arm to arm. - AFP

US: Americans are voting early in record numbers with more than 17.8 million casting their ballots already ahead of a presidential election between Democrat Joe Biden and Republican Donald Trump taking place under the shadow of the COVID-19 coronavirus pandemic.










A person to prosper in life, in any field has to be influenced and guided by someone in life to reach the pinnacle, in that particular segment. Bryan Baptist one of the greatest ruggerites Sri Lanka has ever produced played a pivotal role in developing the game in the country as a player, coach and as an administrator.

Bryan was encouraged by a few school mates at Royal College, Colombo who said that "You are strong and have so much of energy,, why don't you play rugger" to him about six decades ago. He wanted to thank his Sebs 1st XI head coach Imal Boteju, assistant coach Samith Fernando "Actually they helped me in every way possible for me to be successful by scoring two back to back 1000 runs in the Inter school season" said Dunith.

Speaking further Dunith said "I also wanted to extend my gratitude and thanks to my personal coaches Neil Rajapaksha and Rashan Peiris In the just concluded Sri Lanka Cricket (SLC) Premier tournament, Dunith scored a brilliant knock of 63 playing down 180 odd deliveries against the star studded SSC side which include many Sri Lanka national players and another fine innings of 56 in the first innings and 49 runs in the second innings against Negombo CC.

He also had a very successful 2020/21 SLC, under 23, 50 over tournament this season as well. He led his side Badureliya to a shock victory by scoring an exceptional unbeaten knock of 88 against an unbeaten Army SC side. In their final group game he led his side to victory by scoring an elegant knock of 56 guiding his Badureliya team to win, thus getting into the all important semi final berth of the tournament by showing his superior leadership qualities. Sajith Fernando was born on September 27, 1972 started his cricketing career at St. Paul's College Kandy (now goes as Wariyapola Sri Sumangala College) where he was guided and made to play good cricket by former Sri Lanka cricketer late D.H.de Silva. Then in an under-17 game between St. Anthony's and St Paul's, Sajith made a superb century, and this opened the door for him at the Katugastota school. His father Ian Fernando was an Old Antonian. After crossing over to St. Anthony's College he polished his cricket under T.K. Hannan and Sunil Wickremanayake.

He played for the Antonians along with cricketers like Champika Siriwardena, Muttiah Muralitharan, Ameda Ellepola, Ajaz Shafeek,Umesh de Alwis, Asanka Ratnaweera, Dilshan Bandaranayake, Indika Beddegama, Lester Herathge, N. de Mel, Nishan Doranegama, Christopher Samaratunge and Jeremy Speldewinde. In 1991, when Muttiah Muralitharan won the Observer schoolboy cricket award, Sajith Fernando was chosen as best batsman in the competition, and in the following year (1992), Sajith not only won the Schoolboy cricketer of the year but also took the prizes for the best all-rounder, best Batsman (runner-up) behind Russell Arnold (St. Peter's College) and also became the runner-up for the Best Bowler, behind Punyakantha Abeygoonesekera (Nalanda College).


In that year, Sajith Fernando scored five centuries for his school and fully endorsed his batting status to win the best batsman award. In 1992, , Sajith Fernando did better scoring 1,000 runs for the season with four centuries and took 100 wickets and made himself eligible for the top award in school cricket sector.

This left-hand opening batsman scored over 10,000 first class runs and at one time was head coach of S. Thomas'College, Mount Lavinia and also of Ports Authority

In 1992 Sajith was a member of the Sri LankaUnder-19 Team led by Anandian Sachithra Alexander that toured England. The team included players in the calibre of Chaminda Vaas and Russel Arnold and Sajith was awarded the most outstanding player of the tour. The same year, he was a member of the Sri Lanka 'A' team which took part in the SAARC cricket tournament In 1993 he toured South Africa with the Sri Lanka Under-24 Team which was led by Sanath Jayasuriya and this was supposed to be the first ever official tour made by a Sri Lanka team. He was also the deputy skipper of the Under-24 Team against South Africa and later led the team in the final test

match and two ODI matches. In1995, he was a member of the Sri Lanka cricket team led by Marvan Atapattu that took part in the Hong Kong Sixes and the TNT Worldwide Cricket Sixes held in Singapore where they emerged champions in both tournaments. The same year he represented

the Central Province Team in the Inter-Provincial Cricket Tournament and was ad judged the most promising player of the province in this tournament. He went onto lead the Colts U/24 cricket team and guided them to become champions. Sajith performance saw him being offered a scholarship by the Board of Control for Cricket in Sri Lanka, where he represented the Beenleigh Logan CC in Brisbane. On his return he was given the responsibility of leading the Sri Lanka 'A' side against the South African counterparts. In 1998, he was adjudged the man of the series in the premier limited over tournament when Colts emerged champions. He was a member of the Champion Colts Cricket Team which emerged premier league champions in the year 2000 and 2002 which team he led. Sajith after a stint with Colts CC and for the Tamil Union in Sri Lanka, was successful in guiding his side to become the premier limited over champions of 2009/10 cricket season.

Minister approves three new shooting ranges for schoolchildren

Minister of Sports and Youth Affairs, Namal Rajapaksa has granted approval for the construction of three new shooting ranges in an attempt to popularise the sport among the schools in the country.

The Minister responded swiftly to the need when he met the high-ranking officials of the National Shooting Sports Federation (NSSF) at the Sports Ministry in Colombo.

As an initial step to support the plan, the Sports

Minister approved the construction of one airgun range per District in order to facilitate over 7,500 school shooters in the coun-

The ultimate target will be to have shooting ranges in all 25 Districts of Sri Lanka, which would be accessible not only to the students but also to the other shooting community in general and for the public for leisure shooting. The Sports Minister has also identified and approved three locations as shooting

ranges to be completed and the task was handed over to the President and Secretary of the NSSF to be accomplished by December 31.

Meanwhile, President of the NSSF, Shirantha Peiris said that this has been the first time, that a Sports Minister had given a firm decision to move ahead without any interruptions. "I am very happy that

these children can now have a location to train and shooting would improve their focus in studies as well as in their general discipline," NSSF President Peiris told the Daily News yesterday. This programme, coordinated with the Ministry of Education is also extended to train school teachers as coaches who will overlook the training of

'Perfect storm' forced Springboks out of Rugby Championship

JOHANNESBURG, FRIDAY: A Stormers, whose squad coronavirus-induced "perfect storm" forced world champions South Africa to pull out of the 2020 Rugby Championship in Australia, SA Rugby chief executive Jurie Roux said

He said factors had conof the Springboks from the October 31-December 7 tournament included:

Some local players would have flown to Australia having played just one competitive match instead of the five director of rugby Rassie Erasmus considered to be the bottom line.

- Uncertainty over the availability of many Europe-based South Africans as England and France battle with spikes in Covid-19 cases.

- The six Springboks based in Japan, including jet-heeled winger Makazole Mapimpi, have played no rugby recently because of the pandemic.

-- South African government regulations were unclear regarding whether home-based players could legally leave the country.

Harsh lockdown conditions left South African rugby players far behind tributed to the withdrawal those in New Zealand Australia, who resumed playing in mid year, when it came to game-time.

This raised fears that the rusty world champions could be on a hiding to nothing, not only against arch foes New Zealand but also resurgent Australia under new coach Dave Rennie.

"Players in England, Ireland and France are subject to differing local regulations and travel protocols and potentially imminent renewed lockdowns," said Roux in a statement.

"It was unclear when they would be able to become functioning members of the Springbok squad in Australia."

Erasmus, who coached South Africa to World Cup glory before returning to Springboks had "played no rugby at all". Roux added: "Public

safety concerns come first and there is no way we could take short cuts to get them out of their host countries and into a Springbok bubble.

"It seems impossible that the Springboks will not play a Test in 2020, but public health and safety have been the primary "All we can do now is

enjoy our domestic competitions and find ways to be ready for the arrival of the British and Irish Lions in 2021. Preparing the Spring-

boks for a three-Test series against the Lions next July and August without playing a Test since November 2019 is the huge challenge facing SA Rugby. The cash-strapped governing body will also suffer financially as they stood to earn a reported 300 million rand (\$18 million/15.5 million euros) by

competing in Australia. A Lions tour will be a money-spinner, but only if locals and British and Irish visitors are allowed to attend. - AFP

'statement' after Wallabies draw

AUCKLAND, FRIDAY: The "hurting" All Blacks will look to restore pride against Australia at their Eden Park fortress on Sunday after last week's 16-16 draw further dimmed their aura of invincibility in coach Ian Foster's first game in charge.

Foster criticised the three-time world champions' "relatively poor" game management for the drawn first Bledisloe Cup Test in Wellington, and warned they will not make the same mistake in round two on Sunday.

As Test rugby's resumption goes into its second week in New Zealand, where there is no community Covid-19 transmission, a crowd of 47,000 is expected to pack Auckland's Eden Park -- where the All Blacks are unbeaten in 43 games.

However, the Wallabies are riding high. After going into the first Test as underdogs, and ended up outmuscling the All Blacks for much of the game and saw a penalty bounce off the posts after the final hooter.

For Australia, who last won the annual Bledisloe Cup series in 2002, it was a

moral victory with coach Dave Rennie saying "it's something we'll draw on

Sunday afternoon". There is even confidence in the Wallaby camp that they can smash the curse of Eden Park, where it has been 34 years and 19 Tests since they last tasted victory.

But whenever Australia has started a Bledisloe series well in recent years they have generally been thrashed the following week, and Foster warned they can again expect a vast improvement from the All Blacks.

"It was a game where we didn't achieve the level that we wanted to, that's clear and obvious, and yet we walked away with a 16-all draw," said Foster. "So we're hurting and it's

the way it should be. We know we've got to respond."

No room for sentiment

While Foster rated the All Blacks scrum and lineout as effective, he said "how we used those as weapons was probably relatively poor" and also called for more aggression.

Among five changes, Foster included blockbusting wing Caleb Clarke and moved no-nonsense hooker Dane Cole into the front row, while Beauden Barrett returns from injury to take over the fullback role.

His 36-Test brother Scott Barrett, who has been sidelined for three months by a foot injury, will come off the bench in the second half, while experienced centre Anton Lienert-Brown starts in place of Rieko Ioane,

who fluffed a certain try last week when he failed to ground the ball properly. Foster said he accepted

criticism that the All Blacks lacked their usual edge in Wellington.

"Those comments come every time we have a performance that doesn't reach our expectations for starters, so there's not much point arguing with them," he said. "Is it time for a statement? Well, yes it is."
