Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatilake, Minister of Lands and Parliamentary Reforms, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Nine (09) allotments of land depicted and in Advance Tracing No. GA/GFG/2017/821 dated 18.09.2017, prepared by the Surveyor General situated in the Village called Dangedara in the Divisional Secretary's Division of Gall Four Gravets in Galle District of Southern Province and bounded as follows:

01. Lot 'A' – Appaladoowa – Extent: 0.0007 Hectare

North: Appaladoowa claimed by S. W. Senanayake and Moragoda Ela; East: Moragoda Ela and Appaladoowa cross Canal; South: Appaladoowa cross Canal, Lot B and Road; West: Appaladoowa claimed by S. W. Senanayake.

02. Lot 'B' – Extent: 0.0002 Hectare

North: Road, Appaladoowa claimed by S. W. Senanayake and Lot

A; East: Appaladoowa cross Canal; South: Appaladoowa cross Canal and Lot C; West: Mahadoowawatta of which the claimant could not be traced and Road.

03. Lot 'C' – Mahadoowawatta – Extent: 0.0015 Hectare

North: Mahadoowawatta of which the claimant could not be traced, road and lot B; East: Appaladoowa cross Canal; South: Appaladoowa cross Canal and Lot D; West: Mahadoowawatta claimed by D. D. R. Wickramasinghe and Mahadoowawatta of which the claimant could not be found.

04. Lot 'D' – Mahadoowawatta – Extent: 0.0021 Hectare

North: Land of which the claimant could not be traced and Lot C; East: Appaladoowa cross Canal; South: Appaladoowa cross Canal, Lot E and Road; West: Mahadoowawatta claimed by D. D. R. Wickramasinghe.

05. Lot 'E' – Extent: 0.0001 Hectare

North: Road, Mahadoowawatta claimed by D. D. R. Wickramasinghe and Lot D; East: Appaladoowa cross Canal; South: Appaladoowa cross Canal and Mahadoowawatta claimed by H. K. W. Perera; West: Road.



06. Lot 'F' – Appaladoowa – Extent: 0.0002 Hectare

North: Appaladoowa cross Canal and Appaladoowa claimed by E. H. Deepika; East: Appaladoowa claimed by E. H. Deepika; South: Appaladoowa claimed by E. H. Deepika, Appaladoowa claimed by A. C. Rajagopal and Lot G; West: Appaladoowa cross Canal.

07. Lot 'G' – Appaladoowa – Extent: 0.0013 Hectare

North: Appaladoowa cross Canal and Lot F; East: Appaladoowa claimed by E. H. Deepika and A. C. Rajagopal; South: Appaladoowa claimed by A. C. Rajagopal and M. P. Shashini and Lot H; West: Appaladoowa cross Canal.

08. Lot 'H' – Appaladoowa – Extent: 0.0011 Hectare

North: Appaladoowa cross Canal and Lot G; East: Lot G and Appaladoowa claimed by A. C. Rajagopal and M. P. Shashini; South: Appaladoowa claimed by M. P. Shashini, Road and Lot J; West: Lot J and Road.

09. Lot 'J' – Extent: 0.0186 Hectare

North: Appaladoowa cross Canal and Lot H; East: Lot H, Appaladoowa claimed by M. P. Shashini and Road; South: Road; West: Appaladoowa cross Canal.
