Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatilake, Minister of Lands and Parliamentary Reforms, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below are needed for a public purpose and will be acquired under the provisions of that Act.

Fifty four (54) allotments of land depicted in Advanced Tracing No. GA/GFG/2017/515 and dated 22.08.2017 prepared by the Surveyor General, situated in the Villages called Maligaspe, Deddugoda South in the Divisional Secretary's Division of Galle Four Gravets in Galle District in Southern Province and bounded as follows.
