FOREST CONSERVATION ORDINANCE

THE order under Section 3 of the Forest Conservation Ordinance (Chapter 451), as amended by Acts, No. 13 of 1966, No. 56 of 1979, No. 13 of 1982, No. 84 of 1988, No. 23 of 1995 and No. 65 of 2009.

The Order

By virtue of powers vested in me by Section 3 of the Forest Conservation Ordinance (Chapter 451) as amended by Acts, No. 13 of 1966, No. 56 of 1979, No. 13 of 1982, No. 84 of 1988, No. 23 of 1995 and No. 65 of 2009, I, Maithripala Sirisena, Minister of Mahaweli Development and Environment do by this order declare the Knuckles Reserved Forest adjoining to Lali Ambe, Kola Ela, Haewood, Halgolla, Puharambe forest of 13.0867 hectares bounded by the limit set forth in the Schedules No. 01, 02, 03, 04 and 05 hereto as Lali Ambe, Kola Ela, Hoewood, Halgolla, Puharambe Reserved Forest from 15 day of February 2018.

The state land of Lali Ambe Kele called or known as Lot Number 1, 2, 3, of P.P. 0.1412 complied by surveyor General of Udangomuwa village of Ukuwela Divisional Secretary's Division in Matale District, Central Province Containing in extent 0.6763 ha. and bounded as follows :
