FOREST CONSERVATION ORDINANCE

THE order under Section 3 of the Forest Conservation Ordinance (Chapter 451), as amended by Acts, No. 13 of 1966, No. 56 of 1979, No. 13 of 1982, No. 84 of 1988, No. 23 of 1995 and No. 65 of 2009.

The Order

By virtue of powers vested in me by Section 3 of the Forest Conservation Ordinance (Chapter 451) as amended by Acts, No. 13 of 1966, No. 56 of 1979, No. 13 of 1982, No. 84 of 1988, No. 23 of 1995 and No. 65 of 2009, I, Maithripala Sirisena, Minister of Mahaweli Development and Environment do by this order declare the Himbilyakada Forest (2nd Step) of 532.8034 hectares bounded by the limit set forth in the Schedules 01 and 02 hereto as Himbilyakada Reserved Forest (2nd Step) from 15 day of February 2018.

SCHEDULE 1

The state land area comprising of Badayaya, Uthuragala, Pimburangala and Himbilyakada that belongs to Himbilyakada forest (2nd step) called or known as Lot Number 2593, 2597 and 2600 of inset 190 of T. P. P. 13 complied by Surveyor General for Himbilyakada, Veheragala, Godaulpota, Iriyagasulpota villages of Wilgamuwa Divisional Secretary's Division in Matale District, Central Province containing in extent 235.2387 ha. and bounded as follows :

By North : Lot Number 2605, 2605 (Pradeshya Sabha road from Himbilyakada up to Weheragala), 2605, 2605 (Madugahawale Canal), 2605, 2605 (Madugahawale Canal) and 2605 of Topo P. P. 13 ;

By East : Lot Number 2605, 2594 (Madugahawale Canal) 2605, and 2595 (Bambaragaha Canal) of Topo P. P. 13 ;



By South : Lot Number 2595 (Bambaragaha Canal) 2605, 2605 (Pradeshiya Sabha road from Iriyagasulpota upto Weheragala) 2605 and 2601 (Iriyagasulpota Canal) of Topo P. P. 13. ;

By West : Lot Number 2605, 2599 (Pradeshiya Sabha road from Iriyagasulpota up to Weheragala), 2605 and 2598 (Pradeshiya Sabha road from Himbilyakada up to Weheragala) of Topo P. P. 13 (Lot Number 2596 and 2599, located within this forest are Pradeshiya Sabha road)

Extent : 235.2387 ha.

SCHEDULE 02

The state land area comprising of Uthuragala, Kirimetiyyaya and Himbilyakada that belongs to Himbilyakada forest (2nd step) called or known as Lot Number 2603 of inset 190 of T. P. P. 13 complied by Surveyor General for Himbilyakada, Weheragala, Godaulpota, Iriyagasulpota villages of Wilgamuwa Divisional Secretary's Division in Matale District, Central Province containing in extent 297.5647 ha. and bounded as follows.

By North : Lot Number 1986 (forest survey of Himbilyakada - 1st Step) 2605, 2602 (Aliyawala Canal) and Lot Number 2605 of Topo P. P. 13 ;

By East : Lot Number 1450 (Naminioya Forest) of F. T. P. 10 ;

By South : Lot Number 1019 of F. T. P. 10, Lot Number 2605, 2605 (Namini Oya), 2605, 2604 (Canal) and 1986 (Forest Survey of Himbilyakada - 1st step) of F. T. P. 10 ;

By West : Lot Number 1986 (Forest Survey of Himbilyakada - 1st step) of Topo P. P. 13.

Extent : 297.5647 ha.
