SCHEDULE (2)**PRESCRIBED TESTS AND STANDARDS FOR PAPAINE**

Papain shall be the dried latex of the unripe fruit of *Carica Papaya*, Linn (Fam Caricaceae)

It must—

- (a) not contain more than ten per centum of moisture,
- (b) not contain more than eleven and one-tenth per centum of ash calculated on its dry weight,
- (c) not contain any foreign substance, other than any extraneous matter due to unavoidable consequences of the process of collection, preparation and packing; and
- (d) possess a proteolytic activity not less than that of the Ceylon Reference Papain as determined by the following method of assay

Assay

Reagents —

- (1) Beef Powder Lean beef is cut into small pieces, dried in an oven at 105°C, and pulverised It shall be dried before use
- (2) Ceylon Reference Papain is that papain maintained by the Director of Commerce

- (3) 10% w/v aqueous solution of sodium chloride is prepared by dissolving 10% of sodium chloride of analytical reagent quality in distilled water, boiling and cooling before use
- (4) Water means distilled water, boiled and cooled before use

Method

Titrate 10g of papain under test in a mortar with about 20 ml of water until a perfectly uniform mixture is produced. Add a further 25 ml of water and mix very thoroughly. Transfer the mixture quantitatively to a litre standard flask, rinsing the mortar with successive small quantities of water sufficient to produce about 800 ml. Stopper the flask and shake thoroughly and make up to the mark with water. Allow it to stand for 15 minutes. Shake the contents again and allow it to settle down for one minute. Pipette 10 ml of this solution from about the centre of the flask and transfer to a suitable glass stoppered bottle marked No 1. To this bottle add 2g of beef powder, 38 ml of water, 2 ml of 10% w/v aqueous solution of sodium chloride and shake until thoroughly mixed.

To another bottle marked No 2 add 2g of beef powder, 0.1g of Ceylon Reference Papain, 48 ml of water, 2 ml of 10% w/v aqueous solution of sodium chloride and shake until thoroughly mixed.

Place the two bottles in an incubator maintained at 52°C for two hours agitating the contents of the bottles equally every ten minutes by inverting once. At the end of two hours remove the bottles from the incubator and cool them immediately to about 20°C. Filter the contents of each of the bottles separately through tared sintered glass crucibles of porosity 3 and transfer quantitatively all the undigested beef from the bottles to the crucibles with small quantities of water. Wash the residues with water until the filtrates are free from chlorides. (Note—The quantities of water used for transferring and washing the residues in each of the two bottles should approximately be equal.)

Dry the crucibles with residues at 105°C to constant weight, and calculate the weight of the residues.

The weight of the residue corresponding to Bottle No 1 containing the papain under test is not greater than that of the residue corresponding to Bottle No 2 containing the Ceylon Reference Papain.
