Allowances.—Unless otherwise stated, Rent Allowance, temporary Cost of Living Allowance and temporary Special Living Allowance are payable according to Government Regulations.

Conditions of Service.—Appointments will be subject to the Public Service Commission Rules, the Financial Regulations, the Regulations of the Manual of Procedure, Departmental Orders or Regulations, and any other orders or regulations issued from time to time by the Government.

Terms of Engagement.—(1) In the case of appointments to the non-pensionable establishment (excluding those on daily rates of pay), appointees will be required to contribute 5 per cent. of their salary to the Public Service Provident Fund, and they will be allowed to contribute, at their option, a further 5 per cent. The Government contribution, in either case, will be equal to 7½ per cent. of the salary paid in at the close of each financial year.

War Service Concession.—Provided they are qualified in all other respects, ex-Servicemen of

Her Majesty's Fighting Forces and full-time members of the Auxiliary Fire, Air Raid Precautions and Civil Defence Services (excluding those who had left these Services of their own accord), will be allowed to deduct periods of such service (commencing from September 3, 1939, at the earliest and up to December 31, 1949, at the latest), from their ages for purposes of eligibility alone, provided that they joined the Forces before August 15, 1945, and that such service was satisfactory and continuous.

The educational and physical qualifications stated above are the minimum required. Preference will, however, be given to those of higher educational and better physical standards.
