Allowances.—Unless otherwise stated, Rent Allowance, temporary Cost of Living Allowance and temporary Special Living Allowance are payable according to Government Regulations.

Conditions of Service.—Appointments will be subject to the Public Service Commission Rules, the Financial Regulations, the Regulations of the Manual of Procedure, Departmental Orders or Regulations, and any other orders or regulations issued from time to time by the Government.

Terms of Engagement.—(i) In the case of appointments to the non-pensionable establish-ment (excluding those on daily rates of pay), appointees will be required to contribute 5 per cent. of their salary to the Public Service Provident Fund, and they will be allowed to contribute, at their option, a further 5 per cent. The Government contribution, in either case, will be equal to $7\frac{1}{2}$ per cent. of the salary paid in at the close of each financial year.

(ii) Appointees may be required to furnish security in terms of the Public Officers' (Security) Ordinance, if so required by the Head of their Department.

Undergraduate Scholarships in Economics at United Kingdom Universities

APPLICATIONS will be received by me till April 9, 1954, for the selection of 4 (four) students for Undergraduate Scholarships for the study of Economics at United Kingdom Universities from the academic year commencing in United Kingdom Universities this year

The scholarships will be provided by the United Kingdom Government under the Technical Cooperation Scheme of the Colombo Plan

Terms of Scholarship.-The United Kingdom Government will bear full expenses of the scholarships which will include :---

- (a) Costs of scholars subsistence and lodging in the U. K.
- (b) Costs of passage to the United Kingdom and back at the termination of the scholarship.
- (c) Costs of medical expenses of scholars while in the United Kingdom.
- (d) Cost of any travel in the United Kingdom relating to scholarship
- (e) Costs of books and other equipment which the United Kingdom Government considers necessary for the scholar. (f) Each scholar will also be given a reasonable
- outfit allowance which will however not exceed £40.
