#### BENGAL.--No. 230.

Australia, North Coast-Torres Strait.-Bank in Western Approach.

The British Admiralty has given notice (No. 606 of 1895) that information has been received that about 5 P.M. on August 11, 1895, the French despatch-transport Durance obtained a sounding of 11 fathoms in approximately lat.  $10^{\circ} 52\frac{3}{4}$  S., long.  $138^{\circ} 48'$  E., the water being discoloured for some miles both northward and southward of that position.

The vessel then steered W.  $\frac{1}{4}$  N. for a distance of five miles, obtaining soundings of 14 to 18 fathoms, coral, mud, and hard bottom; then passing into a greater depth, and out of the discoloured water.

#### BENGAL.--- No. 231.

South Pacific Ocean—Fiji Islands.—Bank found in search for Zephyr Shoal eastward of Fiji.

The British Admiralty has given notice (No. 608 of 1895) that in a recent search for Zephyr shoal a bank was found in approximately lat. 15° 53' S., long. 176° 464' W. The Penguin anchored on this bank in a depth of 21 fathoms, and obtained a least depth of 11 fathoms half a mile eastward of the above position, the extent of the bank being three-quarters of a mile E. by S.  $\frac{1}{4}$  S. and W. by N.  $\frac{1}{4}$  N. It is possible that less water may exist on this bank.

In the course of this search the Zephyr's position (lat.  $16^{\circ}$  0' S., long.  $177^{\circ}$  6' W. as adopted) was passed and sounded over without shoal water being found. A further search will, however, be made, and in the meantime Zephyr shoal is retained on the Admiralty Chart. Variation, 9° easterly in 1895.

#### GOVERNMENT OF JAPAN.

Himesaki Lighthouse, Sado Island, and Ogishima Lighthouse, Inland Sea.

#### Himesaki Lighthouse.

Notice is hereby given that on and after December 10, 1895, a 5th order fixed white light will be exhibited from a lighthouse erected at the southern head of the entrance

a lighthouse erected at the southern head of the entrance to Yebisu bay, Sado Island, west coast of Japan. The light will illuminate an arc of  $230^{\circ}$  30' between the bearings of N. 79° 30' E. and N. 50° W., of which between N. 58° 30' W. and N. 50° W., the light will not be seen for 1 or 14 mile from the lighthouse, being obscured by the point Torikakehana, south of the lighthouse. The bearings are true, and as observed from seaward.

The elevation of the light above the sea will be 136 ft. and in clear weather it will be seen from a distance of 10nautical miles.

The lighthouse is built of iron, hexagonal in shape, and is painted white. It is 40 ft. high from the base to the centre of the lantern.

The position of the lighthouse, according to the Japanese Admiralty Chart No. 248, is :---

Also that on and after the same date a 6th order at the northern extremity of Ogishima, Inland Sea. The arc of illumination of the light will be 229° 10' between the bearings of N. 52° 25' E. and N. 78° 25' W.

The light will show a green flash between the bearings

of N. 52° 25' E. and N. 72° 32' E., covering Atsusa rock and Nakase, and a red flash between N. 89° 32' E. and S. 87° 45' E. covering Ozonose. It will show for the rest a white flash. The bearings are true, and as observed from seaward.

The intervals between the flashes will be 15 seconds.

The elevation of the light above the sea will be 48 ft., and in clear weather it will be seen from a distance of

12 nautical miles. The lighthouse is built of granite, circular in shape, and

41 ft. high from the base to the centre of the lantern. The position of the lighthouse, according to the Japanese Admiralty Chart No. 50, is :--

Japan-Honshu, N.-W: Coast-Off Henashi Zaki-Existence of Sunken Rocks near Kiuroku Jima (Bittern Rocks).

Lieutenant T.Suzuki, I.N., reports that during Rikuoku survey, 1895, be discovered two rocks with depths of 3 and 2½ fathoms on them at low water, lying respectively W.  $\frac{1}{2}$  N., distant  $1\frac{1}{10}$  mile and W. by N.  $\frac{1}{2}$  N., distant nearly 7 cables, from the largest rock of Kiuroku jima (consisting of three rocks).

Korea-South Coast-Shoan-Gunto (Crichton Group)-Existence of a Sunken Reef Northward of Shoan-to.

Information has been received from Commander S. Tomioka of H.I.M.S. Tatsuta that when passing north-Tomioka of H.I.M.S. Tatsuta that when passing nortn-ward of Shoan-to, Korea South Coast, October 18, 1895, she saw a rock awash at low water, lying at the inter-section of the line joining Roberts island centre and Taro-to (Montravel I.) summit with that joining the north extremes of Chiku-to (Stanley I.), and Seizan-to (Montressor I.), but time did not permit its close examination. This rock is now named the Tatsuta.

#### St. Vincent Gulf-Port Adelaide River.

### MEMORANDUM OF ASSOCIATION OF THE VOGAN TEA COMPANY OF CEYLON, LIMITED.

- 1. THE name of the Company is "THE VOGAN TEA COMPANY OF CEYLON, LIMITED."
- 2. The registered office of the Company is to be established in Colombo, Ceylon.
- 3. The objects for which the Company is established are-
  - (1) To purchase or otherwise acquire the Vogan and Iddagodde estates in Kalutara, and the Stamford Hills, and Barkindale estates in Dikoya, or any one or more of them, or any part or parts thereof.
  - (2) To purchase, lease, take in exchange, hier or otherwise acquire any other land or lands, or any share or shares thereof, and any buildings, machinery, implements, tools, live and dead stock, stores, effects, and other property, real or personal, movable or immovable, of any kind, and any rights, easements, patents, licenses, or privileges in Ceylon or elsewhere (including the benefit of any trademark or trade secret which may be thought necessary or convenient for the purpose of the Company's business), and to erect, construct, maintain, or alter any buildings, machinery, plant, roads, ways, or other works, or methods of communication.
  - (3) To engage, employ, maintain, provide for, and dismiss superintendents, managers, clerks, coolies, and other labourers and servants, and to remunerate any such at such rate as shall be thought fit, and to grant pensions or gratuities to any such, or the widow or children of any such.
  - (4) To clear, open, plant, cultivate, and improve the said estates or any portions thereof, and any other land or lands that may be purchased, leased, or otherwise acquired by the Company in Ceylon or elsewhere, or portions thereof as a tea estate or tea estates, or with any other products, trees, plants or crops that may be approved by the Company.

- (8) To establish and maintain in the United Kingdom, in Ceylon, or elsewhere, stores, shops, places for the sale of tea, coffee, cocoa, and other articles of food, drink, or refreshment, wholesale or retail.
- (9) To establish in any part or parts of the world agencies for carrying on or developing the business of the Company or any branch thereof.
- (10) To let, lease, exchange, or mortgage the Company's lands, buildings, or other property or any part or parts thereof, whether in consideration of rents, money, or securities for money, shares, debentures, or securities in any other Company, or for any other consideration, and otherwise to trade in, dispose of, or deal with the same or any part thereof.
- (11) To borrow or receive on loan money for the purpose of the Company upon the security of cash credit bonds or of hypothecations or mortgages of the Company's property, or any part or parts thereof, or otherwise, as shall be thought most expedient, and in particular by the issue of debentures, debenture stock or bonds to bearer, or otherwise, either charged upon all or any part of the Company's present or future property (including uncalled capital), or not so charged, as shall be thought best.

#### ARTICLES OF ASSOCIATION OF THE VOGAN TEA COMPANY OF CEYLON, LIMITED.

THE regulations contained in the Table C in the Schedule annexed to "The Joint Stock Companies' Ordinance, 1861," shall not apply to this Company, which shall be governed by the regulations contained in these Articles, but subject to repeal, addition, or alteration by special resolution. The Company may, by special resolution, alter and make provisions instead of, or in addition to, any of the

regulations of the Company, whether contained and comprised in these Articles or not.

#### INTERPRETATION CLAUSE.

In the interpretation of these presents the following words and expressions shall have the following meanings, unless such meanings be inconsistent with, or repugnant to, the subject or context :-- The word "Company" means "The Vogan Tea Company of Ceylon, Limited," incorporated or established
by or under the Memorandum of Association to which these Articles are attached.
 "The Ordinance" means and includes "The Joint Stock Companies' Ordinance, 1861," and every other
Ordinance from time to time in force concerning Joint Stock Companies which may apply to the Company.
 "These presents" means and includes the Memorandum of Association and the Articles of Association of the
Company from time to time in force.
 "Capital" means the capital for the time being raised or authorized to be raised for the purposes of the
Company.

Company. "Shares" means the shares from time to time into which the capital of the Company may be divided. "Shareholder" means a Shareholder of the Company.

"Presence or present" at a meeting means presence or present personally or by proxy. "Directors" means the Directors for the time being of the Company or (as the case may be) the Directors

assembled at a Board. "Board" means a meeting of the Directors or (as the context may require) the Directors assembled at a Board meeting, acting through at least a quorum of their body in the exercise of authority duly given to them. "Persons" means partnerships, associations, corporations, companies, unincorporated or corporated by Ordi-nance and registration, as well as individuals.

"Office" means the registered office for the time being of the Company. "Seal" means the common seal for the time being of the Company.

"Month" means the common sear for the time being of the formation of the work of the time well as writing. "Writing" means printed matter or print as well as writing. Words importing the singular number only include the plural, and vice versa.

Words importing the masculine gender only include the feminine, and vice versa.

#### BUSINESS.

2. The Company may proceed to carry out the objects for which it is established, and to employ and apply its a soon after the registration of the Company as the Directors in their discretion shall think fit; and, if the whole of the shares shall not have been subscribed, applied for, or allotted, as soon as, in the judgment of the Directors, a sufficient number of shares shall have been subscribed or applied for.

#### CAPITAL.

4. The original capital of the Company is one million rupees (Rs. 1,000,000) divided into ten thousand

The Directors may, with the sanction of a special resolution of the Company in General Meeting, increase the capital of the Company by the creation of new shares, of such amounts per share and in the aggregate as such resolution shall direct; and they shall have power to add to such new shares such an amount of premium as may be considered expedient.

6. The new shares shall be issued upon such terms and conditions, and with such rights and privileges annexed thereto, as the General Meeting resolving on the creation thereof, or any other General Meeting of the Company, shall direct, and if no direction be given as the Directors shall determine, and in particular such shares may be issued with a preferential or qualified right to the dividends, and in the distribution of assets of the Company, and with a

special or without any right of voting. 26. Subject to the restriction of these Articles, any Shareholder may transfer all or any of his shares by instrument in writing.

27. No transfer of shares shall be made to an infant or person of unsound mind.
28. The Company shall keep a book or books, to be called "The Register of Transfers," in which shall be entered the particulars of every transfer or transmission of any share.
29. The Board may, at their own absolute and uncontrolled discretion decline to register any transfer of shares by a Shareholder who is indebted to the Company, or upon whose shares the Company have a lien or otherwise, or in case of shares not fully paid up, to any person not approved by them; and in no case shall a Shareholder or proposed transfere be entitled to require the Directors to state the reason of their refusal to register, but their declinature shall be absolute. shall be absolute.

30. Every instrument of transfer must be left at the office of the Company to be registered, accompanied by such evidence as the Directors may reasonably require to prove the title of the transferror, and a fee of two rupees and fifty cents, or such other sum as the Directors shall from time to time determine, must be paid to the Company for the registration of every such transfer, upon payment whereof the Directors, subject to the powers vested in them by Articles 29 and 31, shall register the transferee as a Shareholder and retain the instrument of transfer. 31. The Directors may, by such means as they shall deem expedient, authorize the registration of transferees

as Shareholders without the necessity of any meeting of the Directors for that purpose.
32. In no case shall the Directors be bound to inquire into the validity, legal effect, or genuineness of any instrument of transfer produced by a person claiming a transfer of any share in accordance with these Articles; and whether they abstain from so inquiring, or do so inquire and are misled, the transferror shall have no claim whatsoever upon the Company in respect of the share, except for the dividends previously declared in respect thereof, but only if at all, upon the transfere. if at all, upon the transferee.

The register of transfers may be closed during the fourteen days immediately preceding each Ordinary 33. General Meeting; and when a dividend is declared for the three next days ensuing the meeting; also at such other times (if any) and for such periods as the Directors may from time to time determine, provided always that it shall not be closed for more than thirty days in any year.

#### TRANSMISSION OF SHARES.

34. The executors, or administrators, or the heirs of a deceased Shareholder shall be the only persons recognized by the Company as having any title to the shares of such Shareholder.

35. Any guardian of any infant Shareholder, or any committee of a lunatic Shareholder, or any person becoming entitled to shares in consequence of the death, bankruptcy, or liquidation of any Shareholder, or the marriage of any female Shareholder, or in any other way than by transfer, shall, upon securing such evidence that he sustains the character in respect of which he proposes to act under this clause, or of his title, as the Directors think sufficient, be forthwith entitled, subject to the provisions herein contained, to be registered as a Shareholder in respect of such shares, or may, subject to the regulations as to transfers hereinbefore contained, transfer the same to some other person.

36. If any person who shall become entitled to be registered in respect of any share under clause 35 shall not, from any cause whatever, within twelve calendar months after the event on the happening of which his title shall accrue, be registered in respect of such share, or if, in the case of the death of any Shareholder no person shall, within twelve calendar months after such death, be registered as a Shareholder in respect of the shares of such deceased Shareholder, the Company may sell such shares, either by public auction or private contract, and give a receipt for the purchase money, and the purchaser shall be entitled to be registered in respect of such share, and shall not be bound to inquire whether the events have happened which entitled the Company to sell the same, and the net proceeds of such sale, after deducting all expenses and all moneys in respect of which the Company is entitled to a lien on the shares so sold, shall be paid to the person entitled thereto.

#### SURRENDER AND FORFEITURE OF SHARES.

37. The Directors may accept, in the name and for the benefit of the Company, and upon such terms and conditions as may be agreed, a surrender of the shares of Shareholders who may be desirous of retiring from the Company.

38. If any Shareholder fails to pay any call or instalment on or before the day appointed for the payment of the same, the Directors may at any time thereafter during such time as the call or instalment remains unpaid, serve a notice on such Shareholder, requiring him to pay the same, together with any interest that may have accrued, and all expenses that may have been incurred by the Company, by reason of such non-payment.

The notice shall name a day (not being less than one month from the date of the notice) on, and a place or places at, which such call or instalment and such interest and expenses as aforesaid are to be paid. The notice shall also state that, in the event of non-payment at or before the time and at the place appointed, the shares in respect of which the call was made or instalment is payable will be liable to be forfeited.

If the requisition of such notice as aforesaid be not complied with, every or any share or shares in respect of which such notice has been given may at any time thereafter before payment of calls or instalment with interest, and expenses due in respect thereof, be declared forfeited by a resolution of the Board to that effect.

39. Any Shareholder whose shares have been so declared forfeited shall, notwithstanding, be liable to pay, and shall forthwith pay to the Company all calls, instalments, interest, and expenses owing upon or in respect of such shares at the time of the forfeiture, together with interest thereon from the time of forfeiture until payment, at nine per cent. per annum, and the Directors may enforce the payment thereof if they think fit. 40. Every share surrendered or so declared forfeited shall be deemed to be the property of the Company, and

46. A certificate in writing under the hands of two of the Directors and of the Secretary, that the power of sale given by clause 44 has arisen, and is exercisable by the Company under these presents, shall be conclusive evidence of the facts therein stated.

47. Upon any such sale two of the Directors may execute a transfer of such share to the purchaser thereof, and such transfer, with the certificate last aforesaid, shall confer on the purchaser a complete title to such shares.

#### BORROWING POWERS.

48. Any such securities may be issued either at par or at a premium or discount, and may from time to time be cancelled, discharged, varied, or exchanged as the Directors may think fit, and may contain special privileges as to redemption, surrender, drawings, allotment of shares, or otherwise. 52. Every debenture or other instrument issued by the Company for securing the payment of money may be so framed that the moneys thereby secured shall be assignable free from any equities between the Company and the person to whom the same may be issued. GENERAL MEETINGS.

#### GENERAL MEETINGS.

53. The first General Meeting shall be held at such time, not being more than twelve months after the incorporation of the Company, and at such place as the Directors may determine.

54. Subsequent General Meetings shall be held once in every year at such time and place as may be prescribed by the Company in General Meeting, and if no time or place is so prescribed, then at such place and at such time as soon after the first day in each year as may be determined by the Directors. 55. The General Meetings mentioned in the last preceding clause shall be called Ordinary General Meetings;

all other meetings of the Company shall be called Extraordinary General Meetings. 56. The Directors may, whenever they think fit, call an Extraordinary General Meeting of the Company, and

the Directors shall do so upon a requisition made in writing by not less than one-eighth of the number of Shareholders. of the Company for the time being, or by any Shareholder or Shareholders holding in the aggregate one-eighth part of the shares of the Company for the time being subscribed for.

 57. Any requisition so made shall express the object of the meeting proposed to be called, shall be addressed to the Directors, and shall be sent to the registered office of the Company.
 Upon the receipt of such requisition the Directors shall forthwith proceed to convene an Extraordinary General Meeting, to be held at such time and place as they shall determine. If they do not proceed to convene the same within seven days from the delivery of the requisition, the requisitionists may themselves convene an Extraordinary General Meeting, to be held at such place and at such time as the Shareholders convening the meeting may themselves for selves fix.

58. Any Shareholder may, on giving not less than ten day's previous notice of any resolution, submit the same to a meeting.

59. Such notice shall be given by leaving a copy of the resolution at the registered office of the Company. 60. Seven days' notice at least of every General Meeting, Ordinary or Extraordinary, and by whomsoever convened, specifying the place, date, hour of meeting, and the object and business of the meeting, shall be given by advertisement in the Ceylon Government Gazette, or in such other manner (if any) as may be prescribed by the

Company in General Meeting. 61. Every Ordinary General Meeting shall be competent, without special notice having been given of the purposes for which it is convened, or of the business to be transacted thereat, to receive and discuss any report and any accounts presented thereto by the Directors, and to pass resolutions in approval or disapproval thereof, and to declare dividends, and to elect Directors and Auditors in the place of those retiring by rotation, and to fix the remuneration of the Auditors; and shall also be competent to enter upon, discuss, and transact any business whatsoever of which special mention shall have been given in the notice or notices upon which the meeting was convened. 62. With the exceptions mentioned in the foregoing Articles as to the business which may be transacted at Ordinary General Meetings without notice, no General Meeting, Ordinary or Extraordinary, shall be competent to

enter upon, discuss, or transact any business which has not been specially mentioned in the notice or notices upon which it was convened.

63. No business shall be transacted at any General Meeting except the declaration of a dividend recommended by a report of the Directors or election of a Chairman, unless there shall be present in person at the commencement of the business three or more Shareholders entitled to vote.

64. If at the expiration of half an hour from the time appointed for the meeting the required number of Shareholders shall not be present at the meeting, the meeting, if convened by or upon the requisition of Shareholders,

Shareholders shall not be present at the meeting, the meeting, if convened by or upon the requisition of Shareholders, shall be dissolved, but in any other case it shall stand adjourned to the same day in the next week at the same time and place; and if at such adjourned meeting a quorum is not present, those Shareholders who are present shall be a quorum, and may transact the business for which the meeting was called.

The Chairman (if any) of the Directors shall be entitled to take the chair at every General Meeting, whether Ordinary or Extraordinary, or if there be no Chairman, or if at any meeting he shall not be present at the time appointed for holding such meeting, or if he shall refuse to take the chair, the Shareholders shall choose another Director as Chairman; and if no Directors be present, or if all the Directors present decline to take the chair, then the Shareholders present shall choose one of their number to be a Chairman.
66. No business shall be discussed at any General Meeting except the election of a Chairman whilst the chair is vacant.

67. The Chairman may, with the consent of the meeting, adjourn any meeting from time to time and from place to place, but no business shall be transacted at any adjourned meeting other than the business left unfinished at

Minutes of the proceedings of every General Meeting, whether Ordinary or Extraordinary, shall be entered in a book to be kept for that purpose, and shall when so entered be signed as soon as practicable by the Chairman of the succeeding meeting, and the same when so entered and signed shall be interested at any adjournee of all such proceedings and of the proper cleation of the Orbit. evidence of all such proceedings, and of the proper election of the Chairman.

#### VOTING AT MEETINGS.

69. At any meeting every resolution shall be decided by the votes of the Shareholders present in person or by proxy, and in case there shall be an equality of votes, the Chairman at such meeting shall be entitled to give a casting vote in addition to the vote to which he may be entitled as a Shareholder; and unless a poll be immediately demanded by some member present and entitled to vote, a declaration by the Chairman that a resolution has been carried, and an entry to that effect in the Minute Book of the Company, shall be sufficient evidence of the fact without proof of the number or proportion of votes recorded in favour of or against such resolution.

70. If at any meeting a poll be demanded by some Shareholder present at the meeting and entitled to vote, the meeting shall, if necessary, be adjourned, and the poll shall be taken at such time and place and in such manner as the Chairman shall direct, and in such case every Shareholder shall have the number of votes to which he may be entitled as hereinafter provided; and in case at any such poll there shall be an equality of votes, the Chairman of the meeting at which such poll shall have been demanded shall be entitled to a casting vote in addition to any votes to which he may be entitled as a Shareholder and proxy, and the result of such poll shall be deemed to be the resolution of the Company in such meeting. 71. The demand of a poll shall not prevent the continuance of a meeting for the transaction of business other

72. No poll shall be demanded on the election of a Chairman of the meeting or on any question of adjournment.
73. On a show of hands every member shall have one vote only. In case of a poll every Shareholder shall have one vote for every share held by him up to ten, and an additional vote for every ten shares beyond the first ten up to one hundred, and an additional vote for every fifty shares held by him beyond the first hundred.
74. The parent or guardian of an infant Shareholder, the committee or other legal guardian of any lunatic Shareholder, the husband of any female Shareholder not entitled to her shares as separate estate, and the executor or administrator of any deceased Shareholder. or any one of such persons as aforesaid. if more than one, shall not be

80. The instrument appointing a proxy shall be deposited at the registered office of the Company not less than twenty-four hours before the time appointed for holding the meeting at which the person named in such instrument proposes to vote.

No objection shall be made to the validity of any vote, whether given personally or by proxy, except at the meeting or poll at which such vote shall be tendered, and every vote (whether given personally or by proxy) to which no objection shall be made at such meeting or poll shall be deemed valid for all purposes of such meeting or poll whatsoever.

No Shareholder shall be prevented from voting by reason of his being personally interested in the result 82. of the voting.

#### DIRECTORS.

83. The number of Directors shall never be less than two nor more than five, but this clause shall be construed as being directory only, and the continuing Directors may act notwithstanding any number of vacancies. The qualification of a Director shall be his holding in his own right at least twenty-five shares in the Company

upon which all calls for the time being have been paid, and this qualification shall apply as well to the first Directors as to all future Directors.

As a remuneration for their services, the Directors shall be entitled to appropriate a sum not exceeding three thousand rupees annually, to be divided between them in such manner as they may determine, but the Company in General Meeting may at any time alter the amount of such remuneration for the future, and such remuneration shall not be considered as including any remuneration granted for special or extra services hereinafter referred to, nor any

extra remuneration to the Managing Directors of the Company. 84. The first Directors shall be Henry Bois, Villiers Alexander Julius, Walter Bridgeman Kingsbury, Frank Liesching, and George Ernest Woodman, who shall hold office till the first Ordinary General Meeting of the Company, when they shall all retire, but shall be eligible for re-election.

85. One or more of the Directors may be appointed by the Directors to act as Managing Director or Managing Directors and (or) visiting agent or agents of the Company, for such time and on such terms as the Directors may determine or may fix by agreement with the person or persons appointed to the office, and they may, from time to time, revoke such appointment and appoint another or other Managing Director or Managing Directors, and (or) visiting agent or agents.

The Directors may confer on the Managing Director or Managing Directors all or any duties and powers that might be conferred on any Manager of the Company.

If any Director shall be called upon to perform any extra services, the Directors may arrange with such Director for such special remuneration for such services, either by way of salary, commission, or the payment of a lump sum of money as they shall think fit.

#### ROTATION OF DIRECTORS.

86. At the first Ordinary General Meeting of the Company to be held in the year 1896 all the Directors shall retire from office, and at the first Ordinary General Meeting in every subsequent year one of the Directors for the time being shall retire from office as provided in clause 87.
87. The Directors to retire from office at the second and third Ordinary General Meeting shall, unless the Directors otherwise arrange among themselves, be determined by ballot; in every subsequent year the Directors to retire shall be those who have been longest in office.

88. In case any question shall arise as to which of the Directors who have been the same time in office shall retire, the same shall be decided by the Directors by ballot.

89. Retiring Directors shall be eligible for re-election. 90. The Ordinary General Meeting at which Directors retire or ought to retire by rotation shall appoint successors to them, and in default thereof such successors may be appointed at a subsequent Ordinary General Meeting.

91. Any casual vacancy occurring in the number of Directors or Provisional Directors arising from death, resignation, or otherwise, may be filled up by the Directors, but any person appointed to fill such vacancy shall retain his office so long only as the vacating Director would have retained the same if no vacancy had occurred.

92. The Directors, subject to the approval of a General Meeting, may from time to time at any time sub-sequent to the second Ordinary General Meeting increase or reduce the number of Directors, and may also, subject to the like approval, determine in what rotation such increased or reduced number is to go out of office.

93. If at any meeting at which an election of a Director ought to take place the place of the retiring Director is not filled up, the retiring Director may continue in office until the first Ordinary General Meeting in the next year, and so on from meeting to meeting until his place is filled up, unless it shall be determined at such meeting to reduce the number of Directors.

94. A Director may at any time give notice in writing of his intention to resign by delivering such notice to the Secretary, or by leaving the same at the registered office of the Company, or by tendering his written resignation at a meeting of the Directors, and on the acceptance of his resignation by the Directors, but not before his office shall become vacant.

95. The Company may, by a special resolution, remove any Director before the expiration of his period of office, and may, by an ordinary resolution, appoint another person in his stead. The Director so appointed shall hold office only during such time as the Director in whose place he is appointed would have held the same if he had not been removed.

96. Every Director or officer of the Company, and his heirs, executors, and administrators shall be indemnified by the Company from all losses and expenses incurred by him in or about the discharge of his duties, except such as happen from his respective wilful acts or defaults : and no Director or officer shall, nor shall the heirs, executors, or administrators of any Director or officer, be liable for the acts or defaults of any other Director or officer, or for any administrators of any Director or officer, be liable for the acts or defaults of any other Director or officer, or for any loss or expense happening to the Company by the insufficiency or deficiency of title to any property acquired for or on behalf of the Company, or for the insufficiency or deficiency of any security in or upon which any of the moneys of the Company shall be invested, or for any loss or damage arising from the bankruptcy, insolvency, or tortuous act of any person with whom any moneys, securities, or effects shall be deposited, or for any other loss, damage, or misfortune whatsoever which shall happen in the execution of the duties of his office or in relation thereto, unless the same happen through his own wilful act or default. 97. No contribution shall be required from any present or past Director or Manager exceeding the amount, if any, unpaid on the shares in respect of which he is liable as a present or past Shareholder.

#### DISQUALIFICATION OF DIRECTORS.

The Office of a Director shall be vacated-**98**.

- (a) If he accepts or holds any office or place of profit other than Managing Director or Secretary under the Company.
- (b) If he becomes bankrupt or insolvent, or suspends payment, or files a petition for the liquidation of his affairs, or compounds with his creditors. If by reason of mental or bodily infirmity he becomes incapable of acting.
- If he ceases to hold the required number of shares to qualify him for the office.

(e) If he is concerned or participates in the profits of any contract with, or work done for, the Company. Provided that no Director shall vacate his office by reason of his being a member of any corporation, company or firm which has entered into any contract with or done any work for the company of which he is a Director, or by his being agent, or secretary, or solicitor, or by his being a member of a firm who are agents, or secretaries, or solicitors of the company; nevertheless he shall not vote in respect of any contract work or business in which he may be personally interested.

#### POWERS OF DIRECTORS.

The Directors shall have power to carry into effect the purchase of the Vogan, Iddagoda, Stamford Hill,

99. The Directors shall have power to make, and may make such rules or regulations for the management of the business and property of the Company as they may from time to time think proper, and shall carry on the business of the Company in such manner as they may think most expedient; and, in addition to the powers and authorities by any Ordinance or by these presents expressly conferred on them, they may exercise all such powers, give all such consents, make all such arrangements, appoint all such agents, managers, secretaries, treasurers, accountants, and other officers, superintendents, assistants, clerks, artizans, labourers, and other servants, for such period or periods, and with such remuneration, and at such salaries, and upon such terms and conditions as they may consider advisable, and may pay the expenses occasioned thereby out of the funds of the Company, and may from time to time remove or suspend all or any of the managers, agents, treasurers, accountants, officers, clerks, or servants of the Company, for such reasons as they may think proper and advisable, and without assigning any cause for so doing.

102. The Directors shall exercise in the name and on behalf of the Company all such powers of the Company, as are not expressly required to be exercised by the Company in General Meeting, and shall generally do all such acts and things as are or shall be by any Ordinance and by these presents directed and authorized to be exercised, given, made, or done by the Company, and are not by any Ordinance or by these presents required to be exercised or done by the Company in General Meeting, subject, nevertheless, to the provisions of any such Ordinance and of these presents, and to such regulations and provisions (if any) as may from time to time be prescribed by the Company in General Meeting, but no regulations made by the Company in General Meeting shall invalidate any prior act of the Board which would have been valid if such regulation had not been made.

It shall be lawful for the Directors, if authorized so to do by the Shareholders in General Meeting, to arrange terms for the amalgamation of the Company with any other company or companies, or individual or indi-viduals, or for the sale or disposal of the business, estates, and effects of the Company or any part or parts, share or shares thereof, respectively, to any company or companies, or person or persons, upon such terms and in such manner as the Directors shall think fit; and the Directors shall have power to do all such things as may be necessary for carrying such amalgamation, sale, or other disposition into effect so far as a resolution or special resolution of the Company is not by law necessary for such purpose, and in case any terms so arranged by the Directors include or make necessary the dissolution of the Company, the Company shall be dissolved to that end.

107. In furtherance and not in limitation of, and without prejudice to the general powers conferred or implied in the last preceding clause, and of the other powers conferred by these presents, it is hereby expressly declared that the Directors shall have the powers following (that is to say):

- (a) To institute, conduct, defend, compromise, settle, or abandon any action, suit, prosecution, or other legal proceedings on behalf of the Company, and also to compound and allow time for payment or satisfaction of any debts due to or from the Company, and any claims or demands made by or against the Company.
- (b) To refer any claims or demands by or against the Company to arbitration, and observe and perform or enforce the award.
- (c) To make and give receipts, releases, and other discharges for money payable to the Company, and for claims and demands by the Company.
- (d) To act on behalf of the Company in all matters relating to bankrupts and insolvents, with power to accept the office of trustee, assignee, liquidator, or inspector, or any similar office.
- (e) To invest any of the moneys of the Company which the Directors may consider not to be immediately required for the purposes thereof, upon such securities and in such manner as they may think fit, and so that they shall not be restricted to such securities as are permissible to trustees without special powers, and from time to time to vary or release such investments.
- (f) To delegate to any one or more of the Directors of the Company for the time being, or any other person or company for the time being, residing or carrying on business in Ceylon or elsewhere all or any of the powers or functions given to or exercisable by the Directors ; and to confer such powers for such time and to be exercised for such objects and purposes, and upon such terms and conditions and with such restrictions as the Directors may think expedient, and to confer such powers either collaterally with or to the exclusion of, and in the substitution for all or any of the powers of the Directors in that behalf, and from time to time to revoke, withdraw, alter or vary all or any of such powers. The Board may elect a Chairman of their meetings, and determine the period for which he is to hold office, and all meetings of the Directors shall be presided over by the Chairman if one has been elected and if present, but if there be a vacancy in the office of Chairman, or if at any meeting of Directors the Chairman be not present at the time appointed for holding the same, then and in that case the Directors present shall choose one of their number to be Chairman of such meeting.

111. Any question which shall arise at any meeting of the Directors shall be decided by a majority of votes, and in case of an equality of votes the Chairman thereat shall have a casting vote in addition to his vote as a Director. 112. The Board may delegate any of their powers to committees consisting of such member or members of

their body as the Board think fit, and they may from time to time revoke and discharge any such committee, either wholly or in part, and either as to persons or purposes, but every committee so formed shall, in exercise of the powers delegated to it, conform to all such regulations as may be prescribed by the Board. All acts done by any such committee, in conformity with such regulations and in the fulfilment of the purposes of their appointment, but not otherwise, shall have the like force and effect as if done by the Board. 113. The meetings and proceedings of such committees shall be governed by the provisions herein contained

The acts of the Board and of any committees appointed by the Board shall, notwithstanding any vacancy in the Board or Committee, or defect in the appointment or qualification of any Director or of any member of the Committee, be as valid as if no such vacancy or defect had existed, and as if such person had been duly appointed or qualified, provided the same be done before the discovery of the vacancy or defect.

115. A resolution in writing signed by all the Directors shall be as valid and effectual as if it had been passed 

- 1) Of all appointments of (a) officers and (b) committees made by the Directors.
- (2) Of the names of the Directors present at each meeting of the Directors.
  (3) Of the names of the members of the Committee appointed by the Board present at each meeting of the Committee
- Of all orders made by the Directors. Of all resolutions and proceedings of all General Meetings of the Company. (5)
- (6) Of all resolutions and proceedings of all meetings of the Directors. (7) Of all resolutions and proceedings of all meetings of Committees appointed by the Board.

(7) Or all resolutions and proceedings of all meetings of Committees appointed by the Board. 117. All such Minutes shall be signed by the person who shall have presided as Chairman at the General Meeting, the Board Meeting, or Committee Meeting at which the business minuted shall have been transacted, or by the person who shall preside as Chairman at the next ensuing General Meeting, or Board Meeting, or Committee Meeting, as the case may be; and all Minutes purporting to have been signed by any Chairman of any General Meeting, Board Meeting, or Committee Meeting, respectively, shall, for all purposes whatsoever, be *primá facie* evidence of the actual and regular passing of the resolutions, and the actual and regular transaction or occurrence of the proceedings and other matters purporting to be so recorded, and of the regularity of the meeting at which the same shall appear to have taken place, and of the Chairmanship and signature of the person appearing to have signed as Chairman, and of the date on which such meeting was held.

#### ACCOUNTS.

118. The agent or secretary or the agents or secretaries for the time being, or, if there be no agent or secretary or agents or secretaries, the Directors shall cause true accounts to be kept of the paid up capital for the time being of the Company, and of all sums of money received and expended by the Company, and of the matters in respect of which such sums were received and expended, and of the assets, credits, and liabilities of the Company, and generally of all its commercial, financial, and other affairs, transactions, and engagements, and of all other matters necessary for showing the true financial state and condition of the Company. The accounts shall be kept in such books, and in such a manner at the registered office of the Company as the Directors think fit. 119. The Directors shall from time to time determine whether, and to what extent, and at what times and places and under what conditions or regulations the accounts and books of the Company or of any of them shall be

The statement so made shall show, arranged under the most convenient heads, the amount of gross income, distinguishing the several sources from which it has been derived, and the amount of gross expenditure, distinguishing the expense of the establishment, salaries, and other heads of expenditure. Every item of expenditure fairly chargeable excinct the year's income shall be brought into account so that a just a balance of profit and loss may be distinguishing the expense of the establishment, salaries, and other heads of expenditure. Every item of expenditure fairly chargeable against the year's income shall be brought into account, so that a just balance of profit and loss may be laid before the meeting, and in case where any item of expenditure which may in fairness be distributed over several years has been incurred in any one year, the whole amount of such items shall be stated, with the addition of the reasons why only a portion of such expenditure is charged against the income of the year. 122. The balance sheet shall contain a summary of the property and liabilities of the Company, arranged under the heads appearing in the form annexed to the table referred to in schedule C to "The Joint Stock Companies' Ordinance, 1861," or as near thereto as circumstances admit. 123. Every such statement shall be accompanied by a report as to the state and condition of the Company, and as to the amount which the Directors recommend should be paid out of the profits by way of thividend or bonus to the Shareholders, and the statement, report, and balance sheet shall be signed by the Directors. 124. A printed copy of such balance sheet shall, at least seven days previous to such meeting, be delivered at or posted to the registered address of every Shareholder. 125. #### AUDIT.

126. No person shall be eligible as an Auditor who is interested otherwise than as a Shareholder in any 126. No person shall be eligible as an Auditor who is interested otherwise than as a Shareholder in any transaction of the Company, but it shall not be a necessary qualification for an Auditor that he be a Shareholder of the Company, and no Director or officer of the Company shall, during his continuance in office, be eligible as an Auditor. 127. 131. Every Auditor shall be supplied with a copy of the balance sheet intended to be laid before the next Ordinary General Meeting after his appointment, and it shall be his duty to examine the same with the accounts and vouchers relating thereto, and to report thereon to the meeting, generally or specially, as he may think fit.

132. The Auditor or Auditors for the time being shall have a list delivered to him or them of all books kept by the Company, and he or they shall at all reasonable hours in the day time have access to all accounts, books, and documents whatsoever of the Company for the purpose of audit.

#### DIVIDENDS, BONUS, AND RESERVE FUND.

133. The Directors may, with the sanction of the Company in General Meeting, from time to time declare a dividend to be paid, and (or) pay a bonus to the Shareholders in proportion to their shares, but no dividend shall be payable except out of net profits.

The Directors may, if they think fit, determine on and declare an interim dividend to be paid, or pay a 134.

bonus to the Shareholders on account, and in anticipation of the dividend for the then current year.
135. The Directors may, before recommending any dividend or bonus, set aside, out of the profits of the Company such a sum as they think proper as a reserve fund, and shall invest the same in such securities as they may,

with the sanction of the Company, select, or shall place the same in fixed deposit in any bank or banks. 136. The Directors may from time to time apply such portion as they think fit of the reserve fund to meet contingencies, or for equalizing dividends, or for working the business of the Company, or for repairing, or maintain-ing, or extending the buildings and premises of the Company, or for the repair or renewal, or extension of the property or plant of the Company or any part thereof, or for any other purposes connected with the interest of the Company that they may from time to time appropriate Company that they may from time to time deem expedient.

141. Every dividend or bonus payable in respect of any share held by a firm may be paid to, and an effectual receipt given by, any partner of such firm or agent duly authorized to sign the name of the firm.
142. Every dividend or bonus payable in respect of any share held by several persons jointly other than a firm may be paid to, and an effectual receipt given by any one of such persons.

#### NOTICES.

143. Notices from the Company may be authenticated by the signature (printed or written) of the agent or

secretary, agents or secretaries, or persons appointed by the Board to authenticate the same. 144. Every Shareholder shall give an address in Ceylon, which shall be deemed to be his place of abode, and

1. THE name of the Company is "The Kandvan Hills Company, Limited."

2. The registered office of this Company is to be established in Colombo, Cevlon.

3. The objects for which this Company is established are-

(4) To purchase, take on lease, or in exchange hire, or otherwise acquire any property, real or personal, movable or immovable, and any rights, easements, patents, licenses, or privileges in Ceylon or elsewhere (including the benefit of any trade mark or trade secret) which may be thought necessary or convenient for the purpose of this Company's business, and to erect, construct, maintain, and alter any buildings, machinery, plant, roads, ways, or other works, communications, or things for the like purpose, and to sell, manage, improve, develop, lease, or dispose of, or otherwise deal with all or any part of the property owned or occupied by this Company. #### OF ASSOCIATION OF THE KANDYAN HILLS COMPANY, LIMITED. ARTICLES

It is agreed as follows :---

1. Table C not to apply: Company to be governed by these Articles.—The regulations contained in the Table C in the schedule annexed to "The Joint Stock Companies' Ordinance, 1861," shall not apply to this Company, which shall be governed by the regulations contained in these Articles, but subject to repeal, addition, or alteration by special resolution.

2. Power to alter Regulations.—The Company may, by special resolution, alter and make provisions instead of, or in addition to, any of the regulations of the Company, whether contained and comprised in these Articles or not.

#### INTERPRETATION.

Minutes of General Meeting.—Minutes of the proceedings of every General Meeting, whether Ordinary or Extraordinary, shall be entered in a book to be kept for that purpose, and shall when so entered be signed as soon as practicable by the Chairman of the same meeting, or by the Chairman of the succeeding meeting, and the same when so entered and signed shall be evidence of all such proceedings, and of the proper election of the Chairman.

#### VOTING AT MEETINGS.

63. Proxy to be Printed or in Writing.—The instrument appointing a proxy shall be printed or written, and

shall be signed by the appointer, or if such appointer be a corporation, it shall be by the common seal of such corporation.

Exceptions .--But the above rules shall be subject to the following exceptions :-- That no Director shall vacate his office by reason of his being a member of any corporation, company, or firm which has entered into any contract with, or done any work for, the Company, of which he is a Director, or by his being agent, or secretary, or solicitor, or

by his being a member of a firm who are agents or secretaries or solicitors of the Company; nevertheless he shall not vote in respect of any contract, work, or business in which he may be personally interested. 93. 108. What Accounts to be kept.—The agent or secretary or the agents or secretaries for the time being, or if there be no agent or secretary or agents or secretaries, the Directors shall cause true accounts to be kept of the paid up capital for the time being of the Company, and of all sums of money received and expended by the Company, and of the matters in respect of which such receipts and expenditure take place, and of the assets, credits, and liabilities of the Company, and generally of all its commercial, financial, and other affairs, transactions, and engage-ments, and of all other matters necessary for showing the true financial state and condition of the Company, and the company as the Directors the matters hall be kept in such books and in such a menner at the receiptered office of the Company as the Directors think fill accounts shall be kept in such books and in such a manner at the registered office of the Company as the Directors think fit

115. Accounts how and when open to Inspection.-The Directors shall from time to time determine whether, and to what extent, and at what times and places, and under what conditions or regulations, the accounts and books of the Company or of any of them shall be open to the inspection of the Shareholders, and no Shareholder shall have any right of inspecting any account, or book, or document of the Company except as conferred by the statutes or authorized by the Directors, or by a resolution of the Company in General Meeting.

116. 118. Copy of Balance Sheet to be sent to Shareholders. - A printed copy of such balance sheet shall, at least seven days previous to such meeting, be delivered at or posted to the registered address of every Shareholder.

#### DIVIDENDS, BONUS, AND RESERVE FUND.

119. Declaration of Dividend.—The Directors may, with the sanction of the Company in General Meeting, from time to time declare a dividend to be paid to the Shareholders in proportion to their shares, but no dividend shall be payable except out of net profits. 120. Interim Dividend. -- The Directors may, if they think fit, determine on and declare an interim dividend or

dividends to be paid to the Shareholders on account and in anticipation of the dividend on the then current year.

121. Reserve Fund. Previously to the Directors recommending any dividend, they may set aside out of the profits of the Company such a sum as they think proper as a Reserve Fund, and shall invest the same in such

Application thereof.—The Directors may from time to time apply such portion as they think fit of the reserve fund to meet contingencies, or for equalizing dividends, or for working the business of the Company, or for repairing, or maintaining, or extending the buildings and premises, or for the repair or renewal, or extension of the property or plant connected with the business of the Company or any part thereof, or for any other purpose of the Company which they from time to time deem expedient. 123. Unpaid Interest or Dividend not to bear Interest.—No unpaid interest or dividend shall ever bear interest

against the Company. 124. No Shareholder to receive Dividend while Debt due to Company.—No Shareholder shall be entitled to receive payment of any dividend in respect of his share or shares whilst any moneys may be due or owing from him (whether

alone or jointly with any other person) to the Company in respect of such share or shares or otherwise howsover. 125. Directors may deduct Debt from the Dividend.—The Directors may deduct from the dividend payable to any Shareholder all sums of money due from him (whether alone or jointly with any other person) to the Company, and notwithstanding such sums shall not be payable until after the date when such dividend is payable.

Notice of Dividend; Forfeiture of unclaimed Dividend.—Notice of all interest or dividend to become payable shall be given to each Shareholder entitled thereto, and all interest or dividend unclaimed by any Shareholder for three years after notice thereof is given may be forfeited by a resolution of the Board of Directors for the benefit of the Company, and if the Directors think fit may be applied in augmentation of the reserve fund. 127. Shares held by a Firm.—Every dividend or bonus payable in respect of any share held by a firm may be paid to, and an effectual receipt given by, any partner of such firm or agent duly authorized to sign the name of the firm.

#### AUDIT.

129. Accounts to be audited.-The accounts of the Company shall from time to time be examined, and the correctness of the balance sheet ascertained by one or more Auditor or Auditors.

130. Qualification of Auditors,—No person shall be eligible as an auditor who is interested otherwise than as a Shareholder in any transaction of the Company, but it shall not be a necessary qualification for an Auditor that he be a Shareholder of the Company, and no Director or officer of the Company shall during his continuance in office be eligible as an auditor.

131. Appointment and Retirement of Auditors .- The Directors shall appoint the first Auditors of the Company and fix their remuneration and all future Auditors, except as is hereinafter mentioned, shall be appointed at the first Ordinary General Meeting of the Company in each year by the Shareholders present thereat, and shall hold their office only until the first Ordinary General Meeting after their respective appointments, or until otherwise ordered by a General Meeting.

138. Shareholder to Register Address.—Every Shareholder shall give an address in Ceylon, which shall be deemed to be his place of abode, and shall be registered as such in the books of the Company.
139. Service of Notices.—A notice may be served by the Company upon any Shareholder, either personally or by sending the same through the post in a prepaid letter addressed to such Shareholder at his registered address or place of abode; and any notice so served shall be deemed to be well served for all purposes, notwithstanding that the Shareholder to whom such notice is addressed be dead, unless and until his executors or administrators shall have given to the Directors or to the agent or secretary or agents or secretaries of the Company their own or some other address.

140. PROVISION RELATIVE TO WINDING UP OR DISSOLUTION OF THE COMPANY.


