EXCISE ORDINANCE

Excise Notification

IT is hereby notified that the following Order issued by Honourable Minister of Finance, by virtue of the power vested in him by Section 32 read with Section 22 of the Excise Ordinance (Chapter 52) as amended from time to time, and published in the *Extraordinary Gazette* No. 1981/87 of 26.08.2016 to impose an Excise duty per litre of imported foreign liquor as follows with effect from 01.09.2016, was passed by Parliament on 10.12.2016.

(i) Foreign Malt Liquor	Rs. 50.00
(ii) Foreign Wine	Rs. 100.00
(iii) Any other Foreign Liquor	Rs. 200.00
(which are not included in (i) and (ii) above)

RULES

1. A person who wishes to import liquor shall submit an application form set out in accordance with the Schedule I to the Commissioner General of Excise.

2. If the Commissioner General of Excise is satisfied about the application forwarded by the applicant, the approval shall be sent to the Controller of Imports and Exports with the form set out in accordance with the Schedule II.

3. If Commissioner General of Excise is not satisfied about the application, such Commissioner shall inform the applicant, reason for rejection within five days of the receipt of the application.



4. After the receipt of foreign liquor by the Department of Customs, the Director General of Customs shall issue a letter in accordance with Schedule III for the purpose of clearance of foreign liquor to the Commissioner General of Excise.

5. The Commissioner General of Excise shall issue a license for import and a pass for transport of foreign liquor in the form set out in accordance with Schedule IV and V, upon payment of excise duty.

6. The import license issued by the Commissioner General of Excise shall be produced for inspection when required by an Excise officer of the licensed premises.
