THE FOOD CONTROL ACT, No. 25 OF 1950

Order No. 87

BY virtue of the powers vested in me by section 4 (1) (iv) of the Food Control Act. No 25 of 1950, 1, Junius Ruchard Jäyewardene, Minister of Agriculture and Food, do by this Order prohibit the removal from the Customs premises at any port or place mentioned in the first column of the Schedule hereto, of any rice, paddy, wheat, wheat fluir or kurakkan except under a permit issued by the person or any of the persons, as the case may be, mentioned in the corresponding entry in the second column of that Schedule, and except in accordance with such directions as he may issue in regard to the time at which, the manner in which and the place to which such rice, paddy, wheat, wheat flour or kurakkan may be so removed

THE FOOD CONTROL ACT, No. 25 OF 1950 Order No. 39

BY virtue of the powers vested in me by section 4 (1) (vi) of the Food Control Act, No 25 of 1950, I, Junius Richard Jayewardene, Minister of Agriguiture and Food, do by this Order direct the Food Controller to take steps for the allocation of supplies of paddy or other grain or any preparation made mainly or wholly from such grain to merchants and distributors in all parts of Ceylon and to organise and administer a system of rationing such supplies on and after the date hereof.

THE TEA THEFTS PREVENTION ACT, No. 45 OF 1958 **Notification No. 1**

REGULATIONS made by the Minister of Agriculture and Food by virtue of the powers vested in him by section 18 of the Tea Thefte Prevention Act, No. 45 of 1953, and approved by the Senate and the House of Representatives

REGULATIONS

1. These regulations may be cited as the Tea Thefts Prevention Regulations, 1954

2. The fee to be prescribed for the purposes of sub-section (1) of section 2 of the Act shall be ten rupees.

3. Every application for a dealer's licence shall be substantially in Form TT 1 set out in the Schedule hereto '

4. Every dealer's licence issued under section 2 of the Act shall be substantially in Form TT 2 set out in the Schedule hereto and shall contain particulars of the matters stated therein.
5. It shall be the duty of every licensed dealer to notify to the Controller any change in his address or in the

name or address of the licensed premises or the occurrence of any circumstance affecting the accuracy of the particulars furnished in his application for a licence, within seven days from the date of such change or the occurrence of such circumstance.

6 The quantity to be presented for the purposes of the sub-paragraph (i) of paragraph (a) of the proviso to sub-section (1) of section 4 of the Act shall-Ś

- in the case of a retailer carrying on business in any area within the administrative limits of any Municipal Council or Urban Council, be one hundred and twelve pounds, and
 in the case of a retailer carrying on business in any other area, be thirty pounds.

7 The quantity to be prescribed for the purposes of sub-paragraph (11) of paragraph (a) of the proviso to sub-section (1) of section 4 of the Act shall-

(1) in the case of any person being the proprietor, manager or person in charge of any establishment--

- (a) where there are not less than one hundred resident inmates, be five hundred pounds,
- (b) where there are less than one hundred but more than twenty-five resident inmates, be t hundred and fifty pounds, and (c) where there are less than twenty-five resident inmates-
 - - (1) be one hundred and twelve pounds, if such establishment is situated within the administrative limits of any Municipal Council or Urban Council, and
 - (11) be fifty-six pounds, if such establishment is situated m any other area, and

(2) in the case of any other person, be ten pounds

8 (1) Every application for a permit under section 6 (3) of the Act for the purchase or taking delivery of tea seed shall be substantially in Form TT 3 set out in the Schedule hereto

(2) Every permit issued under the aforesaid section for the purchase or taking delivery of tea seed shall be in Form TT 4 set out in the Schedule hereto.

9 (1) Every application under section 7 (2) of the Act for a permit authorising the purchase of refuse tea shall be substantially in Form TT. 5 of the Schedule hereto

(2) Every permit issued under section 7 of the Act for the purchase of refuse tea shall be substantially in Form TT. 6 of the Schedule hereto

10. No manufacturer shall sell of deliver any refuse tea to any person to whom a permit has been issued under section 7 of the Act-

(1) unless such refuse tey has been denatured by one of the following processes, that is to say-

- (a) by the addition of 1 per centum lime and 1 per centum lead oxide, or
 (b) by the addition of 1 per centum magnesium oxide and 1 per centum alum, or
- (c) by the addition of 1 per centum petroleum distillate (Kerosene), or
- (d) by the addition of 1 per centum alum and 1 per centum quick lime (CaO), or (e) by the addition of 1 per centum lime and 1/10 per centum assafoetida, or any other process approved in that behalf in writing by the Controller; and
- (2) unless the package or packages containing such refuse tea is or are marked "Denatured Tea-Unfit for human consumption" in conspicuous characters.

11. (1) The register required to be maintained by a licensed dealer under section 9 (2) of the Act shall-

- (a) in the case of a licensed dealer in made tca, bo substantially in Form TT. 7 set out in the Schedule, hereto,
- (b) in the case of a licensed dealer in green tea leaf, be substantially in Form TT. 8 set out in that Schedule and
- (c) in the case of a licensed dealer in tea seed, be substantially in Form TT. 9 set out in that Schedule.
- (2) Every such register shall contain particulars of the matters stated in the appropriate Form.

12 The register required to be maintained by a manufacturer under section 9 (3) of the Act shall be substantially in Form TT. 10 set out in the Schedule hereto and shall contain particulars of matters stated in that Form.

13. The return required to be transmitted to the Controller by a licensed dealer under section 9 (6) of the Act shall— /.

- (a) in the case of a dealer in made tea, be substantially in Form TT. 11 set out in the Schedule hereto,
- (b) in the case of a dealer in green tea leaf, be substantially in Form TT. 12 set out in that Schedule, and
- (c) in the case of a dealer in tea seed, be substantially in Form TT. 13 set out in that Schedule.

14 The return required to be transmitted to the Controller under section 9 (7) shall be substantially in Form TT. 14 set out in the Schedule hereto.

- 15 The declaration required to be furnished under-
 - (a) section 11 (1) of the Act shall be substantially in Form TT 15 set out in the Schedule hereto,
 - (b) section 11 (2) of the Act shall be substantially in Form TT. 16 set out in that Schedule, and
 - (c) section 11 (3) of the Act shall be substantially in Form TT. 17 set out in that Schedule.
- 16. In these regulations-
 - "Act" means the Tea Thefts Prevention Act, No. 45 of 1953,

"Controller" has the same meaning as in the Act; and

"establishment" includes an educational institution, hospital, prison, reformatory, monastery, convent, boarding house, hotel restaurant, eating house or tea boutique.


