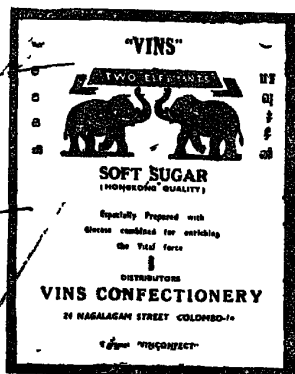

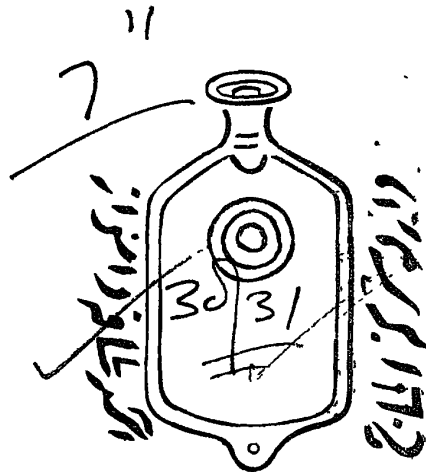

"Improvements in and relating to incandescent mantles and a method for strengthening the ash skeleton of such mantles for use in illuminating appliances and prepared fuels for improving incandescent mantles"

Abstract — This invention relates to a method which makes a strengthening of the ash skeleton of the incandescent mantles for gas lamps, &c According to

the invention heat resisting substances (improving means) are introduced with the flow of gas required for producing the flame heating the incandescent mantles into the incandescent mantle when in the position of use. These improving means may be added either undiluted or diluted to the gas, the liquid gas or the liquid fuel.

Four examples are given as to how this may be done and 15 claims are made

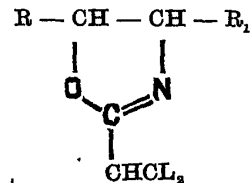

"New Oxazolines and Processes for producing the same"

Abstract.—This invention relates to new oxazolines and to processes for their preparation.

The new oxazolines of the present invention are the dichloromethyl oxazolines of 2-amino-1-para-nitrophenyl propane 1-3-diol and conform to the conventional formula:



where R represents a para-nitrophenyl group and R₁ represents an hydroxymethyl group or R represents a hydrogen atom and R₁ represents a para-nitrophenyl-hydroxymethyl group.

"Improved tyre lug"

Abstract.—The nature of the invention can be ascertained from Claim 1 which reads as follows —

1. A method of relugging tyres having transverse traction lugs, which comprises preparing the tyre to receive the replacement lug by buffing and applying cement to the old lug residue or to said residue and the portions of the tyre adjacent thereto, applying a replacement lug to the prepared surfaces and securing such by the aid of lateral members extending from the body of the replacement lug over the margins of the old lug or over said margins and the portions of the tyre adjacent thereto and vulcanising the whole in situ.

"An improved method of cooking vegetable fibrous raw materials for the production of pulp"

Abstract.—The nature of the invention can be ascertained from Claims 1 and 2 which read as follows:—

1. In the production of chemical or semi-chemical pulp from vegetable fibrous raw material, the step of pre-digesting the vegetable fibrous raw material in a pre-digestion chemical liquor, prior to cooking or mechanically pulping the fibrous material, the quantity of chemical or chemicals and the quantity of liquor used in the pre-digestion treatment being in excess of that used in the subsequent cooking or mechanically pulping treatment of the partially digested fibrous material.

2. The method of producing chemical or semi-chemical pulp from vegetable fibrous raw material which comprises pre-digesting the fibrous raw material in a pre-digestion chemical liquor and subsequently cooking or mechanically pulping the partially-digested fibrous material in a chemical pulping liquor of the same kind, the quantity of chemical or chemicals, and the quantity of liquor used in the pre-digestion treatment being in excess of that used in the subsequent cooking or mechanically pulping treatment of the partially digested fibrous material.
