Patent No 3,302 of 1st March, 1940

American Cyanamid Company, Manufacturers, a corporation organized and existing under the laws of the State of Maine, United States of America, having a place of business at 30, Rockefeller Plaza, New York, New York, U. S. A., seek leave to amend the specification of Letters Patent numbered and dated as above for " Sulphonamido Pyrimidines " alleging as reasons —

The Ceylon Patent is a Registration of British Patent No 555,865 which has been substantially amended by way of disclaimer and it is therefore desirable to similarly amend the Ceylon Patent to bring it in conformity with the British Patent.

The proposed amendments are as follows —

Page 1—Line 27 strike off " a halogen, nitro, azo " and or after amino

Strike off lines 28, 29. and amino in line 30.

Line 31 strike off " an alkyl group " after metal add and after Py is add 2-pyrimidyl or 2-(4, 6-dimethylpyrimidyl) and cancel lines 32 to 41.
