No 4,094 of March 4, 1954 (Convention application under Section 48, claiming priority date, March 12; 1953)

UNION CARBIDE AND CARBON CORPORATION "Dry Cell".

Abstract The nature of the invention can be ascertained from claim 1 which reads as follows —

1 A primary galvanic cell comprising a cup-shaped consumable metal electrode containing a centrallypositioned carbonaceous electrode surrounded with a depolarizer mix and an immobilized electrolyte disposed between the depolarizer mix and the inside wall of said container, characterized in that the cup-shaped consumable metal electrode is positioned within a substantially leak-proof container comprising upper and lower metallic closure members in contact respectively with the carbonaceous electrode and the consumable metal electrode, and a multiply electrically non-conductive jacket surrounding the outer wall of said consumable metal electrode, the edges of the metal closure members and the edges of the jacket being curled to form a liquid tight seal, a layer of wax being coated over the entire underside of the top metal closure to protect the closure from corrosive action of electrolyte or cell exudate, the innermost ply of said jacket being of bibulous material to absorb exudate from the cell, an intermediate ply of said jacket being of electrolyteimpermeable organic resinous material effective to bar transmission of such exudate, and an outer ply of said jacket being of electrically non-conductive material which supports the electrolyte-impermeable ply when wet with exudate.
