



"Improvements in or relating to pumps"

Abstract.—This invention concerns pumps for delivering particulate materials in the dry state.

The nature of the invention can be ascertained from -Claims 1 and 2 which read as follows —

- 1. A pump of the kind hereinbefore set forth for delivering particulate materials characterized in that either the stator or the rotor comprises bristle-like elements which co-operate with the rotor or stator respectively to convey the particulate materials through the pump
- 2 A pump according to Claim 1 in which the bristle-like elements are on the rotor which comprises a bristle carrier of helical form and bristle-like elements secured to the carrier

"Improvements in the manufacture of Tea"

Abstract —The nature of the invention can be ascertained from Claims 1, 2 and 3 which read as follows.—

- 1 A method for the treatment of tea which includes the step of feeding the dired leaf into a mill comprising a plurality of beaters rotating within a perforated container or screen
- 2 A method as claimed in Claim 1 wherein the beaters are pivoted to a rotor carried by a shaft, so that the beaters during rotation fly out by centrifugal force
- 3 A method as claimed in Claim 1 or 2 wherein the size and spacing of the perforations in the screen and/or the number of beaters, and/or the speed of rotation of the latter, are adjusted according to the kind of tea to be treated
