"Process of manufacturing construction materials and the like from coconut husks"

Abstract —This invention relates to a dry process for manufacturing construction materials

According to this invention the process consists in defibering coconut husk so as to separate the waste (coir dust and shorts) from the long fibres, utilising the said waste alone without the addition of any binding material, drying the waste, preforming the said dried waste into boards and subjecting the boards to pressure under temperature. On a commercial scale, the process utilises the coir dust and short fibres of unretted coconut husks.
