THE FISHERIES ORDINANCE, No. 24 OF 1940

REGULATION made by the Minister of Commerce, Trade and Fisheries by virtue of the powers vested in him by section 26 of the Fisheries Ordinance, No 24 of 1940, and approved by the Senate and the House of Representatives

Regulation

The regulations relating to the registration of fishing boats published in *Gazette* No 10,560 of August 7, 1953, are hereby amended as follows —

(1) In regulation 3

(a) in paragraph (a) of that regulation, by the substitution for all the words from "and in a" to "such form" of the words "or if in Sinhalese or Tamil, be in the corresponding form in that language"; and

(b) in paragraph (b) of that regulation, by the substitution for all the words from "registration of the boat", to the end of that paragraph, of the words "registration of the boat";

(2) in regulation 3, by the substitution for the words "a satisfactory report relating to its condition", of the words "a report to the effect that the boat is fit for use";

(3) in regulation 4 by the insertion, immediately after paragraph (2), of the following new paragraph —

(3) The Director shall issue to the owner of a registered fishing boat a certified copy of the certificate of registration issued under paragraph (1), on the application of such owner and on payment by him of a fee of one rupee

(4) by the substitution for regulation 6, of the following new regulation —

" 6 (1) The owner of every registered fishing boat other than a boat referred to in paragraph (2) shall cause the registration number and the distinguishing letters allotted to that boat at the time of registration to be clearly engraved or marked on each side of the boat in white figures and letters. Such figures and letters shall —

(a) in the case of a boat not exceeding fifteen feet in length, be at least six inches in length and one and a half inches in breadth, and

(b) in the case of a boat exceeding fifteen feet in length, be at least eight inches in length and two inches in breadth

(2) The owner of every registered catamaram shall cause the registration number and the distinguishing letters allotted to that catamaram at the time of registration to be clearly engraved or marked across the logs of such catamaram in black figures and letters which are at least eight inches in length and two inches in breadth. The figures and letters shall be so engraved or marked that a part of the registration number and of the distinguishing letters shall appear on each of the logs of the catamaram.

(3) Subject to the preceding provisions of this regulation the owner of every registered fishing boat with a sail shall cause the registration number and the distinguishing letters allotted to that boat at the time of registration to be clearly painted on each side of the sail in black figures and letters on a white background. Such figures and letters shall be at least fifteen inches in length and two inches in breadth";

(5) in regulation 9 —

(a) in paragraph (1), by the substitution for all the words from "accompanied by" to the end of that paragraph, of the

- words "accompanied by the fee set out in the Third Schedule hereto for the registration of the boat", and
- (b) in paragraph (2), by the substitution for the words "a satisfactory report in respect of such boat has been made by him", of the words "and a report to the effect that the boat is fit for use has been issued by such officer",
- (6) in regulation 10, by the insertion immediately after paragraph (2) of the following new paragraph —
- "(3) The Director shall issue to the owner of a registered fishing boat a certified copy of the certificate of the renewal of registration issued under paragraph (1), on the application of such owner and on payment by him of a fee of one rupee",
- (7) in regulation 12, by the substitution for all the words from "case. Every such" to the end of that regulation, of the word "case.",
- (8) by the re-numbering of regulations 14 and 15 as regulations 15 and 16 respectively,
- (9) by the insertion, immediately after regulation 13, of the following new regulation —
- "14 The Minister may, by Order published in the *Gazette* declare that all the provisions of any specified provision, of these regulations shall not apply in relation to any specified class or description of fishing boats",
- (10) in the First Schedule thereto by the substitution for Form D, of the following new Form —

- (11) in the Second Schedule thereto —
- (a) by the substitution for the words "For each catamaram or theppam propelled by paddles or oars", of the words and figures "For each catamaram, theppam or for any other type of boat which does not exceed 15 feet in length"; and
- (b) by the substitution for the words and figures "For each oru or other rowing or sailing boat not exceeding 30 feet in length", of the words and figures "For each oru or for any other type of boat which exceeds 15 feet but does not exceed 30 feet in length", and
- (12) by the insertion, immediately after the Second Schedule to those regulations, of the following new Schedule —
