## THE REVENUE PROTECTION ORDINANCE

THE Order made under section 2 of the Revenue Protection Ordinance (Chapter 191) and published in Gazette Extraordinary No. 10,691 of July 8, 1954, under the heading Customs Notification (R P. O.) No. 54/5, is hereby amended, with effect from the date of which this Order is published in the Gazette, in Part A of the Schedule thereto as follows —

(1) Under the heading "Earthenware not elsewhere specified Roofing riles" by the substitution, for the figures "151 × 101", or the figures "162 × 101".

(2) under the heading "Motor vehicles, trailers and trancers and spare parts and accessories—Motor cars and motor station wagons (not including motor/formes)"—by the substitution for the items (i) a, (i) b, (ii) a, (iii) b, (iv) a, (iv) b, of the following new items :--

- (5) under the heading "Wireless goods and apparatus"-
  - (a) by the substitution for the words "Complete sets for receiving or transmitting" of the following :---
    - "Complete sets for receiving or transmitting and parts thereof n.e.s.", and
  - (b) by the substitution, for the words "Components and spare parts", of the words "Components and spare parts shown to the satisfaction of the Principal Collector of Customs to have been imported for the assembly of complete wireless sets for receiving or transmitting."
