GREETINGS

WHEREAS it appears to me to be necessary to appoint a Commission for the purposes hereinafter mentioned :

Now, therefore, I, Herwald, Viscount Soulbury, Governor-General, reposing great trust and confidence in your prudence, ability and fidelity, do in pursuance of the provisions of section 2 of the Commissions of Inquiry Act, No 17 of 1948, by these presents appoint you to be my Commissioners for the following purposes .—

- (1) To inquire into and report on the present state, and the causes for the decline, if any, of the cigar, cheroot and cigarette industries in Ceylon and of other tobacco products Industries in Ceylon, and
- (2) to report and make recommendations with regard to—
 - (a) the manufacturing methods of cigars, cheroots, cigarettes, pipe tobacco, chewing tobacco, snuff, beedies, and any other commercial products from tobacco, including the technology of tobacco curing ;
 - (b) the regulation, standardisation, and improvement in the quality of tobacco products ;
 - (c) the control, distribution, sales and marketing of tobacco products ;
 - (d) the wages and the working and living conditions of the workers engaged in the tobacco products industries ;

- (e) the duties and taxes applicable to the tobacco products industries ;
- (f) the technical and financial aid, if any, that should be given by Government to the tobacco products industries, and the terms and conditions on which such aid should be extended; and
- (g) such other matters as will promote the development and stabilisation of the tobacco products industries in Ceylon:

And I do hereby appoint you, the said Arumugam Wyrarnuttoo Nadaraja, to be the Chairman of the said Commission:

And I do hereby authorise and empower you, the said Commissioners, to hold such inquiries and make such investigations into the aforesaid matters as may appear to you to be necessary and require you to transmit to me, as early as possible, a report thereon under your hand:

And I do hereby direct that such part of any inquiry relating to the aforesaid matters as you may in your discretion determine shall not be held in public:

And I do hereby require and direct all public officers and other persons to whom you may apply for assistance or information for the purposes of your inquiry and investigations to render all such assistance

and furnish all such information as may properly be rendered and furnished in that behalf:

And I do hereby declare that the provisions of section 12A (inserted by Act No 8 of 1950) of the Commissions of Inquiry Act, No. 17 of 1948, shall apply in relation to this Commission.
