GENERAL CONDITIONS APPLICABLE TO APPOINTMENTS TO POSTS IN THE PUBLIC SERVICE ADVERTISED IN THE "CEYLON GOVERNMENT GAZETTE"

Allowances.—Unless otherwise stated, Rent Allowance, temporary Cost of Living Allowance and temporary Special Living Allowance are payable according to Government Regulations.

Conditions of Service.—Appointments will be subject to the Public Service Commission Rules, the Financial Regulations, the Regulations of the Manual of Procedure, Departmental Orders or Regulations, and any other orders or regulations issued from time to time by the Government.

Terms of Engagement.—(i) In the case of

Terms of Engagement.—(i) In the case of appointments to the non-pensionable establishment (excluding those on daily rates of pay), appointees will be required to contribute 5 per cent. of their salary to the Public Service Provident Fund, and they will be allowed to contribute, at their option, a further 5 per cent. The Government contribution, in either case, will be equal to 7½ per cent. of the salary paid in at the close of each financial year.

(ii) Appointees may be required to furnish security in terms of the Public Officers' (Security) Ordinance, if so required by the Head of

their Department.

(iii) Appointees other than those already in the Public Service will be required to pass a medical examination by a Government Medical Officer as to their physical fitness to serve in any part of the Island.

Qualifications required.—Every applicant must furnish satisfactory proof that he is a Ceylonese. A "Ceylonese" is a citizen of Ceylon by descent or by registration.

War Service Concession.—Provided they are qualified in all other respects, ex-Servicemen of Her Majesty's Fighting Forces and full-time members of the Auxiliary Fire, Air Raid Precautions

and Civil Defence Services (excluding those who had left these Services of their own accord), will be allowed to deduct periods of such service commencing from September 3, 1939, at the earliest and up to December 31, 1949, at the latest), from their ages for purposes of eligibility alone, provided that they joined the Forces before August 15, 1945, and that such service was satisfactory and continuous.

Other Requirements.—(i) Applications from officers of the Public Service, who are qualified, must be forwarded through the Heads of their respective Departments. In the case of applications from officers holding permanent posts in the Public Service, the Heads of the Departments concerned should, in forwarding the applications state whether or not they are prepared to release the applicants (if selected) in accordance with Administrative Regulation 109 of the Manual of Procedure.

(ii) Candidates may be required to present themselves for interview at an appointed time and place. No travelling or other expenses will be paid in this connection.

(iii) Anyone desiring to recommend a candidate should do so by giving a testimonial. Any form of canvassing or attempt to influence the selection of a candidate will disqualify such candidate.

(iv) Any statement in the application which is found to be incorrect will render the applicant liable to disqualification if the inaccuracy is discovered before the selection, and to dismissal if discovered after the selection.

EXAMINATION FOR THE RECRUITMENT OF HOSPITAL SECRETARIES, DEPARTMENT OF HEALTH, 1954

A COMPETITIVE examination for the recruitment of Hospital Secretaries in Grade II in the Department of Health will be held by the Public Service Commission on or about December 1954. The actual dates will be notified later. The Public Service Commission reserves the right to cancel this examination if it considers it expedient in the public interest to do so. It is open to the Public Service Commission to postpone the examination, should it consider it necessary.

- 2. It is estimated that the vacancies will be four of which two vacancies are in respect of permanent posts and two in respect of temporary posts. The Public Service Commission may omit to fill any or all the above vacancies if it considers this necessary in the public interest.
- 3. The examination is open to (a) members of the General Clerical Service, Stenographers' Service, Customs Clerical Service, Railway Clerical Service, Postal Clerical Service, Local Government Service Commission Clerical Service, Colombo Electricity Supply Clerical Service, Electrical Department Clerical Service, Malaria Control Scheme, Survey Department Clerks and Draughtsmen's Service, Railway Station Masters' Service who, on September 30, 1946, were members of the Railway Clerical Service and Postmasters' and Signallers' Service and who have passed the Senior School Certificate (English) or equivalent or higher examination and who are on a salary of not less than Rs. 2,424 p.a. on August 1, 1954.
- (b) Members of the Hospital Clerical Service who are on a salary of not less than Rs. 1,920 p.a. on August 1, 1954, and have passed the Senior School Certificate (English) or equivalent or higher examination.
 - Note.—(i) Members of the services mentioned in 3 (a) and (b) above who have passed the Intermediate or First Examination in Arts or Science of a recognised University or equivalent or higher examination will be eligible to compete, provided they have completed 5 years continuous service in any of the Services referred to in paragraph 3 on August 1, 1954. Applications from candidates who have appeared for such examination will be accepted provisionally and will be considered for appointment only on their furnishing proof of having passed the examination.
 - (ii) Possession of the Diploma in Accountancy of the Ceylon Technical College will be an added qualification.
 - 4. The examination will be held in two parts, viz., (I) a written examination and (II) Viva Voce examination.
- 5. The subjects for the written examination will be as follows and marks will be assigned as indicated against each subject. These subjects should be taken by ALL candidates:

 - Note.—Candidates, both of whose parents are Sinhalese or both Tamil, must take Sinhalese or Tamil, whichever language they prefer. Candidates who are not Sinhalese or Tamil will be given the option of offering Sinhalese or Tamil or Arabic or a special paper in English. Candidates of mixed parentage will be given the option of offering Sinhalese or Tamil, or if English or Arabic is the language of one of their parents, that language.
 - II. Viva Voce 150 mark

All written papers will be of one hour's duration except the paper in English Essay and Precis which will be of one and a half hour's duration.

No special syllabus is prescribed. The standard of the examination in English Essay and Precis, General Knowledge and the Language papers will be that of the London Matriculation examination.

The Viva Voce examination will be held on a date to be communicated to applicants after the written examination and will be restricted to applicants who attain a sufficiently high standard in the written examination.

6. (a) Successful candidates will be appointed to act as Hospital Secretaries for a period of two years. Confirmation will depend on officers passing the following examination:—

The examination will be in two parts:—

- (1) Written papers on-
 - (a) Rules, regulations and procedure relating to Hospital and Dispensary Administration, Public Service Commission Rules and Manual of Procedure.
 - (b) The Medical Department Financial Section Manual and the corresponding Financial Regulations referred to therein. Hospital Charges and Regulations as published in the Government Gazette.
- (2) An oral examination in whichever of the Ceylon Vernaculars has not been spoken by or familiar to the officer as a child.
- (b) Hospital Secretaries will fall within the category of seven day workers and their hours of duty will be from 8 A.M. to 5 P.M. on all days including Public Holidays.
- (c) Hospital Secretaries will be required to furnish security in a sum of Rs. 5,000 in terms of the Public Officers (Security) Ordinance. This security may be furnished either in cash or through a recognised Guarantee Association.
- (d) All appointments will be subject to the Public Service Commission Rules, Financial Regulations, Regulations of the Manual of Procedure, Departmental Orders or Regulations, and any other orders or regulations issued by Government from time to time.

Salary Increments

Annual salary increases are granted within the scales shown above.

Conditions of Resignation

Three months' notice of resignation is normally required.

Leave Provisions

Annual leave accrues at the rate of two and three-quarters working days for each completed month of service. Travelling expenses on home leave are paid once in three years. There is provision for paid sick leave.

Pension Plan

Employees of ICAO participate in the United Nations Joint Staff Pension Fund.
