THE SAVINGS CERTIFICATES ORDINANCE, No. 7 OF 1946

WHEREAS a resolution authorizing a sum of Rs 10,000,000 to be borrowed within Ceylon by the issue of savings certificates under the Savings Certificates Ordinance, No. 7 of 1946, as modified by the Proclamation published in *Gazette Extraordinary* No. 9,773 of September 24, 1947, has been passed by the House of Representatives under section 3 of the Ordinance and has been published in *Gazette* No 10 604 of October 23, 1953.

And whereas the Minister of Finance has, under section 4 (1) of the Ordinance, directed the Postmaster General to borrow a sum of Rs 5,000,000 of the said sum of Rs. 10,000,000 by the issue of savings certificates under the Ordinance (in addition to the sum of Rs. 5,000,000 referred to in the notification published in *Gazette* No. 10,649 of March 5, 1954):

Now, therefore, by virtue of the powers vested in me by section 5 of the Ordinance, I, Leopold James de Silva Senoviratne, Secretary to the Treasury, do by this notification specify the denominations set out in the First Schedule hereto as the denominations of savings certificates which are to be issued, and the purchase price and surrender values set out in the Second Schedule hereto, as the purchase price and surrender value respectively, of each certificate of each such denomination.

PRELIMINARY REPORT ON THE VITAL STATISTICS OF CEYLON, 1954

THE main features of the Vital Statistics for 1954 are summarized below —

Population

The estimated population of Ceylon at mid-year 1954 was 8,385,000 and at the end of the year 8,478,000

There has been an increase of 2.5 per cent in the Island's population during the year. The excess of births over deaths (natural increase) was 217,100 and of emigrants over immigrants 7,982

Marriages

The total number of marriages registered in 1954 under the General and Kandyan Marriage Ordinance was 45,882 (General 37,030 and Kandyan 8,852) as against 46,434 in 1953. The marriage rates (number of marriages per 1,000 of the (Non-Muslim) population) was 5.9 compared with 6.1 in 1953. The 1954 marriage rate is the lowest since 1941 when the rate stood at 5.7. Among the Muslims, 4,821 marriages were registered in 1954 and the marriage rate was 8.6 as against 9.5 in 1953.

Births

303,894 births (154,334 of males and 149,560 of females) were registered in 1954, a decrease of 17,323 compared with the 321,217 births registered in 1953. The sex ratio was 1,032 males to 1,000 females. The birth rate was 36.2 compared with 39.4 in 1953. The 1954 birth rate is the lowest recorded after 1940. The total number of births registered in Colombo Town in 1954 was 25,143 as against 29,725 in 1953. The birth rate for the resident population was 30.2 while the corresponding rate for 1953 was 35.0. 31,123 births on estates were registered in 1954. This is 4,166 fewer than in 1953.

Deaths

86,794 deaths (44,443 of males and 42,351 of females) were registered in 1954 as against 89,003 in 1953. The death rate which has come down from 10.9 in 1953 to 10.4 in 1954 is the lowest on record. In Colombo Town a total of 8,161 deaths were registered in 1954 compared with 7,986 in 1953. The death rate among residents of the town was 10.1 per 1,000 of the population as against 9.9 in 1953. 10,073 deaths on estates were registered in 1954 compared with 10,559 in 1953.

Infant Deaths

There were 21,891 deaths of infants in the first year of life in 1954 while the corresponding figure for 1953 was 22,869. The infant death rate of 72 per 1,000 live births is slightly above the rate for 1953 which was 71. The infant death rate for the resident population of Colombo Town was 77 and on estates 115 as against 72 and 101 respectively in 1953.

Maternal Deaths

The number of deaths from causes attributed to pregnancy and childbearing in 1954 was 1,388 compared with 1,558 in 1953. The maternal death rate of 4.6 in 1954 is an improvement on the rate of 4.9 in 1953 which was then the lowest on record. The rate among residents of Colombo Town in 1954 was 4.2. The maternal death rate on estates in 1954 was 4.5. This is higher than the abnormally low rate of 3.7 recorded on estates in 1953.
