Abstract — This invention relates to the control of flow of powdered material through an orifice

The object of the invention is to overcome the difficulty of the powder periodically clogging the onfice, resulting in the rate of delivery being irregular. The invention consists in a method of facilitating the steady flow of powdered material through an orifice by blowing air or other gas into the material adjacent to the orifice—thereby "aerating" it. This is achieved by having a container with an outlet aperture for the powdered material and means for directing a flow of air or other gas into the mass of powdered material in the container to the said outlet aperture
