"Improvements relating to novel vitreous compositions".

Abstract.—This invention relates to novel vitreous compositions adapted to serve as a source of nutrients for plant growth.

The invention comprises a composition of matter capable of supplying to growing plants the minor elements essential to good plant growth. It consists of finely divided particles of a slowly soluble fused synthetic vitreous matrix produced by fusion and fritting in water. The matrix contains iron and the minor amounts of each of the many substances selected from the class of inorganic compounds of manganese, zinc, copper, boron, cobalt and molybdenum.
