Abstract —The nature of the invention can be ascertained from Claim 1 which reads as follows —

The method of manufacturing percutaneous therapeutic preparations containing a selection from one or more of the substances or groups of substances first set forth in the preceding specification, according to which the selected substance/s is/are intimately associated with a substance other than the said selected substance/s, which other substance is itself brought into the condition of a readily absorbable vehicle or absorption facilitator for the first mentioned or selected substance/s, by intimate physical association with sugar additions in finely comminuted, substantially colloidal and homogeneous condition

Walton Washing Machine Corporation "Improvements in machines for washing clothes".

Abstract —The nature of the invention can be ascertained from Claim 1 which reads as follows —

1. A clothes washer unit, for mounting in a container holding liquid and articles to be washed, comprising a hollow perforated clothes engaging member adapted to be at least partially immersed in the liquid, driving mechanism for reciprocating said member vertically and a pump for withdrawing liquid from the interior of said member and expelling it from beneath said member outwardly into the container, thereby causing liquid outside said member to cascade through its perforations to replace the expelled liquid and at the same time to carry the articles towards said member and press portions at least of the articles against its outer surface, said member having external gripping surfaces which operate on each down stroke of the member to push articles in contact with it downwardly towards the output stream of the pump
