GENERAL CONDITIONS APPLICABLE TO APPOINTMENTS TO POSTS IN THE LOCAL GOVERNMENT SERVICE ADVERTISED IN PART IV OF THE “CEYLON GOVERNMENT GAZETTE”

1. *Allowances.*—Unless otherwise stated, Rent Allowance, temporary Cost of Living Allowance and temporary Special Living Allowance are payable according to Government Rates and Conditions.

2. *Conditions of Service.*—Appointments will be subject to the provisions of the Local Government Service Ordinance, No. 43 of 1945, as amended by the Local Government Service (Transitional Provisions) Ordinance, No. 5 of 1946, any further amendments of Ordinance No. 43 of 1945, and the Regulations made thereunder, and other conditions of service as laid down by the Commission from time to time.

3. *Terms of Engagement.*—The posts specified in the schedule published in Part IV of the *Ceylon Government Gazette* No. 10,432 of August 8, 1952, and other posts added thereto from time to time while held by members of the Local Government Service other than females are pensionable under the Local Government Service Pension Scheme Regulations, 1952.

(a) The pension rights of officers serving under Government will be conserved if released under Section 21 of the Government Minutes on Pensions, and transferred to pensionable posts in the Local Government Service.

(b) In the case of employees of Local Authorities who hold pensionable posts under the Pension

By-laws or Rules of the Local Authorities, the payment of their pension on ultimate retirement will be governed by the Pension By-laws or Rules of the Local Authority in whose employ they were on the date immediately preceding the date of their transfer to the Local Government Service, in terms of Section 48 of the Local Government Service Ordinance, No. 43 of 1945, as amended by the Local Government Service (Amendment) Act, No. 8 of 1949.

(c) All appointees to pensionable posts other than females, officers above the age of 55 and officers who were holding pensionable posts in Government Service on the date immediately prior to their appointment to the Local Government Service, are required to contribute 4 per cent of their salary to the Local Government Service Widows' and Orphans' Pension Fund established under the Local Government Service Widows' and Orphans' Pension Fund Regulations, 1952, published in the *Government Gazette Extraordinary* No. 10,429 of July 30, 1952. The Local Authority will contribute 3 per cent. of salary.

(d) Appointees may be required to furnish security either in cash or by Fidelity Guarantee Bond through a Guarantee Association approved by the Local Government Service Commission in a sum which may be decided upon by the Local Authority.

(e) Appointees not holding scheduled posts in the Local Government Service or permanent posts in the Public Service will be required to pass a medical examination by a duly qualified medical practitioner as to their physical fitness to serve in any part of the Island.

(f) The appointment will generally be on probation or subject to confirmation after a period of one year unless otherwise specified.

4. *Qualifications required.*—Every applicant must furnish satisfactory proof that he is a Ceylonese. The term "Ceylonese" for all purposes of recruitment to the Local Government Service is defined as a citizen of Ceylon by descent or by registration.

5. *War Service Concession.*—Provided they are qualified in all other respects, ex-Servicemen of Her Majesty's Fighting Forces and full-time members of the Auxiliary Fire, Air Raid Precautions and Civil Defence Services (excluding those who had left these Services of their own accord), will be allowed to deduct periods of such service (commencing from September 3, 1939, at the earliest and up to December 31, 1949, at the latest), from their ages for purposes of eligibility alone, provided that they joined the Forces before August 15, 1945, and that such service was satisfactory and continuous.

6. *Other Requirements.*—(i) Applications from those in a Local Body should be forwarded through the Municipal Commissioner or Chairman of the Local Authority in which they are serving.

(ii) Applications from officers in the Government Service should be forwarded through the Heads of their respective Departments. In the case of applications from officers holding permanent posts in the Government Service, the Head of the Department concerned should, when forwarding the application, state whether or not he is prepared to release the applicant if selected.

(iii) Candidates may be required to present themselves for interview or test at an appointed time and place. No travelling or other expenses will be paid in this connection.

(iv) Any person who desires to recommend a candidate may do so by giving a testimonial. Any form of direct or indirect canvassing or attempt to influence the selection of candidates will disqualify such candidates.

(v) Any statement in the application which is found to be incorrect will render the applicant liable to disqualification if the inaccuracy is discovered before the selection and to dismissal after the selection.

(vi) Applications not conforming in every respect with the requirements of this advertisement will be rejected.

(vii) Applications should be made substantially in the form appended below and should be addressed to the Chairman, Local Government Service Commission, and NOT personally to him.

(viii) Applications received in this office after the closing date will not ordinarily be entertained.

THE HOUSING AND TOWN IMPROVEMENT
ORDINANCE

THE following resolution passed by the Senate at a meeting held on July 27, 1954, and by the House of Representatives at a meeting on July 19, 1954, is published for general information —

"This House resolves under the provisions of section 3(b) of the Housing and Town Improvement Ordinance (Chapter 199), as modified by the Proclamation published in *Gazette Extraordinary* No 9,773 of September 24, 1947, that from the first day of September, 1954, the aforesaid Ordinance shall be in force within each of the areas defined in the Schedule hereto.

Schedule

All that area of land within the Village Headman's Division of Kadukanna No 353 in Weligam Korale in the Matara District of the Southern Province, and bounded as follows :—

North. By a line drawn from a point at the south-western corner of Rukgahamulledeniya south-eastwards along the southern boundary of the said Rukgahamulledeniya to a point on the western boundary of the Weligama-Akuressa Road about 2 chains to the north of the 7th mile post on the said road, thence south-eastwards across the said road to the

centre of its junction with the Teljja-wila-Kadduwa Cart Road, thence south-eastwards along the centre line of Telj-jawila-Kadduwa Cart Road (a distance of about 8 chains) to the western boundary of Ihalaganegamayaya.

East : By a line drawn from the last-mentioned point south-westwards along the western boundary of Ihalaganegamayaya to a point on the centre line of the Matara-Akuressa Road about 3 chains to the west of 6½ mile post on the said road, thence north-westwards along the centre line of the Matara-Akuressa Road to a distance of about 1 chain, thence south-westwards across the said road and along the northern boundaries of Udupityaya and Napeyaya to a point on the left bank of Biso Dola.

South : By a line drawn from the last-mentioned point north-westwards along the left bank of Biso Dola crossing the Weligama-Akuressa Road to a point about 4 chains north-west of the said crossing of the said road.

West By a line drawn from the last-mentioned point eastwards and north-eastwards along the southern boundary of Nakandagoda Estate to the starting point of the northern limit of the area.

MALIMMADA BAZAAR AREA

All that area of land within the Village Headman's Division of Malimmada II No. 350 in Weligam Korale in the Matara District of the Southern Province ; and bounded as follows :—

North By a line drawn from a point on the centre line of the Matara-Akuressa road 2 chains west of the 5th mile post on the said road eastwards along the centre line of the said road to a distance of about 1½ chains, thence northwards across the said road and thence northwards, eastwards, south-eastwards and again eastwards along the southern boundaries of Nakandagoda Estate and Kuruppugewatta till it meets the western boundary of Malimmada-Kadduwa Road at a point about 6½ chains north of Malimmada junction, thence due eastwards to the centre line of the said road.

East . By a line drawn from the last-mentioned point southwards along the centre line of the Malimmada-Kadduwa Road to a distance of about 3 chains ; thence eastwards across the said road and south-eastwards and southwards along the western boundaries of Kapperagehena and Kuruppugewatta to a point on the northern boundary of Alutwatta about 4 chains east of the junction of the cart road from Indurukawa Temple and the Matara-Akuressa Road.

South : By a line drawn from the last-mentioned point westwards along the northern boundary of Alutwatta till it meets the eastern boundary of the Matara-Akuressa Road, thence westwards across the said road to a point on its western boundary where it meets the northern boundary of the cart road from Indurukawa Temple.

West : By a line drawn from the last-mentioned point northwards, north-westwards, south-westwards and again north-westwards along the eastern boundary of Indurukawa Welyaya to the starting point of the northern limit of the area

WELIPITIYA BAZAAR AREA

All that area of land within the Village Headmen's Divisions of Munamalpa and Watagederamulla (Moor) Nos. 392 and 396 respectively in Weligam Korale in the Matara District of the Southern Province ; and bounded as follows .—

North : By a line drawn from a point where the left bank of Polwathu Ganga meets the left bank of the Ela eastwards along the said bank of the said Ela, crossing the Hallala-Weligama Road to a point on the western boundary of Welipityawela 4 chains east of the said crossing of the said road.

East : By a line drawn from the last-mentioned point southwards, eastwards and again southwards along the western boundaries of Welipityawela, Ibiwalakumbura, Achariwagura (paddy fields), lands called Kerenketiya, Managehena, Gastunakoratuwa, Peragahakoratuwa Delgahakoratuwa and Dampawelekumbura to a point on the right bank of Mudun Ela.

South . By a line drawn from the last-mentioned point south-westwards and westwards along the right bank of Mudun Ela crossing the Hallala-Weligama Road at culvert No. 2/1 till it meets the left bank of Polwathu Ganga.

West By a line drawn from the last-mentioned point north-westwards, north-eastwards and again north-westwards along the left bank of Polwathu Ganga to the starting point of the northern limit of the area."

REGULATIONS**THE SUPPLY OF ELECTRICITY**

1. In these regulations—

“Act” means the Electricity Act, No. 19 of 1950;

“Chairman” means the Chairman of the Kankesanturai Town Council;

“licensee” means the Kankesanturai Town Council; and

“Superintendent” means the Superintendent of the Electricity Department of the Kankesanturai Town Council.

2. Any person desirous of obtaining the use of electrical energy from the licensee shall, at least fourteen days before the supply is required pay in advance to the licensee the charges for the service cable.

3. Every consumer of electrical energy shall pay for such energy at the rates specified in the licence granted to the licensee under the Act.

4. That portion of the service cable which is on the consumer's premises, the transformers, the main fuses, the meter, and the board shall remain the property of the licensee, and on no account shall they be moved or handled by any person other than any employee of the licensee.

5. (1) Every consumer wishing, at any time after his installation has been connected, to use any lamp, fan or motor of greater size than the one already in use or to install any additional lamp or other apparatus consuming energy, either temporarily or permanently, or in any way to alter or extend the wiring on his premises, shall notify his wish to the licensee in writing, and if he desires that an electrical contractor should do the work, he shall at the same time notify the name and address of such contractor.

(2) No consumer shall connect or cause to be connected any extension, lamp, fan, or motor of greater size than the one already in use or install any additional lamp or other apparatus consuming energy, either temporarily or permanently to the main installation unless such extension, lamp, fan, motor, additional lamp or other apparatus has been inspected and tested and found to be satisfactory by the Superintendent or by an officer authorised by the Superintendent in that behalf.

6. (1) In the event of the melting of the licensee's main fuse in any premises the consumer shall forthwith inform the Superintendent or the officer in charge of the Electricity Department of the Kankesanturai Town Council.

(2) No person other than one of the licensee's authorised officers or workmen shall replace any melted fuse which is the property of the licensee

(3) Where the services of any officer or workman of the licensee are required to replace any fuse which is the property of the consumer a charge of fifty cents shall be made for replacing the fuse.

(4) Where the melting of any fuse which is the property of the licensee is found to have been caused by a defect in the consumer's wiring or apparatus, a charge of one rupee shall be made for replacing the fuse

7. The licensee does not hold itself liable to the consumer for any loss or damage occasioned, directly or indirectly by the total or partial interruption of supply.

8. Where the installation is re-connected after having been disconnected under section 45 of the Act a fee of five rupees, for testing and re-connecting shall be charged and shall be paid in advance by the consumer

9 (1) All charges shall be deemed to be due on the date on which an account is presented.

(2) No complaint against the accuracy of an account shall be entertained by the Chairman unless such complaint is made within a week after the presentation of the account.

10. (1) Every consumer about to vacate his premises shall give in writing three clear day's notice to the Chairman of his intention to do so.

(2) Where the notice referred to in paragraph (1) is not given, the consumer shall be held responsible for the licensee's equipment in his premises and, for all energy consumed on such premises until, the lapse of three days from the date on which the licensee receives notice of the fact that the premises have been vacated;

Provided that if the supply to the premises is disconnected by the licensee before the lapse of the said three days, the consumer shall be held responsible for the energy consumed on the premises up to the time of disconnection.

11. (1) No consumer shall employ any person other than a person—

(a) who has been certified, by the Chief Engineer and Manager of the Department of Government Electrical Undertakings, as having the necessary skill to undertake electrical work or who has had at least three years' practical experience in a recognized electrical workshop or firm or an electrical power station, and

(b) who has been regularly engaged for a period of not less than two years in the practice of electrical engineering,

to—

(a) carry out any work in connection with the wiring, or the electrical fittings or fixtures, of any new installation in any premises of the consumer, which is intended to be connected to the licensee's electricity supply mains, or

(b) carry out or perform in connection with any installation in any premises of the consumer after such installation has been connected to the licensee's electricity supply mains, any electrical work—

(i) which consists of, or is in the nature of, alterations, adjustments, additions or repairs to such installation, or

(ii) which is other than such ordinary replacement of lamps, fans, switches or other component parts as in no way alters or affects the capacity and nature of such installation.

(2) No installation in connection with which any electrical work described in paragraph (1) is carried out by a person other than a person referred to in that paragraph or by the workman of such a person shall be connected to the licensee's electricity supply mains.

12. (1) No work, such as installation work, including additions, alterations and adjustments to existing installations, shall be commenced except after notice of not less than two days has been given by the person, who is employed by the consumer to carry out such work, to the Chairman to enable the Superintendent or a person authorised by him to inspect the proposed work.

(2) If the Superintendent approves the intended work, he shall determine the position of the meter, and the work shall be carried out in accordance with such latest regulations as may be made under section 60 of the Act.

13. On the completion of any electrical work referred to in regulation 12, such work shall be inspected and tested by the Superintendent and—

- (a) if the installation is found to comply with the regulations laid down, a supply of electrical energy to the premises shall be given; and
- (b) if the installation does not comply with the regulations laid down, a supply of electrical energy to the premises shall not be given until such time as the installation has been made to comply with such regulations.

14. If any work connected with any new installation in any premises has been carried out without giving notice to the Chairman and obtaining his prior approval, the licensee may refuse to supply electrical energy to the premises wherein such work has been carried out or may call upon the person who has carried out such work to effect such modifications or alterations to the wiring as the Superintendent may think necessary. If such modifications or alterations are duly carried out the installation shall be re-inspected and tested by the Superintendent and if found to be in order, a supply of electrical energy to the premises shall be given.

15. Where any extension is made to any installation which is already connected to the licensee's electricity supply mains without prior notice to, and without the permission of the Chairman, the whole installation shall be liable to disconnection from the licensee's electricity supply mains.

2. Upon the establishment of a scavenging service for the whole or any specified part of the urban area, the occupier of any premises situated within an area for which such service has been established, shall cause all ashes, sweepings and all other refuse from his premises to be deposited in a bucket or bin with a suitable cover and of such shape and size as may be approved by the Chairman.

3. The occupier of any premises referred to in by-law 2 shall—

(a) daily between such hours as the Chairman may, from time to time, notify by beat of tom-tom or otherwise, cause such dust-bin to be placed by the edge of the road outside such premises but so as to cause no obstruction to traffic on the road, and

(b) cause such dust-bin to be removed within half an hour of the emptying of such dust-bin by the scavenging labourers of the Council.

4. No person shall place on any road any bucket or bin referred to in by-law 2 except between such hours as are referred to in by-law 3.

5. The occupier of any premises served by the scavenging service other than an occupier who is exempted by the Council on the ground of poverty, shall pay monthly to the Council a scavenging fee of twenty-five cents

6. No person shall collect or remove dust, ashes, rubbish, refuse, or filth from any street or public place within the urban area, unless he is authorised to do so by the Chairman.

7. The scavenging fee referred to in by-law 5 shall be paid to the Chairman or to any person duly authorised by him in writing to collect such fee, on or before the tenth day of the month immediately following the month in respect of which such fee is due: Provided that, when the owner or occupier of any premises has given written notice in advance to the Chairman that the premises will not be occupied during the whole of any specified month, and such owner or occupier subsequently satisfies the Chairman that such premises were in fact not occupied during that month, no scavenging fee shall be payable in respect of those premises for that month.

8. Every contravention of any of the foregoing by-laws relating to scavenging shall be punishable with a fine not exceeding twenty-five rupees, and in the case of a continuing contravention, with an additional fine of five rupees for every day during which the contravention is continued after conviction thereof by a court of competent jurisdiction, or after service of a written notice by the Chairman or other officer authorised in that behalf by the Chairman, directing attention to such contravention.
