Whether the claim made by the five employees recruited to the Thurusaviya Fund in 2002 on contract basis; namely G. K. Sudath Kumara, S. V. Thushari Priyangika, Nayana Darshani Rajapakse, Sandakelum Prabha de Silva and K. W. M. Chandima Priyadarshani, who had been placed on salary scales considering that they had earned the salary increments from their date of appointment to the contract basis post and / or from the date of fulfilling the required educational qualifications and whose confirmations had been backdated, have thereafter been caused injustice by the reduction of the increased salary stating that the salary revisions were incorrect and the payment of a lesser salary is just and if so, to what reliefs each of them is entitled.
