Regulations

The Land Acquisition (Payment of Compensation) Regulations 2013, published in the *Gazette Extraordinary* No. 1864/54 dated 30.05.2014 and amended by the Regulations published in the *Gazette Extraordinary* No. 1977/8 dated 26th July 2016 of the Democratic Socialist Republic of Sri Lanka is hereby further amended in Regulation 4(2), as follows.

- 1 by the repeal of the second proviso to Sub-paragraph (iii) of paragraph (n) thereof, and the substitution therefore of the following proviso :
 - "Provided further, a cash payment applicable for self-relocation, as provided for in paragraph (p), may be made to a re-settler under specified projects referred to in paragraphs (a), (b), (c), (d), (e), (f), (g), (h), (i), (j), (k), (l), (m), (n), (o), (p), (q) and (r) or regulation 2(2), in addition to a block of land entitled by such re-settler under this paragraph, if the LARC deems it to be appropriate"
- 2 by the repeal the sub-paragraph (iii) of paragraph (p) thereof, and the substitution therefore of the following sub-paragraph:-
 - "(iii) A. The Compensation payment for self-relocation under the specified projects stipulated in paragraphs (a), (b), (c), (d), (e), (f), (g), (h), (i), (j), (k), (l), (m), (n), (o), (p), (q) and (r) of regulation 2(2), shall be as follows
