The Revenue Protection Ordinance

THE following Order made by the Minister of Finance'in pursuance of the powers vested in him by section 2 of the Revenue Protection Ordinance (Chapter 191) is hereby published for general information.

The Revenue Protection Ordinance

Order

WHEREAS the Cabinet has during the present session of Parliament approved of the introduction into the House of Representatives of a resolution whereby, if such resolution be carried, the export duties payable on the goods specified in Column I of the Schedule hereto-wift be altered

Now, therefore, in pursuance of the powers vested in me by section 2 of the Revenue Protection Ordinance (Chapter 191), read with the Proclamation under section 88 of the Ceylon (Constitution) Order in Council, 1946, published in *Gazette Extraordinary* No 9,773 of September 24, 1947, I, Mahabalage Don Henry Jayawardena, Minister of Finance, do hereby order the Principal Collector of Customs from midnight of 18th/19th November, 1954, to demand and levy on the goods specified in Column I of the Schedule hereto in lieu of the existing export duties payable thereon under the Customs Ordinance, export duty at the rate set out in Column II of that Schedule in addition to the export duties payable thereon under any written law other than the Customs Ordinance.

Provided, however, that in the case of any tea in respect of which a certificate is issued by the Principal Collector of Customs to the effect that such tea—

- (1) was prior to the midnight of November 18th/19th, 1954, the property of the shipper and in the stores of the shipper or his vendor within the municipal limits of Colombo, and
- (2) is being exported before December 31, 1954, in fulfilment of a valid contract for the sale of such tea to a buyer outside Ceylon which was entered into by the shipper prior to the midnight of November 18th/19th, 1954.

export duty shall, notwithstanding the preceding provisions of this Order, be levied and paid at the rate of seventy-five cents per pound in addition to the export duties payable thereon under any written law other than the Customs Ordinance.

CUSTOMS NOTIFICATION

IT is hereby notified for general information that the Principal Collector of Customs will issue a certificate in respect of tea in terms of the Revenue Protection Ordinance published by the Minister of Finance in *Gazette Extraordinary* No. 10,735 of November 18, 1954, only if the following conditions are satisfied :

- (1) that an Auditor's Stock Certificate, which should be issued after physical verifications of actual stocks in the possession of the shipper or his vendor within the municipal limits of Colombo, is registered at the Export Office of the Principal Collector of Customs within 10 days of date hereof,
- (u) that proof is furnished to the satisfaction of the Principal Collector of Customs-
 - (a) that a valid contract for the sale of such tea to a buyer outside Ceylon was entered into before midnight of November 18th/19th, 1954; and
 - (b) that firm arrangements have been made for the export of such tea before 31st December, 1954.

Applications for such certificates should be made within 3 weeks of date hereof. No applications for certificates will be entertained by the Principal Collector of Customs unless the above two conditions have been satisfied.
