THE CEYLON (CONSTITUTION) ORDER IN COUNCIL, 1946, AND THE CEYLON (PARLIAMENTARY ELECTIONS) ORDER IN COUNCIL, 1946

WHEREAS the Clerk to the House of Representatives has, by letter dated 30th November, 1954, informed me under section 24 (2) of the Ceylon (Constitution) Order in Council, 1946, that the seat of the member for Buttala in the House of Representatives has fallen vacant

Now, therefore, I, Oliver Ernest Goonetilleke, Governor-General, in pursuance of the powers vested in me by the aforesaid section and by section 27 of the Ceylon (Parliamentary Elections) Order in Council, 1946, do by this notice—

- (1) order the holding of an election to fill the aforesaid vacancy, and
- (2) specify January 25th, 1955, as the date, and the Badulla Kachcheri, as the place, for the nomination of candidates for such election

Determination

1 The rate of interest payable in respect of a loan not exceeding Rs 5,000 granted to any person for the construction of one house (not comprised in a housing scheme) shall be 2 per centum per annum if that house

is estimated to cost not more than Rs 5,000 and the Commissioner for National Housing is satisfied that the income of that person does not exceed Rs 200 per month

2 The rate of interest payable in respect of a loan exceeding Rs 5,000 but not exceeding Rs 10,000 granted to any person for the construction of one house (not comprised in a housing scheme) shall be 3 per centum per annum if that house is estimated to cost more than Rs 5,000 but not more than Rs 10,000 and the Commissioner for National Housing is satisfied that the income of that person does not exceed Rs 400 per month

3 The rate of interest payable in respect of a loan exceeding Rs 10,000 but not exceeding Rs 25,000 granted to any person for the construction of one house (not comprised in a housing scheme) shall be $3\frac{1}{2}$ per centum per annum if that house is estimated to cost more than Rs 10,000 but not more than Rs. 25,000

4 The rate of interest payable in respect of a loan granted to any person for the construction of one house (not comprised in a housing scheme) which is estimated to cost more than Rs. 25,000 but not more than Rs 50,000 shall be 4 per centum per annum

5 The rate of interest payable in respect of a loan granted to any person for the construction of one house (not comprised in a housing scheme) which is estimated to cost more than Rs 50,000 but not more than Rs. 75,000 shall be 5 per centum per annum

6 The rate of interest payable in respect of a loan granted to any person for the construction of one house (not comprised in a housing scheme) which is estimated to cost more than Rs 75,000 shall be 6 per centum per annum

7 The rate of interest payable in respect of a loan granted to any person for the purpose of carrying out any housing scheme shall be $3\frac{1}{2}$ per centum per annum if each house or unit of residential accommodation constituting the scheme is estimated to cost not more than Rs. 10,000

8. The rate of interest payable in respect of a loan granted to any person for the purpose of carrying out any housing scheme shall be 4 per centum per annum if each house or unit of residential accommodation constituting that scheme is estimated to cost more than Rs 10,000 but not more than Rs 25,000

9 The rate of interest payable in respect of a loan granted to any person for carrying out any housing scheme shall be 5 per centum per annum if each house or unit of residential accommodation constituting that scheme is estimated to cost more than Rs 25,000 but not more than Rs 50,000.

10 The rate of interest payable in respect of a loan granted to any person for carrying out any housing scheme shall be 6 per centum per annum if each house or unit of residential accommodation constituting that scheme is estimated to cost more than Rs 50,000
