“Bombay and Calcutta Compensatory Allowances

31A Officers of the rank of Midshipman attached to the Indian Navy for training shall be entitled to a compensatory allowance—

**THE FOOD CONTROL ACT, No. 25 OF 1950**  
**Order No. 40**

The Fisheries Regulations, 1941, published in *Gazette* No 8,765 of July 18, 1941, as amended by regulations published in *Gazette* No. 10,560 of August 7, 1953, are hereby further amended, by the insertion, immediately after regulation 17, of the following new regulation:—

“ 17A. Where any live fish or the roe, spawn or egg of any fish, which is of a species for the time being included in the First Schedule to the Ordinance is exported by any person, the Director shall cause the container in which such fish or roe, spawn or egg is exported to be sealed in his presence or in the presence of an officer authorised by him for the purpose, so as to ensure that no fish or the roe, spawn or egg of any fish other than that specified in the permit issued to such person is included in such container.”

Regulations

1. These regulations may be cited as the National Housing (No 2) Regulations, 1954.
- 2 Every public housing loan shall be raised by the Minister by the issue of debentures.
- 3 Every issue of debentures shall be made by the Registrar at the Central Bank.
4. Every application for a debenture shall be made on such form as may be provided for the purpose by the Registrar.
5. Every debenture shall be in the appropriate form set out in the Schedule and shall bear the signature or facsimile of the signature of the Minister and shall be countersigned by the Registrar.

6 Every debenture shall be for a sum of one hundred rupees and shall bear interest at a rate to be determined at the time of issue by the Minister with the concurrence of the Minister of Finance, and specified therein.

Provided that where any applicant for a debenture desires to have a debenture issued to him in a higher denomination which is a multiple of one hundred rupees, the Registrar may in his discretion issued to that applicant a debenture in that higher denomination.

7 Save as hereinafter provided, debentures shall be redeemable at par on such date as may be specified therein, being a date not later than twenty-five years from the date of issue.

8 For the purpose of the payment of the interest due on the principal moneys secured by a debenture, interest warrants shall be issued by the Registrar from time to time to the holder of the debenture. Every such interest warrant shall be in such form as may be approved by the Minister. Every such interest warrant shall bear the signature of facsimile of the signature of the Minister and shall be countersigned by the Registrar.

9 The interest due on the principal moneys secured by a debenture shall be paid half-yearly on the dates specified in that behalf in the debenture at the Central Bank. Such payment shall be made by the Registrar, upon the production and surrender of the appropriate interest warrant, out of moneys provided for the purpose from the National Housing Fund.

10 The interest due on the principal moneys secured by a debenture shall not be capable of itself earning interest.

11 No interest shall be payable on any debenture after the date on which such debenture falls due for redemption.

12. A sinking fund shall be established and maintained at the Central Bank. The fund shall be administered by the Registrar. The moneys for the time being in the sinking fund shall be utilised for the purpose of the redemption of debentures.

13 The Minister may, from time to time, authorise the payment of sums of money out of the National Housing Fund into the sinking fund.

14 The moneys for the time being in the sinking fund may be invested by the Registrar in such stock or other securities as may be approved by the Minister with the concurrence of the Minister of Finance. The income or other profits from such investments shall be credited to the sinking fund. All expenses incurred in the establishment and maintenance of the sinking fund shall be a charge on that fund.

15 The Registrar may, from time to time, out of the moneys in the sinking fund compulsorily redeem at par such number of debentures as may be determined by the Minister with the concurrence of the Minister of Finance.

16 No debenture shall be compulsorily redeemed until after the expiration of a period of ten years from the date of its issue.

17 No debentures shall be compulsorily redeemed until all debentures bearing an earlier date of issue have been redeemed.

18 Where all debentures bearing an earlier date of issue have been redeemed and there are more debentures of any issue than are required for the purpose of compulsory redemption, the Registrar shall advertise the number required for redemption, the date of the issue in question, the total number of debentures of

that issue outstanding, and shall invite the holders of such debentures to surrender the same at par. If a sufficient number of debentures are not surrendered in response to such invitation, the Registrar shall determine by drawing which of such debentures shall be compulsorily redeemed.

19 Where in the course of any drawing for the compulsory redemption of debentures, a debenture is drawn of such a denomination that the amount of that debenture together with the amount of the debentures previously drawn on that occasion exceeds the amount of the debentures to be compulsorily redeemed, the Registrar shall redeem such part of the debenture as may be sufficient for the purpose of such compulsory redemption, and shall issue to the holder of that debenture one or more new debentures of such denomination as he may determine and equal in the aggregate to the amount of the unredeemed part of that debenture.

20 Where debentures are to be compulsorily redeemed by drawing under these regulations, the Registrar shall, by advertisement in the *Gazette* and any two or more newspapers published in the Island, give not less than fifteen days' notice of the date on which, and the time and the place at which, the drawing will take place. The number of debentures to be so redeemed shall also be specified in the advertisement.

21 The drawing shall be done in the presence of any holders of debentures who may choose to be present at the time and the place specified in the advertisement.

22 (1) The Registrar shall, by advertisement in the *Gazette*, declare the distinguishing numbers of the debentures to be compulsorily redeemed or to be drawn for compulsory redemption and shall appoint a day not less than three months after the date of the publication of the advertisement on which the principal moneys secured by such debentures and the interest due thereon will be repaid. The Registrar shall, in addition, by written notice served on the holder of each such debenture, inform the holder of the date appointed for such repayment.

(2) Before the expiry of a period of fifteen days after the date of the publication in the *Gazette* of any advertisement under paragraph (1), the Registrar shall, by notice inserted in any two newspapers published in the Island, give information that the advertisement has been published and specify the number and date of the *Gazette* in which it was published.

23 (1) No debenture shall be redeemed, whether compulsorily or otherwise, until it has been surrendered to the Registrar.

(2) A debenture which has been redeemed shall be cancelled by the Registrar.

24 No notice of any trust shall be receivable in respect of any debenture.

25 Any sum not exceeding five thousand rupees payable by way of interest or as principal in respect of any debenture standing in the name of or held by a minor or lunatic may be paid to any person who is, in the opinion of the Registrar, a fit and proper person to receive such sum on behalf of the minor or lunatic.

26 A debenture holder may transfer all or any of his debentures, provided the transfer is effected in an amount of the nominal value of one hundred rupees or of a multiple of one hundred rupees.

27. The transfer of a debenture may be effected by an instrument in writing in the appropriate form set out in the Schedule executed and signed by the holder thereof and the transferee, and the holder thereof shall be deemed to remain the holder of that debenture until the name of the transferee is entered in the register in respect thereof.



28 (1) The Registrar shall refuse to register the transfer of a debenture—

- (a) unless the instrument of transfer and the debenture are surrendered to him,
- (b) unless a fee of one rupee is paid to him in respect of the new debenture which is to be issued, and
- (c) until the issue of the new debenture

(2) Upon the issue of a new debenture the original debenture shall be cancelled by the Registrar

29 In the case of the death of the holder of a debenture the survivor or survivors where the deceased was a joint holder, and the legal representatives of the deceased where he was a sole holder, shall be the only persons who shall be recognized as having any title to his interest in the debenture

30 The provisions of section 229 of the Civil Procedure Code, shall apply to the seizure of debentures by the Fiscal in the execution of the decree of Court, as if debentures were share certificates and as if the Registrar were the proper officer of a company or corporation referred to in that section

31 Any person becoming entitled to a debenture in consequence of the death, bankruptcy or insolvency of the holder thereof shall send or deliver to the Registrar a notice in writing to that effect and shall, subject as hereinafter provided, be entitled to have his name entered in the register in respect thereof upon his proving to the satisfaction of the Registrar that he is so entitled. The provisions of these regulations relating to the transfer of debentures and the registration of such transfers shall be applicable to any such notice as if the death, bankruptcy or insolvency of the holder thereof had not occurred and the notice were a transfer signed by that holder

32. If a debenture is defaced, lost or destroyed, it may be renewed on the payment of a fee of two rupees and on such terms (if any) as to evidence and indemnity as the Registrar may think fit

33 Debentures may be consolidated or subdivided at the option of the holder thereof, subject to the condition that—

- (a) each new debenture which is issued shall be for a sum of one hundred rupees or a multiple of one hundred rupees, and
- (b) a fee of one rupee shall be payable for each new debenture to be issued

34 (1) The Registrar shall keep and maintain at the Central Bank a register in respect of each issue of debentures (hereinafter in these regulations referred to as "the register") There shall be entered in such register all such debentures, together with the dates of their issue and the names and addresses of the holders thereof

(2) No person shall be registered as the first holder of any debenture unless he has paid in full the principal moneys secured by that debenture

35 Where the title of the holder of any debenture is transferred to any other person under these regulations, the name of the transferee shall, subject to the preceding provisions of these regulations, be entered in the register as the holder of that debenture

36 The register may be closed from time to time for any continuous period not exceeding fourteen days and no transfer of debentures shall be entered in the register during that period

37 No alteration shall be made in the register except for the purpose of effecting or recording—

- (a) a change in the title to the debenture by reason of a transfer or otherwise,
- (b) a seizure or sequestration of a debenture by process of law, and
- (c) any change in the particulars relating to the holder of a debenture.

Provided that the Registrar may at any time make alterations in the register for the purpose of rectifying any clerical or other error appearing in the register

38 The register shall be conclusive evidence that the persons entered therein as the holders of debentures are entitled to such debentures, of the dates of issue, redemption, cancellation or transfer and of all other matters entered therein

39 (1) The payment by the Registrar in accordance with these regulations of any sum, whether by way of interest or principal in respect of any debenture, shall be valid and effectual against any demand made upon the Government, the Minister or the Registrar in respect of that sum

(2) A debenture which has been cancelled by the Registrar as hereinbefore provided shall be invalid

40 The signature of the Registrar on any debenture, instrument or other document may, instead of being affixed thereon under his hand, be reproduced in facsimile on such debenture, instrument or other document

41 All sums paid as fees under these regulations shall be credited to the National Housing Fund

42 The provisions of these regulations, as amended from time to time, shall apply in the case of every debenture, and accordingly such provisions shall be deemed to be the terms and conditions subject to which every debenture is issued

43 In these regulations unless the context otherwise requires—

" Act " means the National Housing Act, No 37 of 1954,

" Central Bank " means the Central Bank of Ceylon established under the Monetary Law Act, No 58 of 1949,

" debenture " means a debenture issued under these regulations,

" holder ", in relation to a debenture, means the person whose name is registered in the register as the holder thereof,

" National Housing Fund " means the National Housing Fund established under the Act,

" public housing loan " means a loan raised by the Minister for the purposes of the National Housing Fund, under the authority of a resolution of the House of Representatives, as provided in section 6 of the Act;

" Registrar " means the Superintendent of Public Debt, Central Bank, and

" Schedule " means the Schedule to these regulations

Report

By letter dated the 5th of June, 1954, the Commissioner of Labour acting under paragraph (1) of section 3 of the Industrial Disputes Act, No. 43 of 1950, referred to me as authorised officer for settlement by conciliation, the disputes that had arisen between the Commercial Banks' Association (Ceylon) and the Ceylon Bank Clerks' Union with regard to the following matters —

- (i) Increase in basic salaries
- (ii) Rent allowance
- (iii) Superannuation schemes, and
- (iv) Remuneration at overtime rates for work done on 31st December, 1953

Sittings were held on June 29, 1954, July 3, 1954; September 9, 1954; September 10, 1954, September 18, 1954; and September 25, 1954 No sittings could be held during August, 1954, as Counsel appearing for the Commercial Banks' Association could not for personal reasons be present A sitting fixed for July 28, 1954, could not be held as I was unable to be present for personal reasons

From the commencement of the sittings it became almost apparent that the Banks were not inclined to make an approach towards a settlement in regard to any of the aforesaid matters in dispute, and it became necessary for me to hear the parties and make my recommendations

Increase in basic salaries—

The position taken up by the banks is that it is too premature to go into the question of increases in basic salaries, as the present scale of salaries compares very

favourably with the existing scales in government service, and is also better than the existing scales in other commercial firms. It was also urged that there was an agreement that the banks would consider the question of revision of the salaries of bank employees after the publication of the Report of the Salaries Commission and the reaction of the Government thereto is known. They maintain that, though the Report of the Salaries Commission has been published, the government has not accepted the same but that it is being considered by a committee appointed by the Finance Minister to advise on the acceptance, modification, or the rejection of the proposals made. It is a matter of common knowledge that the government has not acted on the Report of the Salaries Commission except perhaps in the case of the Judges of the Supreme Court.

The Bank Clerks' Union, on the other hand, urge that the agreement was that revision of salaries would be considered on the publication of the Report of the Salaries Commission, irrespective of whether the government would implement those recommendations or not.

From the minutes of a conference held on March 6, 1953, regarding these disputes between the Ceylon Bank Clerks' Union on the one hand and the Colombo Exchange Banks' Association, and Imperial Bank of India, Ltd on the other, it is clear that both parties agreed to await the Salaries Commission's Report, but it is also clear that the banks agreed to reconsider a revision of salaries, if revision is made in the salaries of the Government Service Clerical Staff.

Whatever the agreement may have been, I am of the view that the salaries of Bank Clerks should bear some relation to the salaries of clerks in government service and also clerks in other commercial firms. This principle appears to be accepted by the Bank Clerks' Union, the representatives of which, in the course of their submissions right along, compared the salaries of Bank Clerks with the salaries, allowances, privileges, &c, government clerks are entitled to, in urging their case for the revision of Bank Clerks' salaries. One has also to bear in mind the fact that an increase in the salaries of bank clerks, while those of government clerks remain unchanged, will undoubtedly knock the salary scales of bank clerks out of alignment with the scales of salary of clerks in government service and other commercial services too.

One cannot overlook the fact that in 1946, the banks of their own accord gave an increase of Rs 30 per month on all grades of salaries raising the initial salary of a bank clerk from Rs 50 to Rs 80 per mensem, while it was later that the government increased the initial salary of a clerk in government service to Rs 70 per mensem. Of course, in addition to the salary, a government servant enjoys certain concessions and privileges and is also entitled to a house allowance. This does not to my mind mean that the salaries of bank clerks should be considered as regards increases irrespective of the salary scales in government service.

Apart from all this on the material placed before me by the Bank Clerks' Union, I am not satisfied that a strong case has been made out to warrant a recommendation by me that the present salary scales of Bank Clerks should be raised at this stage.

Taking everything into consideration, I am of the view that the question of any increase in the basic salaries of bank employees should await the implementation by the government of the recommendations in the Report of the Salaries Commission either in toto or in any modified form and I recommend accordingly.

One of the grievances of the bank clerks is that according to the present scale a bank clerk who draws an initial salary of Rs 80 per month in Grade I has to wait 28 years to draw the maximum salary of Rs 234 per month; and a clerk who gets into Grade H on reaching the initial salary in that grade namely Rs 150 per month has to work for 20 years from that

date before reaching the maximum of Rs 330 per month, so that if he started on the initial salary of Rs 80 per month, he would in the ordinary course reach the maximum of Rs 330 per month only after 33 years of service.

It is my considered view that a bank clerk has to wait too long a time to reach the maximum in either grade; but, though I feel that a revision in the scheme of increments is called for, shortening the period in which the maximum salary can be reached, I refrain from making any specific recommendations in view of the fact that this, too, is a matter vitally connected with the revision of salaries.

The scheme of increments in the salary scales of the minor employees also need adjustment on the same lines.

#### *Rent Allowance—*

When salaries are fixed in any sphere of employment it is commonly understood that the amount an employee has to pay by way of house rent is also taken into consideration especially when no living quarters are provided or rent allowance is paid. Rent allowance is therefore so bound up with salaries, that the appropriate time to consider this question would be when increase in salaries is being considered.

I therefore recommend that the question of rent allowance be considered along with the demand for increase in salaries later as recommended above under that head.

#### *Superannuation Schemes—*

Under this head the Bank Clerks' Union brought up the question of Provident Funds and Pension Schemes.

At the commencement, some discussion as to whether these matters should rightly be considered by me, in view of certain previous correspondence between the parties, and a statement made by Mr W K Wijemanne on behalf of the Bank Clerks' Union at a conference, that the demands regarding Provident Funds and Pension Schemes would be withdrawn, provided the question of basic pay was satisfactorily settled.

The minutes of the conference held on November 23, 1953, at which it was agreed that the matters in dispute be referred to an authorised officer shows that one of the matters was "Superannuation Schemes" and Superannuation Schemes would certainly include Pension and Provident Fund Schemes.

The demands of the Bank Clerks' Union are—

- (a) That the contribution of the Banks to the Provident Fund should be 10 per cent of the basic salary, while the employees' contribution is 5 per cent.
- (b) That there should be no restriction regarding the withdrawal of the amount lying to the credit of each employee on retirement, or resignation, or discontinuance from Service except in the case of misappropriation of money belonging to the Bank.
- (c) That there should also be a Pension Scheme in addition to the Provident Fund in each Bank.

The Bank Clerks' Union desires that the Hong Kong and Shanghai Banking Corporation be allowed to stand out of any schemes that may be recommended, as their contribution to the Provident Fund is 20 per cent as against the employees' contribution of 5 per cent to the basic salary.

The Banks oppose these demands.

All the Banks have Provident Funds. The National Bank and the Imperial Bank have pensions as well. The other Banks also pay pensions, but this payment is at the discretion of the employers.

Regarding the Provident Fund, the Banks urge that the demands of the Bank Clerks' Union if granted, would amount to the revision or alteration of the rules and regulations of the various Provident Funds, and that it is not competent for a Conciliation Board to recommend, or an arbitrator to direct by award that the rules be altered without the Trustees of the various Funds being heard

I find that the same position was taken up before the Sastry Tribunal in the dispute between the Banking Companies in India and their workmen; but, in spite of this objection, the Sastry Award which has been cited by both parties, embodied certain directions to be carried out in connection with Provident Funds. I also find from that Award that some of the Banks involved in that dispute were the Chartered Bank of India, the National Bank of India, the Imperial Bank of India, and the Mercantile Bank of India

I have read through the Rules and Regulations of the local Provident Funds of the National Bank, the Chartered Bank, and the Mercantile Bank which had been produced before me; and, if the local heads of these Banks are willing to co-operate, I see no real difficulty about the amendments of the Rules and Regulations of the Funds wherever necessary

In view of the recommendations I propose to make in connection with the demand for Pension Schemes, I would not recommend an increase in the contributions of the Banks, neither would I, at this stage, recommend that the Rules and Regulations of the various Funds be altered, modifying the restrictions regarding the withdrawal of amounts lying to the credit of any employee on retirement, resignation, or discontinuance from service. However, it appears to me, to be unreasonable that an employee in a Bank, who is entitled to be a member of the Provident Fund, should not be allowed to join it for any length of time after he is confirmed in his appointment

The Hongkong and Shanghai Banking Corporation insists on an employee working for at least two years before he can join their Provident Fund. One cannot complain against this in view of the fact that their contribution is as high as 20 per cent of the basic salary of the employee. In the case of the Mercantile Bank and the Chartered Bank, it appears that an employee has to wait 12 months after appointment before he can join the Fund. I can find no justification for this, neither was any explanation given by the Banks. The employees in all the other Banks are eligible to membership of the Provident Fund at the end of the probationary period i.e., on confirmation

I therefore recommend that every employee of a Bank who is entitled to be a member of the Provident Fund by virtue of other qualifications, should be permitted to join the Fund immediately on his being confirmed in his appointment.

In pressing their demand that all the Banks should have Pension Schemes in addition to the Provident Fund as in the case of the National Bank and the Imperial Bank, the Bank Clerks' Union points out that a contribution by the employer and the employee, each of 5 per cent. of the salary to the Provident Fund would bring the latter after 25 years of service only a sum of Rs 4,338 on the present scale of salaries; while an employee of the Hongkong and Shanghai Banking Corporation would, on the footing of the contributions to their Fund, be entitled to receive at the end of the same period a sum of Rs 10,845 approximately

As I stated earlier the National Bank and the Imperial Bank have definite Pension Schemes, so that their employees can look forward to a pension on retirement after a period of loyal service, but, with regard to the other Banks, although it is said that they also do pay pensions, the payment appears to be at the discretion of the employer, or rather, is definitely at the discretion of the employer. The representatives of the Banks, however, state that although the payments

of pensions in those other Banks are discretionary, in no case has a pension not been paid where such was payable. The Bank Clerks' Union does not contradict this, but urges that the payment of Pension should not be left to the whim and fancy of the employer, and that there should in every Bank be a definite Pension Scheme.

If pensions are always paid although there is no scheme as such, I do not see what objection there can be to a definite scheme being formulated and the employee given the satisfaction of knowing that he would at the end of his period of service be entitled to a pension on the basis of a definite scheme of calculation. The Commercial Banks' Association urge that what is now a discretionary payment should not be converted into what the Bank Clerks' Union describes as an entitlement

I cannot say that the demand of the Bank Clerks' Union is extravagant, and my recommendation is that all Banks should have in addition to the Provident Fund, a Pension Scheme as well

It is only proper that there should be uniformity in these Pension Schemes. The Union requests that the scheme recommended by Mr. G. C. Thambyah in 1945, and appearing in *Government Gazette* No. 9,478 of October 27, 1945, be implemented.

I have carefully gone through this recommendation of Mr. Thambyah, I am in complete agreement with him and can do no better than to recommend that that scheme be adopted.

These recommendations in connection with Provident Funds and Pension Schemes are not to apply to the Hongkong and Shanghai Banking Corporation.

#### *Remuneration at overtime rates for work done on December 31, 1953—*

Originally, in addition to other Bank holidays, it appears that January 1, and July 1, were gazetted as Bank holidays, the idea being, to enable the accounts to be closed for the half years ending December 31, and June 30. On these two days, although the clerks had to work (and work very hard as Mr Edward, Chairman of the Commercial Banks' Association said), no business was transacted at the Banks.

The question of extra remuneration for working on these two days came before a Board of Conciliation (Mr. G. C. Thambyah) in August, 1945, and it was then agreed that no extra remuneration would be claimed by the clerks for working on July 1.

Regarding work done on January 1, too, the Banks objected to the payment of extra remuneration. The Bank Clerks' Union appears to have pressed their claims on the grounds of difficulty of travel, difficulty of obtaining their mid-day meal, and extra expenses they were put to in consequence.

The Board, after consideration, recommended that overtime remuneration be paid for working on January 1. Subsequently January 2, was gazetted a Bank holiday, and this, for the purpose of closing the accounts for the half year ending December 31. Some Banks paid over-time remuneration (inadvertently, it is now said) for working on this day, while others did not.

Now, instead of January 2 and July 1, accounts are closed on June 30 and December 31, and these two days are gazetted as Bank holidays instead of July 1 and January 2. The Banks have refused to pay extra remuneration to the clerks for working on December 31, 1953. The clerks have a grievance that, while in the past they received extra remuneration for working on one of the two days on which accounts have to be closed, they are now denied this extra payment, which undoubtedly would be very welcome at that season of the year

As it was stated by Mr Edward that the clerks had to work very hard on those days, I inquired whether

the Banks would, out of consideration for the clerks who had to work very hard on December 31, agree to make the extra payment as was done in certain Banks in the past for work done on January 2. They were not prepared to give me a definite reply and, desired to have time to consider the matter. A communication dated September 30, 1954, was received from the Banks' lawyers stating that the Banks were "not prepared to accede to the claim of the Union in respect of work performed on December 31, in any year", although the amount involved would not be anything considerable.

The grounds on which overtime remuneration was claimed before the Conciliation Board in 1945 for working on January 1, does not apply to December 31 on which day every other office both Government and Mercantile is open.

The Bank Clerks' Union asks that, in the event of extra remuneration not being paid for December 31, they be allowed an extra holiday to make up for the loss of one of the gazetted Bank holidays.

As December 31 and July 1, are now Bank holidays, purely for the purpose of suspending business at the Banks to enable accounts to be closed, it would be improper to consider these two days as holidays for the clerks as well.

I regret I am unable to recommend that overtime remuneration be paid to clerks for working on December 31, 1953, or in any other year, neither can I recommend that they be allowed an extra holiday in lieu of December 31.
