

Neelis Corlenchige Don Wilson Gunesekera.

"Fibre packing and filler material and method of making same".

Abstract.—The nature of the invention can be ascertained from claims 1 and 2 which read as follows:—

1 A method of making packing and filler material characterised in spreading loose mattress fibre evenly on an alumnium or galvanised sheet to any suitably required height and spraying same with compounded ammoniated rubber latex, vulcanized rubber latex, ammoniated rubber latex, rubber latex having **a** D R C. of  $3\frac{1}{2}$  lbs. per gallon or, with gums or glue, drying in hot air and pressing same between rollers to reduce to the desired thickness.

2 A method as claimed in claim 1 where, when compounded latex is used, the fibre after being pressed between rollers is passed through a hot air chamber to be fully vulcanised.

"Triple action utility filter"

Abstract.—This invention relates to filter for water or light liquids. The nature of the invention can be ascertained from claims 1 and 2 which read as follows —

1. A device or triple action utility filter comprising of a special chamber for collection of filtered solid matter with an outlet at its bottom for cleaning and an extension for fitting to the water mains or stream a filtering body screwed or fixed to the top of the above-mentioned special chamber in which the filtering or absorbing medium (fibre) is compressed and an outlet provided at the top for discharge or delivery of the filtered water as described in my specification and drawings

2. A device as claimed in claim I which the stream or current is directed from the bottom of the filtering medium under which is placed vertically the special chamber
