"Improvements in and relating to Fuels for Internal Combustion Engines"

Abstract —This invention relates to fuels for internal combustion engines. The nature of the invention can be ascertained from Claim 1 which reads as follows —

l A fuel for internal combustion engines which comprises hydrocarbons of the gasoline boiling range containing a minor proportion of a tetra-alkyl lead, a minor proportion of a completely esterified organic ester of an oxyacid of phosphorus or arsenic containing at least one carbocyclic radical and a minor proportion of a halohydrocarbon scavonger.

"Initiating device for a projectile preferably with hollow charge effect"

Abstract —The present invention relates to an initiating device for a projecule The nature of the invention can be ascertained from Claims 1 and 2 which read as follows:—

1 Initiating device for a projectile, preferably with hollow charge effect, comprising a front member

subject to external actuation and a rear member containing an igniting composition, characterised in that the said members are electrically joined to each other and that they contain electrical means of such a kind that the said igniting composition will be electrically ignited upon the front member being subjected to external actuation

2 Initiating device according to claim 1, characterised in that the front member houses a crystal or the like gives rise to electrical voltages when subjected to mechanical strains and stresses

"A composition for surfacing roads, roofs, floors and the like and its bye-product (thinner)"

Abstract.—The nature of the invention can be ascertained from claims 1 and 2 which read as follows:—

- 1 A composition for surfacing roads, 100fs, floors and the like characterized in liquidising scrap rubber and vulcanising same with a proportionate percentage of flower of sulphur as described in my specification.
- 2 A thinner for mixing paints and for use as wood preservative distilled through a still in the process of liquidising scrap rubber for the composition as described and claimed in claim 1 above
