





"An improved incandescent mantle for gas or gasifying lamps and process for its manufacture"

Abstract —The nature of the invention can be ascertained from claims 1, 2 and 3, which read as follows —

- 1 A process for the manufacture of improved incandescent mantles for lamps operated by gas or vaporised liquid fuels, said mantles being impregnated with thorium and cerium compounds in the known manner, characterised by the feature that thermostable additives (improving means) are evaporated in a high vacuum
- 2 A process as claimed in claim 1, characterised by the feature that silicon dioxide is evaporated in a high vacuum on incandescent mantles impregnated with thorium and cerium compounds.
- 3 A modification of the process as claimed in claim 1, characterised by the feature that, instead of the woven incandescent mantles, the threads used for the weaving or knitting, after impregnation with thorium and cerium compounds, are subjected to the treatment with thermostable substances (improving means) in a vacuum
