PROCLAMATIONS BY THE GOVERNOR.

IN the Name of Her Majesty VICTORIA, of the United Kingdom of Great Britain and Ireland Queen, Defender of the Faith.

PROCLAMATION.

By His Excellency Sir ARTHUR ELIBANK HAVELOCK, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Island of Ceylon, with the Dependencies thereof.

WHEREAS by the 19th section of Ordinance No. 10 of 1885 it is enacted that whenever the following events have occurred, viz:—

- the period fixed under section 7 for preferring claims has elapsed, and all claims (if any) made within such period have been disposed of by the Forest Settlement Officer; and
- if such claims have been made, the periods fixed for appealing from the orders passed on such claims have elapsed, and all appeals (if any) presented within such period have been disposed of by the Appellate Officer or the Supreme Court; and
- all lands (if any) to be included in the proposed forest, which may be acquired under section 13, have been vested in the Crown—

the Governor shall, by Proclamation to be published in the *Government Gazette*, specify the limits of the forest, which it is intended to reserve, and declare the same to be reserved from a date fixed by such Proclamation:

And whereas all things necessary for declaring the forest hereunto mentioned to be a reserved forest have been fulfilled, and all times have elapsed, and it is expedient to specify the limits of such forest :

Now know all Men that We, the said Governor, do by this Our Proclamation hereby specify the limits of the forest situated in the villages of Sellankandel and Chenakudirippu, in the Puttalam pattu, and comprised in lots P 148 and 2,805 in preliminary plan 370, which it is intended to reserve, to be as follows :—On the north by Crown forest and the pond called Bellanwala ; on the west by Crown forest called Palaikulikadu and Sandikadu and eastern boundary line of the village forest set apart for the use of the inhabitants of Puttalam, namely, Chenakudirippu and Arachivillu ; on the south by village road leading from Kurunégala road to Mi-oya ; and on the east by the river Mi-oya, exclusive, however, of lots X 148, T 148 $\frac{1}{2}$, O 148 $\frac{1}{2}$, T 148, U 148, S 148, Q 148, R 148 $\frac{1}{2}$, V 148 in preliminary plan 370. And We do hereby declare the same to be a reserved forest as from and after the 5th day of September, 1892.

WHEREAS by "The Courts Ordinance, 1889," it is amongst other things enacted that Criminal Sessions of the Supreme Court shall be holden by one of the Judges thereof for each of the Circuits into which the Island is divided for the purposes of the administration of justice, for the hearing, trying, and determining all prosecutions which shall be commenced against any person for or in respect of any crime or offence—

"For the Southern Circuit twice at least at Galle and such other places in such Circuit as the Governor, after previous consultation with the Judges, shall appoint; such Sessions commencing at Galle on April 25 and September 15 in every year":

And whereas it is further provided by the said Ordinance that it shall be competent for the Governor, for sufficient reasons to him appearing, to order, after previous consultation with the Judges, other Sessions to be holden at the places therein mentioned, or at any other place in any of the said Circuits, or to alter the dates therein mentioned and to fix any other date for the commencement of the Sessions at any place :

And whereas it appears to Us to be expedient to hold a Criminal Sessions of the Supreme Court at Mátara, a place included in the said Southern Circuit :

Now therefore know Ye that We, the said Governor, for sufficient reasons to Us appearing, and after previous consultation with the Judges of the Supreme Court, do order and appoint that a Criminal Session of the Supreme Court shall commence to be holden at Mátara, a place within the said Southern Circuit, on or about Wednesday, the 21st day of September, 1892.

Japan—Inland Sea—Misima Nana—Shoal near Track.

The British Admiralty has given notice (No. 304 of 1892) that the Commander of the U.S.S. Alert reports that, when following the track through Misima Nada (as shown on Admiralty Chart No. 83), a sounding of 7 fathoms was obtained near where 25 fathoms or more has heretofore been charted, with the south end of Koal Sima bearing W. 7° S., and the south-west point of Itsuki Sima N. by W. ½ W., distant 3½ miles. The ship's course was then altered to N. by W. ½ W., and for a distance of about 8 cables depths of 7 fathoms were found, the water then deepening to 15 fathoms.

Approximate position of south end of shoal: lat. 34° 3' 55" N.; long. 132° 48' 20" E.

NOTE.—As less water may exist on this shoal than above given, mariners should use caution when navigating in the vicinity. The track through on chart No. 83 has been expunged north-eastward of lat. 34° 1½' N. (Variation 4° westerly in 1892).

DRAFT ORDINANCES.

M I N U T E.

The following Draft of a proposed Ordinance is published for general information:—

An Ordinance for imposing a Duty on Tavern Licenses within Municipalities.

Preamble.

WHEREAS it is expedient to amend the Ordinances Nos. 10 of 1844 and 13 of 1891, and to impose a duty on all licenses issued in respect of arrack taverns within Municipalities: Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows:—

Stamp duty payable on tavern licenses within municipalities.

1 (1) Whenever in pursuance of the provisions of section 26 of the said Ordinance No. 10 of 1844, as re-enacted by section 9 of the said Ordinance No. 13 of 1891, the government agent of a province issues a license to sell by retail arrack and rum at any tavern situated within the limits of a municipality, such license may be subject to a stamp duty.

(2) The Governor in Executive Council may from time to time, by notification in the *Government Gazette*, fix the amount of such duty, which may vary in different municipalities, but which shall in no case exceed five hundred rupees, and may, with the like advice, amend or alter any such notification.

To be read as one with Ordinances Nos. 10 of 1844 and 13 of 1891.

2 This Ordinance shall be read as one with the Ordinances Nos. 10 of 1844 and 13 of 1891, and shall commence and take effect on the First day of July, One thousand eight hundred and ninety-three.
