IN terms of section 53 of the Motor Traffic Act, No. 14 of 1951, notice is hereby given that a public inquiry will be held into each of the following applications for Stage Carriage Permits to ply omnibus or hiring car services or for renewal of such permits, on the date, time and place shown against each application

- 2. (i) At a public inquiry no person other than any of the following persons shall be entitled to be heard.—The applicant and every person who has duly made objections to the grant of the permit
 - (ii) The Commissioner may, in his discretion, permit any person other than a person referred to in paragraph 2 (i) above to be heard at a public inquiry
- (iii) The Commissioner may, in his discretion, refuse to hear at a public inquiry any person if he is satisfied that the views of that person have already been stated adequately by some other person at that inquiry.
