Declaration of Gangasiripura Grama Niladhari Division as an Urban Development Area including the already declared Thissamaharamaya Urban Development Area

Column I

All the area of lands comprising of No. 4 Gangasiripura Grama Niladhari Division situated in the Hambanthota District, Southern Province and bounded by metes and bounds as specified in Column II including the areas already declared

North :

From the Southern boundary point of Gemunupura Grama Niladhari Division No. 38, a line drawn southeast wards along the Southern boundary of Debarawewa Grama Niladhari



on 17.12.1982 under *Gazette (Extra Ordinary)* Notification No. 223/16 as a Coastal Zone in Sri Lanka, declared on 14/03/1986 under *Gazette (Extra Ordinary)* Notification No. 392/20 in the included areas, declared on 24.07.1987 under *Gazette (Extra Ordinary)* as "Gam Udawa" Kataragama, declared on 29.12.1992 under *Gazette (Extra Ordinary)* Notification No. 747/7 as Ruhunupura respectively.

Division No. 37 until it meets the meeting point of Northern and Western boundaries of Medawelana Grama Niladhari Division No. 2.

East :

From the last mentioned point a line drawn southwest wards along the Western boundary of Medawelana Grama Niladhari Division No. 2 and southeast wards along the Western boundary of Senapura Grama Niladhari Division No. 6 until it meets the Northern boundary of Rabarwatta Grama Niladhari Division No. 7.

South :

From the last mentioned point a line drawn northwest wards along the Northern boundary of Rabarwatta Grama Niladhari Division No. 7 until it meets the Eastern boundary of Molakepupathana Grama Niladhari Division No. 34.

West :

From the last mentioned point a line drawn northwest wards along the Eastern boundary of Molakepupathana Grama Niladhari Division No. 34 until it meets the Southern boundary of Polgahawelana Grama Niladhari Division No. 36; thence, a line drawn northeast wards along the Southern boundary of Polgahawelana Grama Niladhari Division No. 36 until it meets the Eastern boundary of the said Grama Niladhari Division No. 36; thence, a line drawn northwest wards along the Eastern boundary of the said Grama Niladhari Division No. 36 until it meets the starting point.
