THE CEYLON (CONSTITUTION) ORDER IN COUNCIL, 1946

Order under Section 61

ORDER made by the Public Service Commission under section 61 of the Ceylon (Constitution) Order in Council, 1946.

ORDER No. 84

1. The powers specified in Column I of the Schedule hereto are hereby delegated to the officer or officers of the Railway Department specified in Column II of that Schedule.

2. Any person dissatisfied with the decision made by an officer under any power delegated to such officer under paragraph 1 of this Order may—

- (a) in the case of a decision made by any Divisional Transportation Superintendent, any Assistant Divisional Transportation Superintendent, the Assistant to the General Manager (Operating) or any Station Master (Special Class, Class I or Supernumerary Grade, Class I)—
(i) if such person is a member of the Traffic Staff, appeal to the Operating Superintendent; and
(ii) if such person is a member of the Engineering or Mechanical Staff, appeal to the Chief Mechanical Engineer (Headquarters);
- (b) in the case of a decision made by the Station Superintendent (Fort), the Depot Master (Colombo Yard) or the Goods Agent (Colombo Goods Shed), appeal to the Operating Superintendent;
- (c) in the case of a decision made by the Foreman (Running Sheds), appeal to the Chief Mechanical Engineer (Headquarters);
- (d) in the case of a decision made by the Deputy Chief Engineer (Way and Works), the Assistant Chief Engineer (Way and Works), the Signal Engineer (Way and Works), any District Engineer (Way and Works), any Inspector (Permanent Way), the Inspector (Bridges), any Inspector (Signals), the Chief Building Foreman or any Foreman, Grade I (Permanent Way, Signals, Buildings and Bridges), appeal to the Chief Engineer (Way and Works);
- (e) in the case of a decision made by the Deputy Mechanical Engineer, the Administrative Assistant or any Foreman (Ratmalana Workshops), appeal to the Chief Mechanical Engineer (Ratmalana);
- (f) in the case of a decision made by the Assistant to the General Manager (Administrative), appeal to the Chief Administrative Officer;
- (g) in the case of a decision made by the Assistant to the Commercial Superintendent, appeal to the Commercial Superintendent;
- (h) in the case of a decision made by the Chief Administrative Officer, the Operating Superintendent, the Chief Mechanical Engineer (Headquarters), the Commercial Superintendent, the Chief Engineer, Way and Works, the Chief Mechanical Engineer (Ratmalana), the Chief Accountant or the Superintendent of Railway Stores, appeal to the General Manager;

Provided that any person dissatisfied with the decision made by an officer to whom he has appealed under the provisions of sub-paragraph (a), (b), (c), (d), (e), (f) or (g) may appeal from such decision to the General Manager.

3. The powers delegated to any officer under paragraph 1 of this Order shall be subject to the following conditions:—

- (a) that those powers shall be exercised according to such instructions as may be issued from time to time by the Public Service Commission; and
- (b) that in any case where the Public Service Commission decides that any power of punishment delegated to such officer shall be exercised by the Public Service Commission, such officer shall not exercise that power in that case.

4. This Order shall have effect notwithstanding anything in the Order under section 61 of the Ceylon (Constitution) Order in Council, 1946, published in *Gazette* No. 10,847 of October 7, 1955.

5. Nothing in this Order shall be deemed or construed to derogate from, or to affect in any other way, the right of appeal to the Public Service Commission conferred by section 61 of the Ceylon (Constitution) Order in Council, 1946.

6. The Order dated September 27, 1949, and published in *Gazette* No. 10,024 of September 30, 1949, as last amended by Order dated February 11, 1950, and published in *Gazette* No. 10,073 of February 17, 1950, is hereby revoked.
