The Army Discipline Regulations, 1950, published in *Gazette* No. 10,154 of September 22, 1950, as amended by regulation published in *Gazette* No. 10,526 of May 15, 1953, are hereby further amended as follows.—

- (1) in regulation 101—
 - (a) by the substitution, in paragraph (1) thereof, for the words "a member of the Provost Section", of the words "a member of the staff of the Army Detention Barracks or a member of the Provost Section"; and
 - (b) by the substitution, in paragraph (2) thereof, for the words "any member of the Provost Section", of the words "a member of the staff of the Army Detention Barracks or a member of the Provost Section";

(2) in regulation 102, by the substitution in paragraph (1) thereof, for the words "The commanding officer", of the words "The Commandant of the Army Detention Barracks or in the case of a Unit Detention Barracks, the commanding officer";

(3) in regulation 103—

- (a) by the substitution in paragraph (2) thereof for the words "forthwith to the commanding officer", of the words "forthwith to the Commandant of the Army Detention Barracks or in the case of a Unit Detention Barracks, forthwith to the commanding officer"; and
- (b) by the substitution in paragraph (3) thereof, for the words "In extreme cases the commanding officer", of the words "In extreme cases the Commandant of the Army Detention Barracks or the commanding officer",

(4) by the substitution, for regulation 106, of the following new regulation.—

“106 (1) Remission of sentence may be granted to a soldier undergoing detention—

- (a) by the Commander of the Army,
- (b) by the Commandant of the Army Detention Barracks, if the soldier is undergoing detention in the Army Detention Barracks, or
- (c) by his commanding officer, if the soldier is undergoing detention in a Unit Detention Barracks.

(2) The Commander of the Army may, if he considers it necessary so to do, vary or annul any remission of sentence granted to a soldier by his commanding officer or by the Commandant of the Army Detention Barracks, as the case may be.”

(5) in regulation 109, by the substitution for the words “in Detention Barracks if his commanding officer is satisfied”, of the words “in the Army Detention Barracks by the Commandant of the Army Detention Barracks and to a soldier undergoing detention in a Unit Detention Barracks by his commanding officer, if the Commandant of the Army Detention Barracks or the commanding officer, as the case may be, is satisfied”, and

(6) in regulation 110—

(a) by the re-numbering of paragraphs (1), (2) and (3) of that regulation, as paragraphs (2), (3) and (4) respectively; and

(b) by the insertion immediately before the re-numbered paragraph (2), of the following new paragraph—

“(1) The Commandant of the Army Detention Barracks may grant to a soldier undergoing detention in detention barracks leave on compassionate grounds for a period not exceeding one hundred and forty-four hours. Leave on compassionate grounds for a period exceeding one hundred and forty-four hours may be granted by the Commandant of the Army Detention Barracks with the prior approval of the Commander of the Army and such leave shall not, in the first instance, be granted for a period exceeding twenty-eight days.”

(c) by the substitution in the re-numbered paragraph (2) thereof, for the words “in detention barracks”, of the words “in a Unit Detention Barracks”;

(d) by the substitution in the re-numbered paragraph (3) thereof, for the words “in detention barracks”, of the words “in a Unit Detention Barracks”, and

(e) in the re-numbered paragraph (4)—

(a) by the substitution for the words “in detention barracks”; of the words “in a Unit Detention Barracks”, and

(b) by the substitution for the words and figures “in paragraphs (1) and (2)”, of the words and figures “in paragraph (2) or paragraph (3)”.

Collective Agreement No. 4 of 1955

THIS COLLECTIVE AGREEMENT made this 23rd day of December, One thousand nine hundred and fifty-five BETWEEN The Banks enumerated in the First Schedule hereto being members of the COMMERCIAL BANKS' ASSOCIATION (CEYLON) (hereinafter referred to as "the Banks") of the One Part and THE CEYLON BANK CLERKS' UNION (hereinafter referred to as "the Union" acting for and on behalf of its members from time to time in the employment of the Banks and who are hereinafter referred to as "Employees") of the Other Part

WITNESSETH and it is hereby agreed as follows :

- (1) This Agreement will come into force forthwith and will continue to remain in force up to and including the thirty-first day of December, one thousand nine hundred and fifty-six
- (2) The scales of salaries payable by the Banks to Clerical Employees and to Peons and other minor employees and by the National Bank of India Limited to Supervisors employed by that Bank shall
 - (a) for the period 28th March, 1955, to 31st December, 1955, be those set out in the Second Schedule hereto.
 - (b) for the period from 1st January, 1956, up to and including the 31st December, 1956, be those set out in the Third Schedule hereto.
- (3) The present scale rate and basis of Dearness and Special Allowances payable to employees shall continue to be payable for the duration of this Agreement.
- (4) Subject to the provisions of this Agreement (which shall supersede the Award dated the 26th day of November, 1955, in D. C. Colombo 614 Special and made under the Industrial Disputes Act, No. 43 of 1950) the current terms and conditions of Employment will continue in force up to and including the 31st day of December, 1956, and no claims or demands in respect of terms, conditions, emoluments or allowances inconsistent with this Agreement shall be made or admissible for the duration hereof.
- (5) Work performed during normal working hours on 31st days of December, 1955, and 1956, or on any Bank Holiday gazetted in lieu thereof shall not qualify for overtime payment and shall be covered by the monthly salary paid to employees unless and until there shall be any statutory or legal requirement that work performed by employees on such days shall qualify for additional payment.
- (6) During the period of this Agreement no other grades or classes within the Supervisory, Clerical, Peons or Menial or other grades of employees shall be made, created or demanded.
- (7) No claims in respect of emoluments, allowances, overtime or other cash payments shall be made or be admissible in respect of any period prior to the 28th day of March, 1955
- (8) It is agreed between the parties hereto that this present Agreement disposes for its duration of all existing disputes both individual or collective between the Union and/or the employees on the one hand and the Banks and/or the said Association on the other hand save that nothing in this provision shall disentitle the Union to put forward claims in regard to superannuation provisions including pension and provident fund.
