# Trade Mark Notices

#### Trade Marks Office

#### Hours of Inspection

The office shall be open to the public every week day, except Saturday, between the hours of ten to four, and on Saturdays between the hours of ten to one, except on public holdays. Applications for inspections will however be accepted up to 3 p.m. on week days and 12 noon on Saturdays.

# Trade Marks limited to colours

Where it is stated in the advertisement of an application that the mark upon its registration is to be limited to

certain colours, the colours are, as far as possible, indicated in the accompanying representation of the mark in the usual heraldic manner.

### Association

Where it is stated that an advertised mark is to be associated (under Section 22 of the Trade Marks Ordinance (Cap. 121),) with another mark, it is indicated by its official number.

#### Applications in Part A or Part B

Applications for registration in Part A of the Register are shown with the official number unaccompanied by any letter. Applications for Part B of the Register are distinguished by the letter B prefixed to the official number.

Imperial Chemical Industries, Limited

"New pesticidal basic esters of phosphorothiolothionic acid"

Abstract —This invention relates to new basic esters of phosporothiolothionic acid more particularly to those of the following general formula:—

$$S' = P - S - LX$$

$$OR_2$$

in which R<sub>1</sub> and R<sub>2</sub> stand for like or unlike alkyl radicals, L stands for a saturated or branched chain aliphatic hydrocarbon radical or for such a radical in which the curbon atoms are interrupted by an oxygen or sulphur atom or by a nitrogen atom carrying an alkyl substituent and X stands for the residue of a secondary aliphatic or heterocyclic amine or of the salts of such amines attached to L through the amine nitrogen atom, this nitrogen atom not being attached to the same carbon atom in the said hydrocarbon radical as is the relative sulphur atom
