

"Improvements in or relating to power-driven centrifugal-blower delivery apparatus"

Abstract —This invention relates to power-driven centrifugal-blower delivery apparatus such as is employed for a dispersed delivery of powder insecticide

According to the invention, a power-driven centrifugal-blower delivery apparatus is provided with a blower casing which can be turned bodily about its exis relative to a power unit which carries said casing and drives the blower impeller, whereby a delivery nozzle incorporated with said casing can be brought to any desired position within the range of movement thus afforded for said casing The said delivery nozzle preferably is straight and arranged to provide for a flow from the impeller to the discharge end of the nozzle in a direction tangential to said impeller or blower casing

"Improvements relating to water purification and supply systems"

Abstract —The nature of the invention can be ascertained from claim 3 which reads as follows:—

An automatically-controlled water purification and supply system comprising a sedimentation tank, a gravity filter unit, an intermediate pure water tank, a pneumatically-pressurised storage tank adapted to supply purified water to a distribution point, a motor-driven pump for pumping water from the intermediate pure water tank to the storage tank, and a pressure-sensitive device adapted to operate the pump motor within pre-determined limits of pressure in the storage tank, the filter unit and the intermediate pure water tank being located on substantially the same level and thus constituting a self-compensating system in that water may flow from the sedimentation tank to the filter unit and thence to the intermediate pure water tank when the water-level in the latter is lowered below the water-level in the filter unit by the automatically-controlled pumping of water from the intermediate tank to replenish the storage tank.

"Cooking, heating or lighting apparatus operated with liquid fuel and method for its operation".

Abstract.—This invention relates to apparatus for cooking, heating or lighting operated with liquid fuel.

The invention is based on the idea of connecting a device into the path of the liquid fuel between a low situated supply container and the higher situated burner, which device in the manner of a pulsometer or the like effects the conveying of the liquid fuel simply by local heating of a part of the same in a vapourizer above the vapourization temperature and subsequent condensation of the produced vapour owing to cooling.

or a derivative thereof of formula,

with sodium borohydride or potassium borohydride m a non-acidic hydroxylic solvent and hydrolyzing the boron complex so formed thereby obtaining a 1-p-nitrophenyl-2-acylamido-propane-1, 3-diol compound of formula,

where R is hydrogen or a carboxylic acid acyl radical,

2. Process according to claim 1 wherein the reaction of the a-acylamido β -hydroxy-p-nitropropiophenone compound with sodium borohydride or potassium borohydride is carried out at a temperature below 50 °C.
