Hours of Inspection

The office shall be open to the public every week day, except Saturday, between the hours of ten to four, and on Saturdays between the hours of ten to one, except on public holidays. Applications for inspections will however be accepted up to 3 p.m. on week days and 12 noon on Saturdays.

Trade Marks limited to colours

Where it is stated in the advertisement of an application that the mark upon its registration is to be limited to

certain colours, the colours are, as far as possible, indicated in the accompanying representation of the mark in the usual heraldic manner.

Association

Where it is stated that an advertised mark is to be associated (under Section 22 of the Trade Marks Ordinance (Cap. 121)), with another mark, it is indicated by its official number.

Applications in Part A or Part B

Applications for registration in Part A of the Register are shown with the official number unaccompanied by any letter. Applications for Part B of the Register are distinguished by the letter B prefixed to the official number.

OPPOSITION

NOTICE is hereby given that any person who has grounds of objection to the registration of the following trade marks may, within two months from the date of this Gazette, lodge Notice of Opposition on form T. M. No. 7 bearing an uncancelled or impressed stamp of Rs. 25. The period of lodging Notice of Opposition may be enlarged by the Registrar if he thinks fit and "pon such terms as he may direct.





"Shingles".

Abstract.—This invention relates to improvements in metallic shingles. The nature of the invention can be ascertained from claim (1) which reads as follows:—

1. The method of making a metallic shingle by pressing a plane blank in rectangular shape and cutting from two diagonally opposite corners triangles of predetermined size, cutting a portion simulating a keystone of predetermined size from a third corner of the blank, pressing, concave grooves in one plane face of the blank adjacent the edges of the blank, folding the marginal portions of two sides of the blank adjacent to the fourth corner of the blank to underlie one face of the blank and then folding the remaining marginal portions of the blank to overlie the other face of the blank.

THE BRITISH BATA SHOE COMPANY LIMITED. "Improvements relating to rubber footwear".

Abstract.—This invention relates to articles of footwear formed of rubber or the like with insoles incorporating sponge rubber—The nature of the invention can be ascertained from Claim 1 which reads as follows—

1. 'A method of making shoes comprising building together the following components, namely, a sole incorporating vulcanisable rubber, an upper also incorporating vulcanisable rubber and an insole incorporating a top layer of porous fabric and an under layer composed of a composition of vulcanisable rubber containing a sponging agent, and subjecting said components on a last to heat and pressure by an exterior medium to vulcanise the rubber constituents and to convert said composition into vulcanised sponge rubber, the procedure being such that gases produced in the msole during sponging escape through and under the control of said fabric and the components are under the exterior pressure of said medium, the reactive interior pressure of the last and the internal pressure due to said gases, so that the components are united as an integral whole.

Abstract.—This invention relates to new therapeutically useful complexes of tetracycline.

It is the object of the present invention to provide a therapeutic form of tetracycline which is stable for prolonged periods of time when formulated as an aqueous suspension for oral or parenteral use. This object is attained and it is now provided by the present invention crystalline tetracycline-calcium chloride complex and further a crystalline complex containing four molecules of tetracycline per molecule of calcium chloride.

"A new halohydrocarbon and methods of making the same".

Abstract—This invention relates to a new halohydrocarbon viz. 1 · 1 : 1—trifluoro-2-bromo-2-chlorethane of the formula CF₃-CHBrC1.

The nature of the invention can be ascertained from Claims 1, 2 and 3 which read as follows:—

1: The new chemical compound 1:1:1—trifluoro-2-bromo-2-chloroethane.

2. Process for the manufacture of the new compound 1:1:1-trifluoro-2-bromo-2-chloroethane which comprises brominating 1:1:1-trifluoro-2-chloroethane or chlorinating 1:1:1-trifluoro-2-bromoethane.

. 3. Process as claimed in Claim 2 wherein the bromination of 1:1 1—trifluoro-2-chloroethane is carried out in the gaseous phase at a temperature in the range 350°-600°C., preferably 425°-475°C.
