REGULATION made by the Minister of Defence and External Affairs under section 161 of the Navy Act, No. 34 of 1950.

Regulation

The regulations for Officers published in *Gazette* No. 10,187 of December 9, 1950, as amended from time to time, are hereby further amended as follows —

- (1) in regulation 4—
 - (a) by the omission of paragraphs (c) and (d); and
 - (b) by the omission of the proviso to that regulation,
- (2) by the substitution for regulation 5 of the following new regulation.—

“5. A commission as a Lieutenant may be issued to a candidate for service in the Non-Executive Branches”.
- (3) by the substitution for regulation 6 thereof, of the following new regulation —

“6 (1) The promotion of officers below the rank of Commander shall be as follows —

 - (a) A Cadet shall be eligible for promotion to the rank of Midshipman—
 - (i) if he completes a course of training to the satisfaction of the Captain of the Navy, and
 - (ii) if his conduct is satisfactory
 - (b) A Midshipman shall be eligible for promotion to the rank of acting Sub-Lieutenant—
 - (i) if he completes to the satisfaction of the Captain of the Navy a period of service in the rank of Midshipman,
 - (ii) if he completes a course of training to the satisfaction of the Captain of the Navy, and
 - (iii) if he is recommended for promotion by his Commanding Officer.
 - (c) An acting Sub-Lieutenant shall be eligible for confirmation in the rank of Sub-Lieutenant, if he completes a course of training for such period and of such description as the Captain of the Navy may deem fit

Provided, however, that where the completion of such course of training has been delayed on account of circumstances beyond his control, the Captain of the Navy may confirm such officer in the rank of Sub-Lieutenant with effect from such date as he may determine
- (d) A Sub-Lieutenant shall be eligible for promotion to the rank of Lieutenant—
 - (i) if he completes to the satisfaction of the Captain of the Navy a period of service in the rank of Sub-Lieutenant (whether acting or confirmed),
 - (ii) if he completes a course of training to the satisfaction of the Captain of the Navy,
 - (iii) if he is recommended by his Commanding Officer as being fit for promotion to the rank of Lieutenant, and

(iv) if he, being an officer in the Executive or Engineering Branch, is in possession of a Watchkeeping Certificate.

(e) A Sub-Lieutenant in the Executive or Engineering Branch who, on account of circumstances beyond his control, has been unable to obtain a Watchkeeping Certificate, may be promoted to act as Lieutenant if he satisfies the other requirements specified in sub-paragraph (d) and may, upon his obtaining such Certificate, be confirmed in the rank of Lieutenant with effect from the date on which he was promoted to act as Lieutenant.

(f) A Lieutenant shall be eligible for promotion to the rank of Lieutenant Commander after eight years from his date of seniority as Lieutenant.

(2) For the purposes of sub-paragraph (1) (f), the expression "date of seniority" when used in relation to—

(a) an officer who was in the service of the Navy on November 3, 1952, means the date determined by the Permanent Secretary;

(b) any other officer, means the date on which that officer was promoted to the rank of Lieutenant.

(4) in regulation 8, by the substitution for the words "Commander, Captain or Rear Admiral" of the words "Commander or to a rank higher than that of Commander"

The provisions of Part II of the Wages Boards Ordinance, No 27 of 1941, shall apply to the following trade—

The beedi manufacturing trade, that is to say—

- (1) the preparation of tobacco for the manufacture of beedi,
- (2) beedi rolling, and
- (3) packeting beedi,

including—

- (1) loading and unloading of and portage for transporting bales of tobacco, wrapping leaves, beedies and packing cases;
- (2) stacking and (periodical) re-stacking of tobacco and wrapping leaves in store,
- (3) grading tobacco,
- (4) sprinkling water on wrapping leaves,
- (5) drying tobacco in the sun;
- (6) cutting wrapping leaves,
- (7) crushing tobacco into chips for preparation of fillers ("beedi tobacco") for rolling;
- (8) preparation of wrappers for rolling,
- (9) filling wrappers with "beedi tobacco",
- (10) beedi rolling,
- (11) tying rolled beedies with thread;
- (12) sorting beedies,
- (13) fixing ring labels round rolled beedies;
- (14) bundling of beedies,
- (15) sun drying bundles of beedies;
- (16) wrapping bundles of beedi in paper and labelling;
- (17) making packets of bundles,
- (18) labelling packets,
- (19) cleaning and sweeping of stores and drains, and
- (20) any other operation connected with or incidental to the work specified in this paragraph, but excluding the work of the following workers—
Agents for purchasing tobacco, lorry and van drivers, carters, clerks, managers, supervisors and storekeepers

Tapping coconut, kitul or palmyrah palms for supplying toddy to distilleries or for the manufacture of vinegar	37 cents for each gallon of toddy delivered by worker
Tapping spadices for supplying toddy to distilleries or for the manufacture of vinegar	Rs. 55 for 80–120 coconut, kitul or palmyrah palms
Tapping spadices for supplying toddy to taverns	Rs. 60 for 25–40 coconut, kitul or palmyrah palms

The application of the foregoing rates for tapping coconut, kitul or palmyrah palms, shall, in every case where a worker is employed in tapping toddy for the arrack trade or for the manufacture of vinegar, be subject to the conditions that the toddy delivered by him contains not less than 7.5 per centum alcohol by volume. Where, however, such toddy contains less than 7.5 per centum alcohol by volume, the worker who delivered it shall be paid an amount which bears to the rate specified above the proportion which the percentage of alcohol in that toddy bears to 7.5 ”;

(2) by the substitution, for Part III of that Schedule, of the following new Part:—

“PART III

Minimum rate of wages for time work applicable to the workers specified in column 1 shall be the corresponding rates set out in column 2.

In any month where the period of unauthorised absence of a worker exceeds four days, he shall be paid as wages for that month an amount which bears to the minimum monthly rate the proportion which the number of days work increased by 4 bears to 30
